In consideration of the FEFC permitting me to participate in the activities, I, for my heirs, administrators, executives and assignees, hereby covenant and agree that I will never institute, prosecute, or in any way aid in the institution or prosecution of, any demand, claim, or suit against the FEFC and its officers, agents or employees, acting officially or otherwise, for any loss, damage, or injury to my person (including death) or my property which may occur from any cause whatsoever as a result of participation in the flying club

I understand and agree that the FEFC officers are not responsible for the actions of its individual members.

If I, or my heirs, administrators, executor, and assignees should demand, claim, sue or aid in anyway in such a demand, claim or suit, I agree to indemnify FEFC, it's officers agents or employees for all damages, expenses, and costs that may incur as a result thereof.

I understand and agree that I am assuming the risk of personal injury or property damage to me that may result while participating in the flying club activities, including such injuries or damage that may be caused by the negligence of FEFC, it's officers agents or employees.

I also understand and agree that I may be held liable for any damages or losses to a FEFC which is caused by my gross negligence, willful misconduct, or fraud.

The term FEFC as used here includes the Flight Expo Flying Club including individual shareholders members, any officer, agent, or employee of the Flight Expo Flight Flying Club, acting officially or otherwise.
