## **Council Meeting Minutes: June 10, 2025 — "Subject to Approval"**

**Present:** Diane Fried, Denel Ingraham, Charlie May, Vicki Egesdal, LaLita Tadena, Pat Woods, Pastor Ed Backell and Sandy Hoveskeland. Dan Olson, George Simon and Nancy Purcell were absent.

**Call to Order:** Vice President LaLita Tadena called the meeting to order at 6:30 p.m.

**Devotional:** Charlie gave the devotional about being a kind witness. Acts 1:8 speaks to the Holy Spirit empowering us so we can express our love of God to others through our words and deeds.

**Approval of Minutes:** A motion was made by Charlie and seconded by Pat to approve the May 13, 2025 minutes as presented. Motion was unanimously approved.

Treasurer's Report: Vicki Egesdal provided the treasurer's report which was reviewed and discussed by the Council. Current assets are \$182,499 compared to \$179,439 on May 31, 2024. Assets are down mainly from depreciation. Unearned givings are \$29,566 compared to \$26,650 at this time last year. UGM income is \$1,630 compared to \$275 this time last year. Part of this increase is donations to UGM Kid's Camp. Building use is \$5,388 compared to \$4,989 at this time last year. Dan Winchester's family donated \$300 for building use for Dan's funeral. Plate offerings January through May 2025 are \$59,048 compared to \$50,633 January through May 2024. Pastor's salary to-date is \$11,250 and \$7,125 has been contributed to his retirement account. Net loss from January through May 2025 is \$16,620 compared to a net loss of \$10,629 at this time last year.

STCU Checking: \$4,588.60 Schwab Building Fund: \$36,031.54 Schwab Savings: \$120,847.62 Vanguard Savings: \$21,031.72



Pastor's Report: Pastor Ed preached and taught every Sunday. Adult Sunday School closed out Psalm 119. When Sunday school resumes in the Fall, the class will begin examining the smaller New Testament books, beginning with the Book of Jude. Pastor Ed made hospital visits, helped with neighborhood canvassing to distribute flyers for the Northgate Revival Concert on June 11, met with Sharon Nelson to plan Bill Nelson's funeral and presided over Dan Winchester's funeral. Pastor Ed and Jami also participated in a congregational small group meeting at Charlie and Squeaky's house on June 9. He also followed up on a prayer request from Susie for her family. Discussion followed about new people coming to church and whether they have been followed up with. A discussion followed about starting new member classes and the definition of a member. Council members should read the Constitution to be clear on the definition for discussion at the Council meeting on July 8.

Properties and Maintenance: See report submitted by Charlie May. Charlie requested approval to spend \$425 to have the overflow parking lot gravel treated with weed killer. A motion was made by Pat and seconded by Diane to approve spending \$425 to have the gravel treated. Motion was unanimously approved. Charlie mentioned in his report that the water heater in the Fellowship Hall needed to be replaced. However, it seems to be working fine so he will postpone doing anything about it for now. Charlie will remind the user groups to park in their own lot and to meet in the back classrooms versus the Fellowship Hall. The church has gotten busier, and the back classrooms are reserved for the user groups.

**Worship and Music:** See report submitted by Nancy Purcell. Details for the funerals of Dan Winchester and Bill Nelson are included in the report. Judy and Jami continue to work with the Praise Team. Jami would like to have a choir every Sunday.

**Congregational Ministries:** See report submitted by LaLita Tadena. Flyers were distributed to the community for the Northgate Revival Concert at Holy Trinity on June 11. This is the first of three sticky events for the summer at Holy Trinity. The other events are a BBQ night on July 24 and a S'Mores night on August 28. Squeaky is taking the lead on the S'Mores event. Volunteers are needed to help with the BBQ in July.

**Christian Education:** See report submitted by Pat Woods. Holy Trinity's summer schedule began May 25. Church services now begin at 9:30 a.m. Wednesday morning Bible study will continue through the summer from 10 a.m. to 11:30 a.m. Nancy Purcell is the leader, and the Book of John is being discussed. Friday morning breakfast and Bible study will also continue through the summer from 7:30 a.m. to 9:00 a.m. Various topics are discussed.

**Social Care and Concerns and Care Team:** See report submitted by Diane Fried. Diane's report contains details of how Holy Trinity is supporting UGM Kid's Camp this summer. She also reported that the care team continues to visit shut ins. She offers communion during the visits. Pastor Ed has his sermons scripted if anyone would like a copy. Diane keeps a list of shut ins.

#### **New Business:**

- Nominating Committee: Preparation for the end of this term Judy and Squeaky are on the nominating committee. There should be 3-5 on the committee according to the Constitution so we need another volunteer.
- 2. <u>Foreign Exchange Student:</u> An email was received from a representative of the Council on International Educational Exchange for host families for high school students for the coming school year. An announcement could be made to the church members, but the Council will take no action as this is a personal decision.


