These Terms & Conditions apply to all sales, quotations, hire agreements and services provided by Northern Machinery Group Ltd.

### 1. Quotations

All quotations are valid for 30 days unless otherwise stated.

Prices may be subject to change due to supplier price increases, stock availability or specification changes before an order is accepted.

A quotation does not constitute a binding contract until an order has been accepted by Northern Machinery Group Ltd.

### 2. Orders

Orders may be placed by telephone, email or in person.

Acceptance of an order is subject to product availability and confirmation by Northern Machinery Group Ltd.

We reserve the right to refuse or cancel any order where pricing, stock or specification errors have occurred.

### 3. Payment Terms

Unless otherwise agreed in writing:

Payment is due prior to dispatch.

Account customers must pay within agreed credit terms.

Overdue accounts may be subject to interest and recovery costs.

Ownership of goods remains with Northern Machinery Group Ltd until payment has been received in full.

### 4. Delivery

Delivery dates are estimates only.

Whilst every effort will be made to meet delivery times, Northern Machinery Group Ltd cannot be held liable for delays caused by suppliers, transport providers or circumstances beyond our control.

Customers must inspect goods upon receipt and report any shortages or damage within 48 hours.

## **5. Returns**

Returns will only be accepted with prior agreement.

Goods must be:

Unused.

In original packaging.

Suitable for resale.

Special order, non-stock and bespoke items may not be eligible for return.

Any approved returns may be subject to a restocking charge.

## **6. New Machinery**

New machinery is supplied subject to the manufacturer's warranty and conditions.

Warranty claims must be made in accordance with the manufacturer's procedures.

Northern Machinery Group Ltd shall not be liable for production losses, downtime or consequential losses arising from machinery failure.

## **7. Used Machinery**

Used machinery is sold in the condition inspected unless otherwise stated in writing.

Customers are responsible for ensuring machinery is suitable for their intended application.

Where applicable, machinery may be demonstrated prior to sale.

No warranty is given on used machinery unless specifically agreed in writing.

## **8. Hire Equipment**

Hire equipment remains the property of Northern Machinery Group Ltd at all times.

The hirer is responsible for:

Safe operation of equipment.

Loss, theft or damage during the hire period.

Returning equipment in a clean and serviceable condition.

Consumables used during hire are chargeable separately unless otherwise agreed.

Late returns may incur additional hire charges.

Any damage beyond normal wear and tear will be charged to the hirer.
