Agent/Appraiser & Staff Dues Information: A one-time startup fee of \$75 applies to each agent or appraiser when opening a new office, as well as to any new agent or appraiser joining an existing office. Unlicensed office staff are not required to pay dues; however, a \$75 startup fee applies to each. Additionally, a \$75 transfer fee will be assessed whenever an agent transfers to another participating office within NECAR.

Please note the following pro-rated dues for the yearly MLS portion of your membership. The figure includes both the startup fee and the proration for each month until the next yearly fees are due in the following year. The MLS year runs June 1^{st} – May 31^{st} .
