NECAR President Keith Jackson, Century 21 Lifetime Realty, presented home buying trends to local residents at the Adair County Public Library.

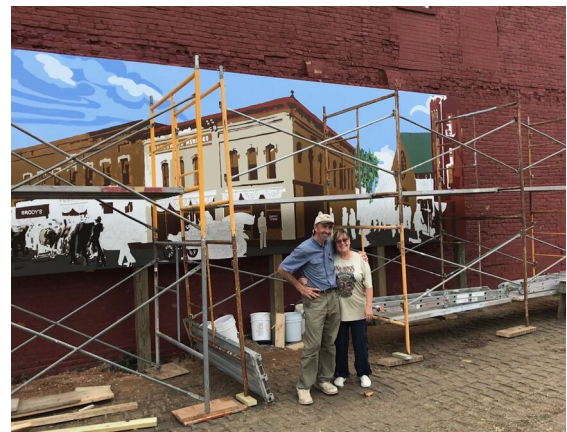


LUNCH & LEARN

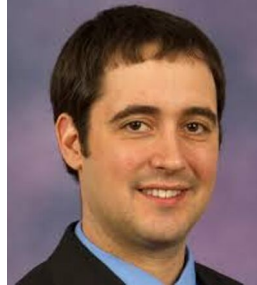
