- i. Airport Reported by Steve Shallbetter:
 - 1. Approximately 6400 gallons on hand at \$3.60/gallon
 - 2. One of the two fuel dispensers sheared a gear and quit working. Parts quoted at approximately \$350 have been ordered and service is in progress to repair. Minnesota Independent Petroleum is doing the work
 - 3. S.E.H. has furnished the costs for removing Hangar #1. 90% will be paid through the grant. The cost to the City will be \$1,110. Removal of this hangar is a compliance issue; the Advisory Board has no formal position on the matter. To move forward the City needs to approve the acquisition of Hanger #1. M/S/P: Gilsrud/Eck to move forward with the acquisition and removal contingent upon FAA's approval of the CATEX.
