Tracy Yost joined the Moss Landing Power Plant/Vistra Fire Symptoms Facebook group on January 19, 2025, but so far haven't posted, commented, or reacted to any posts or comments.



Pam Marino, a journalist with Monterey County Now, published an article on January 23, 2025, about a recently created group in Pacific Grove with the goal of walking every street. Coincidentally, Tracy Yost was interviewed and said that walking every street “gives her a way to meet neighbors, and indeed, the conversations overheard involve people introducing themselves and getting to know one another.”

As more and more area residents report increasing symptoms and negative health effects related to the Vistra Moss Landing Plant Fire, with dwindling coverage from local media, the wife of Vistra Corp. Vice President of Operations and the Moss Landing Power Plant, Tracy Yost, had no issue getting media coverage encouraging residents to get outside and walk every street.
