Vistra Corp. through its political action committee (PAC), Vistra Employee Political Action Committee of Vistra Corp. (ID: C00226548) has made a considerable amount of contributions in recent elections, including but not limited to Congressman Jimmy Panetta, California State Senator John Laird and Assemblymember Robert Rivas.

Vistra Corp. supporter and recipient of a December 9, 2024, \$7,500 contribution to the Tried-and-True PAC, Congressman Jimmy Panetta (CA-19), has largely been silent in the wake of the January 16, 2025, Vistra Moss Landing Plant Fire despite the fact he represents the area where the Vistra fire occurred. Congressman Panetta has only made a single public visit since the fire to Moss Landing, Calif. on Saturday, January 18.

We are monitoring the fire in Moss Landing and in contact with first responders and the compromised battery storage facility. We ask residents to stay alert, follow the directions of emergency services, and stay safe.

Clean energy facilities have a responsibility to be operated safely and to protect the surrounding communities. I urge this battery facility to be transparent and cooperate with authorities to address this emergency situation swiftly.

After 3 previous incidents at the Moss Landing Power Plant, why didn't Congressman Panetta demand transparency before the Vistra Fire in Moss Landing, Calif. on January 16, 2025? We can think of more than 7,500 reasons why.

"As California and the Central Coast derive more and more of our energy from renewable resources, storage is key for ensuring that power is available when the sun isn't shining, and the wind isn't blowing. The energy storage facility that Vistra is deploying in Moss Landing will help us build a more reliable, low-emission grid, providing zero-emission power to communities far and wide when they need it. As we face the increasing threat of wildfires and disruptions to our grid, this backup power can serve to bolster our grid's stability and reliability."

It should be noted that Congressman Panetta had a second political action committee called JOINING IDEAS TO MOTIVATE MOVEMENT FOR YOU (JIMMY PAC) in election years 2022, 2020 and 2018.

On January 21, 2025, State Senator Laird would also publish a response to a online <u>change.org</u> petition, Halt the Establishment of Battery Storage Facilities in Monterey and Santa Cruz County. In his response, Senator Laird stated "To help rebuild community trust that the facility can operate safely, significant changes are necessary."

Assemblymember Robert Rivas received a \$5,000 contribution in 2024 from Vistra Corp., however, his campaign financial documents are also pending to the Federal Elections Commission. It should also be noted that Assemblymember Rivas' brother, Ricardo "Rick" Rivas, is one of 12 members of the California Coastal Commission.

Assemblymember Dawn Addis has not accepted any contributions from Vistra Corp.

Elected officials are more concerned with the community trusting Vistra, a for-profit corporation. Transparency, accountability and ethics are paramount to being an elected official, and in this regard our elected officials have sold their vote, our vote and torched public trust while pandering to Vistra, a corporation that poisoned our communities.
