#### Now, therefore, the parties agree as follows:

- Vendors Must comply with all relevant local, state, and federal law. Vendors shall have access to the location space agreed upon by the parties no less than 2 hours before the event's start time (8am) for setting up Vendors vending station. Selected vendors who do not pay by <u>JUNE 8, 2024</u> will forfeit their deposit/vendor spot for this event. Vendors are responsible for obtaining and paying for any and all business licenses, permits and taxes that are needed for operation including state sale taxes. The Host is <u>not</u> responsible for any items that are needed for the Vendor (i.e. generator, outlets, electricity). All needed items are the responsibility of the Vendor. Vendor shall not vend any goods/services other than those described herein at and during the Event without Host's written consent. This includes a stall, food van, caterer, food business registration or notification by the Health Protection Service.
- Vendor's station shall consist of a 10x10 space ONLY and shall be clean and orderly; and shall comply with all applicable laws and regulations. No vendor 10 x 20 tents, no vendor mobile shops will be permitted on the picnic grounds. Vendors MUST use tent weights to ensure safety of all who attend the event. Vendors must keep their merchandise and displays within the allotted boundaries of the space provided by Bernard Terrell Cigars. Vendors MUST have business signs to identify their businesses. ("A business with no sign is a sign of no business.")
- Vendor's staff may announce availability of the goods to be vended only while they are within the confines of the vendor's location.
   Vendor's staff shall be clothed and groomed in a clean, neat fashion and shall conduct themselves in an orderly fashion. No loud music, noise, or sound amplification devices shall be used by the vendor's staff at the location.
- Food Truck vendors must stay in designated food truck area, food truck must be attended to at all times while in service. Vendor
  responsible for properly dumping all trash in designated areas. Vendor responsible for all food and sanitation licenses needed to
  operate and serve food in Illinois.
- Vendor shall have access to the location for up to 1 hour after the Event's conclusion at 7:00 pm to dismantle and remove all things
  brought to the location by Vendor. Vendor shall leave the location clean of trash and substantially in the condition it was before the
  Vendor occupied it. Vendor hereby agrees to indemnify and hold harmless the Host against any damages or claims that may arise in
  connection with Vendor's presence at the Event and Vendor's activities of any kind.
- Vendors must be set up and ready to serve, sell, and operate by 10:00am (THE OFFICIAL OPENING TIME OF EVENT) Vendors MAY
  NOT LEAVE VEHICLE IN GRASS AREA after unloading. VEHICLE MUST BE MOVED IMMEDIATELY AFTER UNLOADING
  MATERIALS. Vendors must remove their own trash and debris from the space and properly dispose of recyclable and compostable
  items in containers. Vendor will be charged a \$150.00 penalty for any debris or trash left on site with photographic evidence and will
  not be invited back to vend at Bernard Terrell Cigars events.
- Vendors are prohibited from selling counterfeit items, unlicensed merchandise, guns, ammunition, alcohol, and drug paraphernalia of
  any kind, items prohibited by Chicago, Illinois or Federal law or any merchandise that the event considers racist, discriminatory, or
  offensive.
- Vendor's space is NON Transferrable. Vendor may not allow anyone else to use the space without the express written permission of Bernard Terrell Cigars.
- Bernard Terrell Cigars offers NO guarantees or warranties of any kind. Picnic occurs rain or shine. NO REFUNDS will be provided if the
  vendor does not come and the picnic is going on.
- Vendor will release and will hold harmless the Bernard Terrell Cigars Annual Cigars in the Park Picnic, Bernard Terrell Cigars, T & J
  Steward Enterprises Inc., Cook County Forest Preserve and their owners, officers, directors, agents and employees from any and all
  claims arising from any injuries, losses or damages (whether to person or property) caused by Vendor, vendor's merchandise, or
  vendor's participation in the Picnic.
- Bernard Terrell Cigars may take appropriate action against any vendor who fails to comply with relevant laws (federal, state, and local), the Vendor contract or other rules established by Bernard Terrell Cigars. Such action may include, but is not limited to, revocation of this contract, permanent denial of selling privileges or other relief deemed necessary by Bernard Terrell Cigars.
