1. CONSENT AGENDA*

a. APPROVAL OF MINUTES: February 7, 2026

Councilor Barber made a motion to approve the February 7 Minutes with changes, Councilor Butters 2nd. Motion passed.

2. DEPARTMENT REPORTS

a. ROADS-Councilor Butters

The grader went out to get some snow off the road where the county may have created berms. There was some ice on Mesplie that needed some work.

There was a concern about the batteries on the grader. Mayor Snyder would like to see solar panels on the side of the building to charge the batteries. Discussed putting the blade on the snowblower since it may work better. Council discussed snow removal. Some culverts will be taken care of this spring. Also, discussed water near the museum and diverting it and other running water issues.
