1. CONSENT AGENDA

APPROVAL OF MINUTES: June 6, 2025 *

BUILDING MAINTENANCE/HISTORICAL-Councilor Barber

The inspector should be here end of July. The NW corner of the jail is damp.

Discussed a French drain inside the jail and solutions to reduce the moisture.

IRRIGATION-Councilor Snyder

Reported that it takes 6 hours to get about 10" of water on the pond. Councilor Snyder is concerned about the power lines on the ground. He would like to get them in the ground or covered. Council discussed a culvert to prevent a washout.
