



Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.1stkingtax.com, www.ktifinancialcpa.com and KTI FINANCIAL CPA and governs data collection and usage. Collection of your Personal Information

In order to better provide you with products and services offered, KTI FINANCIAL may collect personally identifiable information, such as your:
