REVEALING THE HAUNTED PAST OF HISTORIC TALBOTT, TENNESSEE

Intentionally ignored and buried in the Hamblen County records for many years, public interest has once again brought the Jeremiah Lexer murders to light. Once a dark blemish on the seemingly quiet East TN county, Hamblen County now receives notoriety as the birthplace and home of one of America's Earlierst Known Serial Killers – Jeremiah Lexer. It is located at 7588 W. Andrew Johnson Hwy Talbott, TN 37877.

Lexer lived on a massive plantation on the outskirts of Hamblen County with his extended family from 1826-1902. Records show that he was a seemingly upstanding member of the community, with no notable grievances with either the government or neighbors.

Beginning in 1887, multiple missing people cases were reported to the Hamblen County Sheriff James Franklin Hayes over the next 15 years. These reports were considered unlinked and attributed to dangerous mountainous wildlife or becoming lost in the massive Appalachian Mountains. No one suspected that a quiet citizen was responsible for these suspicious disappearances. Tragi-

cally, it was discovered a murderer lived amongst them.

On July 5, 1902 Jeremiah Lexer took his own life after a brutal killing-spree that left his entire family slain and nothing but bloody carnage left for people to discover the following day. After his plantation was searched, the gruesome discoveries of over 30 bodies was a shock to the community. The blatant disregard for human life and extensive torture tactics discovered, sickened those who saw it. Some victims were locked in a giant ironclad room, within one of his barns, where they were left to literally starve to death. Many of the asphyxiations took place upstairs in his office. The victims' bodies were dropped by secret chute from his office to the basement, where some were meticulously dissected, stripped of flesh, crafted into skeleton models. Lexer also burned some of the bodies or placed them in lime pits and other chemicals for disposal. Within the basement were discovered two giant furnaces as well as pits of acid, bottles of various poisons, and even a stretching rack.

Recently, this property has been used as a restaurant but closed after too many documented accidents. Many blame the spirits of the past as previous workers cite specific examples of this property being infested with restless spirits. Some stories have

included violent, paranormal activity – others passive experiences. Multiple paranormal groups have verified activity.

A little girl can often be seen in the 2nd bedroom, gazing out of the window, facing the East. Many people driving on 11-E report

seeing a man with an axe outline peering out of the windows.

The Lexer murders were covered up and forgotten for years. The government officials who took it upon themselves to cover up these atrocities, for the good of the community, have long since passed, and the secret Lexer files were officially released in 1987. Today the Lexer Plantation serves as the home of Frightmare Manor – a highly successful and nationally recognized Haunted Attraction. This is privately owned property.

Bud & Phyl Morello's Great Adventure

We're out here in Colorado trying to visit our son Ben and we thought that on the way we would go to the Grand Canyon since we had never been there. Beautiful place but it is a shame it is loaded with smog from the cities.

On the way out we had to stop three times to get our motor home fixed from overheating. Finally we had it flushed in Albuquerque at a cat dealer.

We ventured on to the canyon and stayed five days.

We also saw some Indian ruins and sunset crater in Flagstaff, AZ.

After the Grand Canyon we went to Mesa Verde, just west of Cortez, AZ. More ruins but you had to climb down steps and explore inside the ruins and then climb a series of wood ladders to get to the top. I am having a little trouble at 7000' altitude.

After we left Mesa Verde we went to the four corners monument where four states, Colorado, New Mexico, Arizona and Utah meet. I sat on all four states at once, Never knew my butt was that big!

After leaving we went to Durango, Colorado and were going to try to make it to Montrose, Colorado which was only 150 miles.

We never made it to Montrose because you guessed it, major "Brown Pants Roads" worse than Escalente and the Merced canyon.

I used the exhaust brake and overrode the transmission to drop down into first gear.

We found a campground in town and I had a beer to calm myself.

After talking to other campers they said that after most campers take that road once, they never do it again!

Not to actual size! They are 4"x 2.75" To determine the myths about the antique vehicle license plates, I thought I would do the research and find the actual code of law about them. We have all heard that you can only drive in parades, to shows or cruise-ins but a lot of us drive them a lot more often. So read the article below to determine your ideas about them.

TENNESSEE ANTIQUE MOTOR VEHICLE LAW

Antique Motor Vehicle Per Tennessee Code Ann 55-4-111, A person may register a vehicle as an "antique motor vehicle" providing that certain requirements are satisfied. The vehicle:

- Must be a motor vehicle over twenty-five (25) years old and have a non-modified engine and body.
- Can be used for participation in, or transportation to and from, club activities, exhibits, tours, parades, and similar uses as a collector's item.
- Can only be used for general transportation on Saturday and Sunday, and
- Can be used on any day for the purpose of selling, vehicle testing, or obtaining repairs to or doing maintenance on the vehicle.

NOTE: Both cars and motorcycles may be considered antique motor vehicles, if all provisions are met as stated above.

No renewal required. The registration is a permanent registration and is not required to be renewed annually. Once assigned, the license plate cannot be reassigned to another vehicle.

Violations. Any person violating the provisions of Tennessee Code Ann. 55-4-111 will be restricted from participating in Tennessee Antique Motor Vehicle plate program for five (5) years from the date of the violation, will be asked to surrender the license plate and will be required to pay the full vehicle registration price for operating the vehicle. An example of a violation would be operating the vehicle for general transportation purposes on a day other than Saturday or Sunday.



Display of the antique motor vehicle plate. The antique plate can be mounted on the rear of the vehicle or the owner may display, on the rear of the vehicle, a license plate from an era when the manufacturer of such vehicle occurred, as long as the antique vehicle plate is maintained in the vehicle and is readily assessable and produced upon request of any law enforcement officer.

Vintage License Plates: Instead of registering a vehicle with the standard antique motor vehicle plate, a person may choose to register an antique motor vehicle with an official vintage Tennessee license plate of an era when the vehicle was manufactured, and may display that license plate as their official Tennessee vehicle registration on the rear of the vehicle. Provisions for vintage plates may also apply to motorcycles.

All other provisions of Tennessee Code Ann 55-7-111 must be followed to avoid forfeiture of the registrant's antique license plate.

Cost of registration. Class (C) Antique Vehicles - registration fee is \$27.75, plus any applicable county fees.
