I understand that this waiver and release Agreement is a material term and condition of being able to participate in Flight Activities, and that without this Agreement the increased costs and potential liabilities for Acuity Aeroworks, LLC would make Flight Activities either materially more expensive or completely unavailable to me. I WAIVE THE PROTECTION OF ANY APPLICABLE STATUTE OR LAW, AND I AGREE THAT THIS IS A GENERAL RELEASE EXTENDING EVEN TO CLAIMS THAT I DO NOT KNOW OF OR EXPECT TO EXIST WHEN I EXECUTE THIS AGREEMENT AND RELEASE. I certify that I have adequate insurance, including medical and disability insurance, to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions which could interfere with my safety in the Flight Activities, or else I am willing to assume, and bear the costs of, all risks that may be created, directly or indirectly, by any such condition.
