- **Motion made by Chairman and Supervisor Sean Wilcox, to terminate Alan Gilliard JR. due to lack of attendance, misuse of coquina work truck, etc. Second by Secretary and Supervisor Alfonso Finelli.**
- **Chairman and Supervisor Sean Wilcox made the motion that Alan Gilliard be trespassed from Coquina property to Deputy Varnadore with OCSD. Motion Unanimous.**
- **Motion made by Chairman and Supervisor Sean Wilcox for Brittney to run an ad for superintendent, motion seconded by Treasurer and Supervisor Ericka Pinder**
- **Motion made by Chairman and Supervisor Sean Wilcox to post meeting minutes unapproved on the website. Motion unanimous.**
- Marlon made interim superintendent.
- Robert Knapp gave the board GPS records of the grader going out of Coquina boundaries and claimed Jeremiah Ailes was the operator.
- Robert Knapp claimed that a culvert pipe was stolen from the North pit, a police report was made by Robert Knapp.
- There was a formal complaint regarding multiple employees. The complainant stated Robert Knapp approved timecards for Alan Gilliard but did not match GPS records for Alan Gilliard's work truck. The board agreed to investigate this claim.
