MEETING MINUTES OF THE

BOARD OF SUPERVISORS OF COQUINA WATER CONTROL DISTRICT DECEMBER 14, 2023

Pursuant to published Notice, the Board of Supervisors of Coquina Water Control District (the "District") held its meeting on Thursday, December 14, 2023, at the District office, located at17429 NW 242nd Street, Okeechobee, Florida 34972.

CALL TO ORDER

Supervisor Jeffrey Hubbard called the meeting to order at 6:35 p.m..

ESTABLISH A QUORUM

A quorum was established with the following attendees:

Supervisor Jeffrey Hubbard; Supervisor Christina Trojanowski; Supervisor Sean Wilcox; Superintendent Howard Sensaboy, Engineer Gene Schriner and Paralegal Erin Fralix.

OLD BUSINESS

Mr. Hubbard asked about revising the Employee Handbook. After discussing same, the board agreed to schedule a workshop on January 11, 2024 at 5:00 pm.

Mr. Hubbard asked if Mr. Sensaboy was able to switch the wifi/phone service. Mr. Sensaboy stated he contacted Verizon and they quoted \$140 per month, which is \$110 less than Centurylink. This includes unlimited wifi, company cell phone, 1gb wifi box and office phone. Once they receive the phone they will port over the office number, which can take up to two weeks. After the thirty day trial with Verizon he will discontinue the service with Centurylink.

Mr. Hubbard explained a new joystick for the John Deere had to be purchased and same has been installed.

NEW BUSINESS

Mr. Hubbard asked about the five (5) year permits. Mr. Sensaboy explained the current five year permit expires in 2024 and is for the canal reconstruction. He also explained they recently certified the permit for 160th & will be certifying Section 33 soon. Mr. Schriner explained they have to meet with SFWMD in the field regarding Section 33. The question was asked why the canals have not been completed within the five year permit. Mr. Sensaboy stated the reason they have not started

on Canal C & B is because the District does not have easements from some of the landowners along these canals and therefore there are some places that cannot be accessed. Also, on Canal B, from 2-mile South, there are areas where the canal is in the wrong place. The board asked Mr. Sensaboy to obtain maps from the surveyor showing where the canals and our easement lines are located. Once they have these and can review same we will move forward with obtaining the missing easements.

Ms. Trojanowski would like to have a map of all the roads so we can keep track of what work is being completed. Ms. Fralix will obtain a map of the roads & have same laminated.

Mr. Hubbard made a motion to make Marlon foreman and for him to keep his work truck. Ms. Trojanowski seconded that and same was unanimously passed.

ACCOUNTANT'S REPORT

Mrs. Williams was not present.

ATTORNEY'S REPORT

Mr. Fitzpatrick was not present.

SUPERINTENDENT'S REPORT

Mr. Sensaboy stated the paperwork has been submitted to Seacoast with regards to the cds.

Mr. Sensaboy stated there are two pipes under 208th Avenue that need to be replaced. There are two pipes behind the shop that feed the reservoir that need to be replaced.

Mr. Sensaboy put the equipment in the reservoir behind the shop and he wants to hold off on renting the long stick as he feels he do most of the work with the District's equipment.

PUBLIC COMMENTS

Mr. Jim Griffin brought up a discussion from the previous meeting regarding raising weirs. He asked if by doing this will it cause more flooding. Mr. Schriner explained there are three structures in the back reservoir and because improvements have been made to Canal D and E, South Florida Water Management District has stated we lost storage and have to make it up. In order to make it up, we have to raise the outfalls. Mr. Sensaboy stated one of the three reservoirs is basically just a holding cell and the elevation of the weir is still higher than the two pipes that feed that reservoir. He further explained that since Canal E has been completed, there have been no flooding issues. Mr. Schriner further explained SFWMD's mission is water quality & they do not care about flooding. He also explained these weirs must be raised before SFWMD will consider permitting our plans for the crossing on Canal D.

APPROVAL OF MINUTES & WARRANTS

Mr. Hubbard made a motion to approve the Minutes & Warrants for November 2023. This motion was seconded by Ms. Trojanowski and same was unanimously passed.

The next regular board meeting is scheduled for January 11, 2024 at 6:30 p.m.. This meeting was adjourned at 8:10 p.m..
