**#5 – REPORT FROM ATTORNEY:**

-Weiss and Serota has been working on our request about doing roads and

this far into her investigation it does not appear that Coquina legally must maintain roads. Mr. Fitzpatrick will be inviting her to attend next month's meeting to give the board an update via zoom.

-During the landowners' meeting with voting there was a contest made on votes, due to this contest Mr. Fitzpatrick will be taking the original votes, supporting documents, and ballots with him to do a recount.

- **Motion made by Supervisor and Chairman Jeff Hubbard to seek restitution from Jessica Dakin, seconded by Supervisor and Secretary Tonya Schumacher.**
- Discussion on why AJ was taking a truck home, concerns regarding insurance coverage discussed. **Motion made by Supervisor and Chairman Jeff Hubbard for AJ to take his work truck home, seconded by Supervisor and Treasurer Sean Wilcox.**
- AJ withdrew his request for an investigation on the board and a previous employee.
- **Motion made by Supervisor and Treasurer Sean Wilcox, seconded by Supervisor and Chairman Jeff Hubbard for AJ to receive Life-lock for one year due to the slip in a freedom of information act.**

- **Motion made by Supervisor and Chairman Jeff Hubbard, seconded by Supervisor and Treasurer Sean Wilcox for Coquina to rent the long reach from NED.**
- Aj is moved to second in command by Superintendent Sean O'Connell.
- Discussion about being able to do random drug tests on employees through a third-party company that comes to the facility. \* Office administrator needs to get 3 quotes for next month's meeting \*
- Discussion about Tonya not believing Coquina should pay for AJ's life-lock due to Tonya not receiving life-lock from Coquina when her social security number was leaked in May 2025 to Jessica Dakin in a Freedom of Information act.
- **Motion for Tonya Schumacher to receive reimbursement for her LifeLock subscription due to previous social security slip back in May made by Supervisor and Treasurer Sean Wilcox, seconded by Supervisor and Chairman Jeff Hubbard.**
