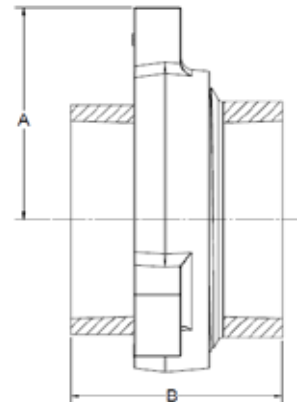

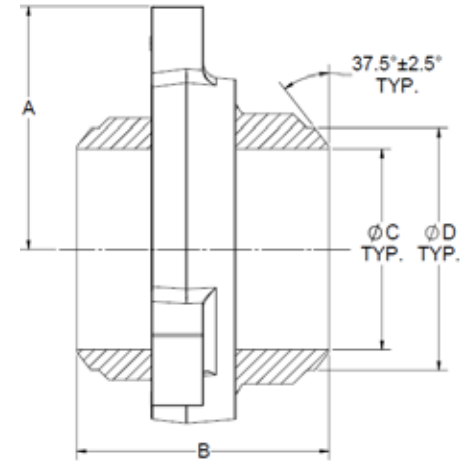

The metallic components are separated by two insulating rings, one of which also functions as a sealing member. Materials used for insulating the connection and the double BUNA o-ring arrangement used for sealing are constructed of high quality materials that are resistant to most of the process fluids and chemicals that are routinely encountered during oil and gas production.
