Old Business and New Business at O.C.C. December 2018



Under Old Business the Floor was opened to Dennis Osterhorn by President Kendall Willis.

Dennis went on to discuss the By-Law changes published in the January Vette Gazette.

The first change essentially proposed to change the dates new candidates for club officers would be nominated to the September meeting instead of the October meeting. Also that all nominations would be closed at the October meeting. An official list of candidates will be published in the October Vette Gazette with the election of officers to be held at the November OCC meeting. The change was voted and ratified by the membership.

The second change to the by-laws was to allow a single signature on a check issued by the Treasurer. It also stated that no obligation, debt, or other liability shall be incurred by the Treasurer without specific approval of the officers. Dennis went on to state that the bank doesn't ever look at the signatures on a check unless there is some kind of issue regarding the check. Also that most of the Club's banking is done with the debit card so signatures aren't required on most transactions. Dennis added that he is in constant communication with the board about every expenditure that arises and gets a verbal or written agreement, mostly through emails, on whether to appropriate the monies or not. He added that modern communication is far different and obviously much more rapid than it was 10-15 years ago. Dennis said he went back sev-

eral years with the bank to see if two signatures had indeed been signed and they had not.

A third by-law change was brought forth about adding the Wednesday night dinner planners to the Official Volunteer list.

Rick Poepping stated that it should be the President presiding over the discussion on the new by-laws according to Robert's Rules of Order. He pointed out that the addition of the Wednesday night dinner planners to the by-laws, however well intended, was not following the protocol of said rules. Dennis agreed, but defended himself stating he was trying to help out. The vote on whether or not to change the by-laws regarding the two signatures was tabled as was the change for the dinner planners and Dennis handed the paperwork off to President Kendall Willis.

Bill Prewitt added that it didn't matter if the bank required the two signatures or not on a check. It was a club mandate to do so for our own protection.

Dave Newell added the current by-law should be followed as is, and when he and his friends were on the board, the club was about the people, and more fun, and that it should go back to being the club. He threatened not to pay his dues.

Lori Bleitner added that she believed the club members should be kept interactive in the decisions about how much money is spent and for what. She mentioned she was disappointed when she discovered the club had appropriated funds for the new club computer. She had two or three old ones she would have donated. She also was concerned the club spent \$400 on glasses for gifts for the event organizers.

Mary Heeley added that major expenses in the past always had two signatures when she was on the board. She also echoed that it was for the Club's protection and that pretty much any organization requires two signatures for expense approvals. Mary was in the opinion the by-law remain as

written.

Steve Majino agreed that when he was president two signatures were required and always signed and the by-law should not be changed.

John Miceli added that Denny has brought forth a very detailed budget for the club to see at any time. Dennis has upped the ante to assist the club to remain solvent by doing so. Also that the expense for the computer was discussed during earlier meetings before the computer was purchased and all attendees seemed to be in agreement. John also stated that old computers are just that, old, and probably not a good investment. John also said the 99% of all money went back into the club for events or to donations that were agreed/voted on by the club membership. He also stated that he certainly did not wish to alienate any club member by decisions made by the board.

Discussed by the membership was an amount that must be brought forth to the membership before money is spent. The number most people seemed to agree on was \$200 to \$250 or more had to be discussed with the membership before funds would be appropriated. This has not been sent to the board for review or the newsletter editor for publication as of this printing.

After some very lively debate there was no vote on whether the proposed by-law change for the signatures on checks be changed or not. The addition of the Wednesday night dinner planners was not further discussed. There was no new business discussed,


