The proposal to change the OCC ByLaws is: A membership in the OCC is a single membership, or a membership for a couple. "A Couple" would include married couples, partners, and those in a relationship as long as they are residing at the same address. All rights of the OCC would be available to both members as long as they own a Corvette. If they sell the Corvette, they will continue to members as long as they keep their Membership Dues up to date. OPTIONAL: The term "Associate Member" would be for those who wish to be part of the OCC but do NOT own a Corvette. The Associate member has no voting right. Sponsors and those who contribute to the OCC could become Associate Members.

Dues would be determined by the OCC Officers. This will be up for discussion at the September meeting. As with any change to the ByLaws, it will be necessary for ALL members to vote on any change.

- There was no 50/50 drawing this month. The meeting was adjourned at 9:15 PM by motion from Larry Dann, seconded by Randy Vollmer.



September 2020 By Laws updates

Section 2 Membership Status

Current:

- A. Primary Any person duly approved, as provided for in SECTION 1 of this article and having paid the required dues in accordance with Section 3. **NO CHANGE**
- B. Associate an additional member designated by duly approved active primary member. **CHANGE** see under new item B
- C. Charter All members who organized the Club on July 21, 1979. NO CHANGE
- D. Honorary Any person who had commended themselves to club esteem and/or has been named an Honorary Member by a majority vote of club members present at any regular meeting. **NO CHANGE**

Reason for change:

The Following proposal is to change the OCC Bylaws: Currently the bylaws membership allows for a member to choose an "Associate Member" to be a part of the "Member's" membership. This is unclear in many ways as to their status and functionality. The name "Associate" also is offensive or downgrading to many. In most cases the OCC Member's spouse, or partner is the 'Associate 'The following amendment would allow for all Members and their spouse, or partner to be equally called "Members" of the OCC. The proposal is to change the current bylaws to simply state:

B. A membership to the OCC is a single membership, or a membership for a couple. A couple would include married couples, partners, and those in a relationship, or if their name is on the title. All the rights of the OCC Club would be available to both Members as long as they still own a Corvette. If they sell their Corvette, they could continue to be members as long as they keep their membership dues up to date.

SECTION 3: MEMBERSHIP DUES Effective January 2018 membership dues for Corvette owner members shall be thirty-five dollars (\$35.00) per member annually to include an associate **couple membership**. Dues are to be paid at or before the December meeting. Members who have not submitted their dues by February 28th 1 st of the current year will be suspended from the organization and no longer have privileges. Honorary members and club sponsors are exempt from these dues. New members joining after July 1, will pay \$20.00 for the balance of the calendar year. Lapsed members will pay thirty-five dollars (\$35.00) any time during the year.

Honorary members are entitled to all club privileges except the right to vote or hold office.

SECTION 2: ELECTION OF OFFICERS

D. Election of officers shall be determined by a majority of the valid ballots (paper and /or show of hands) cast at the December November meeting. Primary and associate Active members for a period of less than three months or non-paid members shall be ineligible to vote.

E. An Active primary or associate members for a period exceeding three months shall be eligible to run for any office, but only one office. Members shall be allowed to run as a team for the office of President and Vice-President, only if they choose to do so.

Section 11: OUT REACH VOLUNTEER The Club may ask for a Volunteer (a member / associate member) to handle Outreach duties. These duties would include the following:

- 1) Send get well cards to members and associate members when notified of hospitalization or surgeries.
- 2) Flowers will be sent on loss of club member, associate member or immediate family (defined as parents, spouses and children). Floral arrangements are limited to \$75 for members or associate members excluding delivery charges. Floral arrangements are limited to \$50 for immediate family excluding delivery charges.

These changes in no way affect our Dues or other items of the Bylaws.

One other change that needs to be corrected to fall in line with another section regarding elections is:

SECTION 2: ELECTION OF OFFICERS

C. Elections shall be held at the December **November** meeting. Nominations shall not be reopened at the December meeting.

Items denoted in **RED** are the current item to be changed.
