Charles Heard made the motion to adopt the agenda. Sextus Shannon seconded the motion. All were in favor.

Approve May 7, 2024 minutes:

Nathan Chisolm made the motion to adopt the May 7, 2024 minutes.

Charles Heard seconded the motion. All were in favor.

Special Presentation

• St. Jude Bike-A-Thon Committee Presentation- Sextus Shannon and the St. Jude Bike-A-Thon Committee made a special presentation in the form of plaques to the Mayor and Board of Aldermen, Police Department, Public Works, and Fire Department for their assistance with all of the St. Jude Bike-A-Thon fund raising events.

Public Hearing

- **804 Central Street-** Efrom Coleman Property- Efrom Coleman, *present* along with Code Enforcement Officer Shane Davis, *present*: declare it as a public nuisance; repair or demolish the property; fire damage in March 2024; small building behind the house doesn't have much damage and have wiring but no access to utilities; Efrom Coleman was given 90 days to clear the site and haven't and the timeframe has expired; meeting tonight to discuss the future of the property; Efrom Coleman said he is disabled and can't afford to repair or fix up the property as quickly due to his disability and low on funds and he doesn't have home insurance.
 - Charles Heard made the motion to continue the discussion during executive session.
 - Sextus Shannon seconded the motion. All were in favor.
- 2023-2024 Mid-Budget Review- Brandy Smith explained the budget amendments; increase in the computer line item due to website creation and help with reconciliation, PERS rate increase will begin July 1, 2024 but was already included in the original 2023-2024 budget.

- Nathan Chisolm made the motion to approve the 2023-2024 fiscal budget amendments.
- Sextus Shannon seconded the motion. All were in favor.

Public Comments

• **Developer George Provias, Oaks of Plantersville Development Updates**- Amy Middleton, *present*, spoke on George Provias behalf- gave a brief overview about the Oaks of Plantersville development; normally takes a year to complete; will be a part of the green community; will have a community center that will consist of five computers/copier machine (will mostly be for the tenants); targeting families with children; to begin construction September 2024. The Board thanked Amy Middleton for her time.

Water- Public Works Director Jim Curry, present

- Public Works Director Jim Curry explained the reason for the high water loss percentage (29.4%); it was due to discovering a leak at the booster station and is currently working on the repairs.
- **ESG-** Renee Morris inquired about the EGS report; Jim Curry said that one of the sewer pumps is down for repairs (217 State Park Road) so right now one sewer pump is working; don't have to purchase a new sewer pump.

- Allowed Tony Schmidt (*present*) to explain how to renovate the south park pavilion into a community center: need a drawing for the kitchen for plumbing and electrical; need a new toilet in the front pavilion; south pavilion leave it open and spray for installation; metal doors; Mayor Shelton Shannon suggested to draw up plans and present at the next Board meeting
- Bobby Parker also explained how to fix the electrical at the park; would like to use Tallent Electric, LLC as the contractors to make the repairs (\$45.00 man per hour with a 2 man crew): the tree roots had grown into the electrical wires between the concession stand and the main power source; the contractor will replace the wiring and install it in conduit around the trees; the cost will consist of researching the problem, copper wiring, conduit, conductors, and labor; cost estimates between \$1,500.00 and \$5,000.00.
 - Nathan Chisolm made the motion to approve repairing the electrical at the park and use Tallent Electric, LLC as the contractor with the cost between \$1,500.00 and \$5,000.00.
 - Sextus Shannon seconded the motion. All were in favor.
