**Hunter Kerry- Rose Pest Control**- Introduction as the new mosquito control coordinator through Rose Pest Control. The weather has been a problem with the rain and heat but they have increased the larvicide and barrier treatments. He requested that residents pay attention to standing water within their own property lines to reduce mosquito activity. The residents of Secord Township have access to the Barrier Treatment Programs offered at no charge. This treatment can be done once, every 30 days and residents must call each month to schedule a new appointment.
