Discussion on Lean to for A/C and Generator: Pole Building quote of \$11,000.00 is too high. Agreed to put out for bid. Publishing in June.

Road Committee:

2025 plan is in place and already has begun. Completed brining on dirt roads, Completed crack sealing of 8.4 miles of road. Contract for paving are all signed and approved and will begin between now and end of August, weather pending. Sugar River Rd repave has begun.

The Road side Park on M30 will be closed temporarily this summer for new bathroom facility to be installed. No dated on closure yet.

Constable: Maxine reported. All is Well at Eagles. Waiting on new liquor license. Rogers has no liquor license.

Zoning Administrator: Harold Day reported: 3 new Zone Reports in April.

Many phone calls received inquiring on new builds prior to water returning
