Township Hall and Grounds will be monitored at all times by video camera. Hall Monitor will be on duty at all times during the rental of hall.

RULES/TERMS OF RENTAL:

1.	Smoking is not allowed in the Township Hall. If the Township Hall is contaminated by
	smoke, the renter will be liable for the costs to clean the smoke odor. Renter

2.	Alcohol is not allowed in the Township Hall or on Township Property. Renter

3.	Parking on the grass is prohibited. If the sprinkler system is damaged by illegal parking
	the renter will be liable for any damage for repairs.
4.	Commercial or nonprofit activities at the Township hall are prohibited. Renter
	initials
5.	Removing any Township Property (furniture, etc) from the Township Hall is
	prohibited. The renter will be liable for the full replacement cost of the Township
	property removed or damaged. Renter initials
6.	The Renter agrees to and shall hold the Township, its agents, officers, employees,
	successors and assigns harmless from any and all claims, damages, The Renter is in
	possession of the premises. Renter initials
7.	The Renter shall provide security during its use of the premises, appropriate to the
	Renter's use. Additionally, the renter will remain on site throughout their rental period
	and shall not rent the Hall on behalf of others. Renter initials

8.	The Renter agrees to be liable for any and all damage to the Township Hall, and
	Township Hall grounds, or personal property that may occur wile the Renter is in
	possession of the premises. Renter initials
9.	The Renter shall provide the Township with a copy of their current Home Owners'
	Insurance at the time this Agreement is signed. Renter initials
