A Bill to Be Entitled

'Moroccan National Eviction Act'

BE IT ENACTED BY THE DALIL AZIZ HERE ASSEMBLED THAT:

No Nationals should be evicted from their homes and if a home is occupied No Fictitious courts can send bailiffs out to home and evict occupants.

Michigan Bill #:222.003 DA-1003 Date: __04__/_06__/_2023__ An Act to Prevent Eviction of Occupants from their Homes in Allodium Moroccan Praedium Ante Michigan Be it enacted by the House of Dalil Aziz of Allodium Moroccan Praedium Ante Michigan in General Assembly convened:

Section 1. Definitions.

(a) "Occupant" shall mean any person who is the lawful occupant of a home in Allodium Moroccan Praedium Ante Michigan.

Section 2. Prohibiting Eviction. (a) No occupant of a home shall be evicted from their home in Allodium Moroccan Praedium Ante Michigan due to an inability to pay property taxes.

Section 3. Enforcement. (a) The Department of Taxation of Allodium Moroccan Praedium Ante Michigan shall be responsible for the enforcement of this Act.

Section 4. Severability. (a) If any provision of this Act is declared invalid, the remainder of this Act shall remain in effect.

Section 5. Effective Date. (a) This Act shall take effect immediately upon its passage into law.

SECTION 6. (a) The Cadi, (Moroccan Tax Assessor of Ampam), will oversee determining the regulations and parameters for the proper exercise of his/her unalienable rights.

Section 7 (a) this privilege will commence immediately upon completion of all AMPAM State Nationalization requirements.

Section 8 (a) any county, city, town, or municipal charter colony not willing to adhere to these Moroccan Laws will be fined One Hundred Thousand USD (\$100,000.00) (Units of Silver Dollar) by the State Provincial Government of AMPAM.

The Demand for Lawful Money shall be made initially for all payments towards fines and assessments, but upon full faith and consideration, may be deemed satisfiable in units of current United States issued "Legal Tender", i.e., Federal Reserve Notes.

SECTION 9(a). This Legislation will take effect immediately after acceptance by the Dalil Aziz (Matriarchal Council) and the Wazir Ali Rais (Prime Minister) of AMPAM. All laws in conflict with this legislation are hereby declared null and void notwithstanding.
