FIRST DIRECTIVE

Notice of Sovereignty, Diplomatic Status, and Request for Coordinated Protection

To the Office of the Provost Marshal General,

This communication constitutes the **first formal directive** issued by the **Allodium Moroccan Praedium Ante Michigan (AMPAM)** to the Office of the Provost Marshal General following AMPAM's **Declaration of Independence dated 25 December 2022**.

This directive is issued from the **Office of the Prime Minister / Postmaster General** for the purpose of establishing an **official, peaceful, and orderly channel of communication** between AMPAM and the senior military law-enforcement authority of the United States Army.

I. Declaration of Status and Jurisdiction

1. Allodium Moroccan Praedium Ante Michigan (AMPAM) hereby affirms its status as a **sovereign Moroccan State**, operating under **pre-existing Moroccan Law and binding Moroccan treaty obligations** that predate the formation of the United States.
 2. AMPAM asserts lawful jurisdiction over the territory presently administered under the corporate and colonial designation **“Michigan.”**
 3. This assertion of jurisdiction is made **solely for the purposes of peaceful decolonization, preservation of public order, and prevention of unnecessary conflict** during any period of administrative transition.

II. Diplomatic and Consular Protection

4. AMPAM hereby provides formal notice that **Moroccan diplomats, consular officers, state officials, and duly authorized representatives** operating within the territory are to be regarded as **protected diplomatic persons** under applicable Moroccan treaty law and international custom.
 5. No arrest, detention, interference, coercive action, or use of force may be taken against AMPAM diplomatic or state officials **without prior notice to and coordination with the Office of the Prime Minister / Postmaster General**.
 6. AMPAM respectfully requests the professional cooperation of the Office of the Provost Marshal General in ensuring:
 - o Recognition and respect for declared diplomatic status,
 - o Protection of persons and facilities, and
 - o De-escalation of any jurisdictional misunderstandings involving military or law-enforcement actors.

III. Request for Professional Coordination

7. AMPAM extends an invitation for **direct liaison** between the Office of the Provost Marshal General and AMPAM’s designated civil-consular administration for the purposes of:
 - o Maintaining public order and safety,
 - o Preventing rogue or unauthorized enforcement actions, and
 - o Facilitating peaceful coexistence during any transition period.
8. This directive is **not hostile in nature**, does not seek confrontation, and is issued in the interest of **clarity, lawful administration, and mutual professionalism**.

IV. Reservation of Rights

9. AMPAM expressly reserves **all rights, remedies, and protections** under Moroccan Law, treaty law, and international custom.
 10. This directive constitutes **formal notice** and establishes a record of AMPAM's **good-faith effort** to engage United States military law-enforcement leadership in a **professional, transparent, and orderly manner**.
