DECLARATION OF EXCHANGE NORTH BUILDING CONDOMINIUM

Exchange at Cameron Harbor, G.P., a Tennessee general partnership (hereinafter referred to as the "Declarant"), pursuant to the provisions of Tennessee Code Annotated, § § 66-27-201 through 507, known as the Tennessee Condominium Act of 2008 (the "Act"), for the purpose of amending the previously filed Declaration of Exchange Master Condominium, does hereby

WITNESSETH:



declare as follows:

WHEREAS, Declarant has heretofore submitted a certain tract or parcel of land (the "Property") in Hamilton County, Tennessee, to condominium ownership pursuant to the Declaration of Exchange North Building Condominium of record at Book GI 11395, Page 457, in the Register's Office for Hamilton County, Tennessee (the "Declaration");

WHEREAS, defined terms used in the Declaration and not otherwise defined herein shall have the same meanings ascribed to them in this Amendment No. 1;

WHEREAS, the legal description of the Property in the Declaration referenced Unit No. 1 created by the Master Declaration;

WHEREAS, due to a subsequently filed Plat of record that modified a property boundary and an a utility easement, the Master Declaration was amended by Amendment No. 1 to Declaration of Exchange Master Condominium of record in Book GI 1/436, Page 13, in said Register's Office, and Declarant desires to modify the property description in the Declaration so that the properly described Property will be subject to the Declaration;

WHEREAS, the Declarant desires to modify the Section 7.2 of the Declaration to add an additional Special Declarant Right in a new paragraph (i);

WHEREAS, the Declarant owns all of the Units in the Condominium and has the right to amend the Declaration for the purposes described in this Amendment;

WHEREAS, the Section, paragraph and Exhibit designations in the Declaration shall be used to reference the amendments thereto hereinafter described:

NOW, THEREFORE, for the above described purposes, Declarant hereby amends and supplements the Declaration as follows:

Section 2.1 Real Estate.

The legal description of the real estate attached to the Declaration as $\underline{\text{Exhibit } A}$ is hereby amended by substituting therefor the attached $\underline{\text{Revised Exhibit}}$ \underline{A} .

Section 7.2. <u>Special Declarant Rights</u>. This Section is amended by adding the following new paragraph (i):

(i) The right to utilize the portion of the Common Elements improperly designated as Unit 118 on the Plat (together with right of access to the adjacent common area restroom) as a sales, leasing, or management office for the Declarant or affiliates of the Declarant for the lesser of: (i) ten (10) years from the date hereof, or (ii) until the Declarant and its affiliates are no longer involved in the sale or leasing of any property in downtown Chattanooga. Such right is conditional upon (i) reimbursement to the Association of ten percent (10%) of the electrical charges incurred by the common element electrical panel located therein, (ii) restricted access to the common area restroom by key or combination lock, and (iii) restricting access by the public to the exterior entrance.

Except as expressly modified hereby, all terms and provisions of the Declaration shall continue and remain in full force and effect.

IN WITNESS WHEREOF, the Declarant has caused the foregoing Amendment No. 1 to the Declaration of Exchange Master to be executed by a general partner and duly authorized agent this day of August, 2018.
