

Criteria for inclusion on The Portuguese Podengo Club of Great Britain's

Judges List

(Issued January 2010)

Introduction

- A) Inclusion on any of the Club's judging lists is subject to the candidate completing the Club's Judges Application & Questionnaire and meeting the stated criteria. It is at the discretion of The Portuguese Podengo Club of Great Britain Judges Sub-Committee who reserve the right to refuse an application. Even if a judge fulfils the required criteria it does not guarantee automatic inclusion on any of the Club's judging lists.
- **B)** In applying for inclusion on any of the Club's judging lists the applicant agrees to the condition that they will write a critique on all judging appointments and will submit them to the canine press and send a copy of the critique to the Secretary of the Club within a month of the date of the Judging appointment.
- **C)** It is the expectation of the Club that judging appointments will cover a wide geographical area.
- **D)** The judging lists are only valid from the 1st January to the 31st December each year. The Club will then update all lists but reserve the right to amend these lists at any time at their discretion.

Note:

This updated Judges Criteria was unanimously agreed by The Portuguese Podengo Club of Great Britain Judges Sub-Committee on 2nd January 2010 and has subsequently been approved for use by The Kennel Club.

A3 List Breed Specialists requirements

- 1) Judges who have the support of The Portuguese Podengo Club of Great Britain.
- *2) Judges who have owned, exhibited or have had at least 7 years /experience in the Breed.
- *3) To have judged a minimum of 50 dogs in this Breed over a wide geographical area.
- *4) To have attended 1 Breed Specific Seminars run by The Portuguese Podengo Club of Great Britain and passed the Breed Specific 'Hands–On' assessment.
- *5) To have attended a seminar given by a Kennel Club Accredited Instructor on Kennel Club Rules, Regulations and Judging Procedures.
- *6) To have attended a Seminar given by a Kennel Club Accredited Instructor on Conformation and Movement and passed the relevant 'Hands-on' Assessment.
- 7) All the above criteria to be fulfilled except in exceptional circumstances.

A3 List Non- Specialists requirements

- 1) Judges who have the support of The Portuguese Podengo Club of Great Britain.
- *2) To have had a minimum of 7 years judging experience in any one breed to include 5 years in this Breed.
- *3) To have judged a minimum of 50 dogs in this Breed over a wide geographical area.
- *4) To have attended 1 Breed Specific Seminars run by The Portuguese Podengo Club of Great Britain and passed the Breed Specific 'Hands-on' Assessment.
- *5) To have attended a Seminar given by a Kennel Club Accredited Instructor and passed the relevant examination on Kennel Club Rules, Regulations and Judging Procedures.
- *6) To have attended a Seminar given by a Kennel Club Accredited Instructor on Conformation and Movement and passed the relevant 'Hands-on' Assessment.
- *7) To have awarded Challenge Certificates in at least one other breed, on at least 2 occasions.
- 8) To have bred and/or owned a minimum of 3 dogs of any breed when they obtained their first entry in The Kennel Club Stud Book.
- 9) All the above criteria to be fulfilled except in exceptional circumstances.

B List Breed Specialist requirements

- 1) To have the support of The Portuguese Podengo Club of Great Britain.
- 2) To have had at least 5 years active involvement in the Breed.
- 3) To have judged 40 dogs in this Breed in a minimum of 10 classes over a wide geographical area.
- 4) To have attended 1 Breed Specific Seminar run by The Portuguese Podengo Club of Great Britain and passed the Breed Specific 'Hands-on' Assessment.
- 5) To have stewarded at 12 different shows in the previous 3 years unless approved to award Challenge Certificates in another breed.
- 6) All the above criteria to be fulfilled except in exceptional circumstances.

B List Non- Specialist requirements

- 1) To have the support of The Portuguese Podengo Club of Great Britain.
- 2) To have had at least 5 years judging experience in any breed.
- 3) To have judged 40 dogs in this Breed in a minimum of 10 classes over a wide geographical area.
- 4) To have attended 1 Breed Specific Seminar run by The Portuguese Podengo Club of Great Britain and passed the Breed Specific 'Hands-On' Assessment.
- 5) To have awarded Challenge Certificates in at least one other breed, at least 12 months prior to Application to be considered to be included on this list.
- 6) To have stewarded at 12 different shows in the previous 3 years unless approved to award Challenge Certificates in another breed.
- 7) All the above criteria to be fulfilled except in exceptional circumstances

<u>C List Breed Specialist requirements</u>

- 1) To have the support of The Portuguese Podengo Club of Great Britain.
- 2) For aspirant judges who have shown an interest in the Breed.
- 3) To have owned or been actively involved in the Breed for at least 3 years.
- 4) It is desirable to have attended a Breed Specific Seminar run by The Portuguese Podengo Club of Great Britain.

C List Non-Breed Specialist requirement

- 1) To have the support of The Portuguese Podengo Club of Great Britain.
- 2) For aspirant judges who have shown an interest in the Breed.
- 3) To have owned or been actively involved in at least one other breed of dog for at least 3 years.
- 4) It is desirable to have attended a Breed Specific Seminar run by The Portuguese Podengo Club of Great Britain.

Hound Group Judges

The following persons have the support of The Portuguese Podengo Club of Great Britain:

In accordance with the Kennel Club Recommendation Championship Show Hound Group Judges can be considered for inclusion on the Club's B List.

Overseas-Portugal

- 1) To Have the Support of The Portuguese Podengo Club of Great Britain.
- 2) Judges from Portugal who are qualified and approved to Judge Portuguese Podengos by the Portuguese Kennel Club to award C.A.C.'s in the breed.
- 3) To abide by the Rules and Regulations of the U.K. Kennel Club.

Overseas-Other F.C.I Countries

- 1) To Have the Support of The Portuguese Podengo Club of Great Britain.
- 2) Judges from other F.C.I. Countries who are qualified and approved by the F.C.I. to Judge Portuguese Podengos and award C.A.C.'s and C.A.C.I.B.'s. in the breed.
- 3) To abide by the Rules and Regulations of the U.K. Kennel Club.
