<u>Roads-</u> Paving will commence on May 21·2021. The roads to be paved are Canvasback, Rail and Marsh Hawk. The paving should take about 4 days to finish. The Board would like MHCM to send out a communication to homeowners reminding them of the paving. The paving will have a \$5,000.00 increase.

<u>Elections-</u> Candidate statements and the ballot will be sent to the community by e-mail from MHCM on June 19, 2021. Candidates and statements will also be read at the July 17, 2021 BOD meeting. Voting will also commence that day, July 17, 2021. There will be 3 Board positions open.

<u>Speed Sign Update-</u> The Board discussed when the association will receive the signs and who will be doing the installation. The radar signs are stuck in transit as of Friday, May 14, 2021 due to shortage of workers. Installation will be done by Jeff Sprague as soon as they locate where they will be installed.

<u>Wood Duck Water Issue-</u> Lisa Splitter will be working up an analysis (Hydrology report) for us for the water issues and solutions. Gary Baton will call and get an update on when it will be fixed.
