

**BE IT FURTHER RESOLVED**, that the above-named officer be hereby authorized and empowered for and on behalf of the Association to sign any leases, acts of sale, partitions, contracts, and any other documents necessary to carry out the authority granted in this resolution. Further, the Association hereby ratifies any and all prior leases, acts of sale, partitions, contracts, and other acts executed by the above-named officer on behalf of the Association.
