UNFINISHED BUSINESS

Topic: Discover Llamas Magazine

Information to board, the cost for the publication exceeded \$7000. SSLA did not break even on the literature, possibly due to shipping costs. A closer inspection of the details for the publication will be looked into to discover how to proceed with the magazine. Magazine is published once every 2 years.

Drop off points for the Discover Llama magazine are with Tom Wilson, Laurie Jones, and Mary Rose Collins. Contact these folks for your publications.

Topic: Llama Journal

After discussion concerning journal costs: online versus hard copy, printing/shipping cost and securing ads from advertisers, it was decided by Board to table this discussion until figures can be determined for hard copy costs of magazine. Online publication is due out in July and will be coordinated by Charlene Braun. Articles should be submitted to her prior to July.

Topic: Procedure Manual

Has been revised and Mary Rose has someone that is reviewing copy for accuracy and formalities. She is in hope that it will be typed up and finalized next month.

Topic: Obstacle Trailer Advertising

Kathy Devaul is the keeper of the "Map of Trailer" – defined: it is the spots/sizes on the trailer for advertising (Left, Right and Front sides) and costs of those spots.

A. What is needed? A form to send out to members (electronic or mail out) with pertinent information from advertiser; example: Name, address, type of artwork, deadlines for advertising, etc.

- B. Steps for processing the information:
 - 1. Kim Kyst will create a form for the advertiser.
 - 2. Kim and Kathy will send the created form to board for approval.
 - 3. After approval from Board, the form is sent to Charlene (prior to July 10) for publishing in the Llama Journal.

4. Member fills in pertinent information on trailer form (picking spot) and sends check and form to Kathy Devaul.

- 5. Kathy then sends member artwork information to a company to allow them to work up ad and pricing for the artwork. (That will be billed directly to member.)
- Trailer is then taken to have artwork advertising installed.

NEW BUSINESS

Topic: Committees, Liaisons and Chairs

The by-laws states: "the President shall fill by appointment with concurrence of the Board, the following positions plus any other Committee Chairpersons that are deemed necessary: Llama Journal Editor, Membership Chairperson, LLSA Conference Chairperson, and Librarian. Hello everyone! The first annual Winter Classic Llama and Alpaca Show was a success.

It was held at Chicopee Woods Agricultural Center in Gainesville, GA. The show was the second weekend in December and our judges were Tor Sorenson and Robin Sturgeon. It was a double ALSA show for Performance, Halter, and Youth. We also offered Alpaca

Performance. Many special awards were given out, such as our Premier Exhibitor Award (a llama pendant from Images of the Heart and Soul, won by Dorthe Peolquin of Peloquin's Perch); two llama sun catchers for Overall Performance Champion (one was awarded to Dorthe Peloquin and the other to Mary Rose Collins);

gift baskets for our High Point Youth award (one was awarded to Elizabeth Ingram and the other to Bailey Jones): and we had 4 Best of Show awards. Each judge got to give out a male and a female Best of Show. These were awarded to ALCL Live Action, MCC Amahl's Baymax, Overman's Black Sapphire, and MCC Amahl's Gyspy Heat Wave.

We had exhibitors for MANY states including, Georgia, Florida, Ohio, Illinois, and North Carolina. Our schedule is a little different from most shows. We run Showmanship and Halter on Saturday starting with

females. We run all the females (suri, light, medium, heavy) and then all the males. That seemed to work out great last year and we will be doing so again this year.

We have lots of new and exciting things happening this year for the Winter Classic. We are an SSLA-sponsored show and we will be giving out points for SSLA sweep-

stakes as well as SSLA trophies and plates. LFA will also be sponsoring us this year so we will be adding a futurity show that will pay premiums for First Place, Second Place, Third Place, Grand and Reserve Champion. Versatility Champion will also be an award that will be added this year.

Once again, it will be held the second weekend in December (9th and

10th) at Chicopee Woods Agricultural Center in Gainesville, GA. We will also be a dual ALSA show again this year with Cynthia Ernst and Mary Jo Miller as our judges.

Our ALSA show will be adding Alpaca Halter classes this year. We will also have new awards. We will have ribbons to Third Place in all our classes, banners will be given for our Halter Show, and sashes will be given for Performance and LFA as well as for our new class this year, Overall Showmanship.





Jackson County 4-H Love of Llamas Year in Review

The 4-H motto, "To make the best better", focuses on the idea of youth reaching their highest potential through the engagement of challenging activities and giving back to their community. The Jackson County 4-H Love of Llamas club takes this motto to heart. Through weekly meetings the youth collaborate and implement many activities that help them develop their independence and leadership skills and increase their awareness of the positive impact they can have on their community through service.

This year we had three new club members who hit the barn running, so to say. Lilly Howell, Isabelle and Ava Olliff all became actively engaged in both the educational studies and hands-on work necessary to understand and work with large exotic animals. Each girl had obstacles to overcome and learned the value of hard work, patience, and fortitude. Learning to groom, feed, and care for llamas may be fun, but it is also a lot of work and takes a deep level of commitment. With the help of senior members Cody Avery, Andie Ellett, and Elizabeth Ingram the younger members became much more sure of themselves and participated in many community events. Here is a review of some of their accomplishments.

An open house in June welcomed youth ages 9 – 18 to visit the farm and learn about llamas and the 4-H program. August was the beginning of show season and several youth participated. Shows included the NC Mountain State Fair Llama Show in Fletcher, NC; GA National Fair in Perry, GA; Winter Classic at Chicopee Woods in Gainesville, GA; and the Hillbilly Llama Show in Perry, GA.

Community activities included Holiday Parades; visiting home bound patients, the annual Jefferson Easter Egg Hunt where llamas become long eared "ramas"! Participation at an elementary school where students could get



a photo with a llama in red pajama during Read Across America Day raised more than \$700 for Relay for Life. Larger all-day events included the Girl Scout Animal Day which the youth developed, organized, and implemented for a full-day badge earning event for over 75 Girl Scouts ages 5 – 18 was a huge success. The Blue Ridge Scenic Railway event was tied in with the fall train rides to Farmer Brown's Pumpkin Patch where the youth meet the public with llamas in costumes as engineers, train crew and in fall attire, and llama learning took place.

Another highlight was the 2017 SSLA Conference and Annual Membership Meeting at the Mountain Lodge in Flat Rock, NC where several youth were honored. Cody Avery received the SSLA Grand Champion Year End Award for Special Youth in both Showmanship and Performance; Kate Dutton received the SSLA Reserve Champion Year End Award for Junior Youth in both Showmanship and Performance; Andie Ellett received the SSLA Grand Champion Year End Award for Intermediate Youth in Showmanship and the SSLA Reserve Champion for Intermediate Youth in Performance: Lilly Howell received the SSLA Third Place Year End Award in Showmanship and the SSLA Participation as Youth Ambassador; and Elizabeth Ingram received the SSLA Third Placement Senior Youth in Performance and the SSLA Fourth Placement Senior Youth in Showmanship.
