Clean & Sober Housing Application

This packet will explain the resources available to you through Mack House of Western Washington. Please Read Completely & Carefully all Rules and Regulations. Our housing can be transitional or permanent, depending on your needs. You are the one to decide if and when you are ready to move out into the community.

Program fees begin at \$500.00 a month & go up for a shared room. All move-in fees must be paid by or upon your move-in date. Beds are on a first come, first-serve basis. If you would like to reserve a bed, all of your move-in fees must be paid ahead of time before you can submit one of our addresses. And we will hold a bed for you. The total move-in fees for a shared room are \$925.00. If DOC turns down the address, you can submit one of our other addresses, and if that one should be turned down, you will get your fees returned to you. But, if you decide that you do not want to come to the Mack House and would rather go somewhere else, your fees will not be refunded because we held the bed for you.

We accept all persons as well as registered sex offenders (all levels) and paroling sex offenders who will be on supervision, as long as the Marysville DOC accepts them. **All program fees must be paid before your move-in date. If you qualify for a DOC Voucher to pay your program fee, DOC must approve it before releasing. Voucher approval covers all costs for 90 days.**

All of our homes are Christian, with mandatory weekly church service & bible study. Private counseling is available upon request.

The availability of beds changes from time to time, so keep in touch with us.

Shared Room	\$500-\$550 month
Private Room	\$500-\$775 month

Included in the fee are Utilities, Cable TV in the dayroom, House Phone, Bed & Dresser, plus full use of the home's kitchen, bath, laundry, etc.

EXAMPLE:

Clean & Sober Housing Move-In Fees for a Shared Room

1st month program fee \$500.00 + ½ month's fee \$250.00 + \$175.00 non-refundable maintenance fee
Total Move-In Fees for a Shared Room = \$925.00 Must be paid in full before moving in!

**Please notify management 30 days prior to vacating so your two-week deposit will be used
"Use it or Lose it."**

***** Mack House requires all applicants to pay their move-in fees fully before accepting any of our addresses for your release. If your release date is more than 6 mos. out, submit the address but do not send any money at this time. Wait till it's 60 day's out. *****

Read these rules carefully. In order to keep peace and have an organized house these rules must be followed. Any failure to follow the rules will result in fines or eviction, depending on the violation.

****RULES ARE SUBJECT TO CHANGE**** depending on conditions at the house to provide for a peaceful ongoing clean & sober environment.

MAJOR RULES: NO Drugs, Alcohol, Weapons, Fighting, Stealing, Disruptive Behavior!
--

A. PAYMENT OF program fees

1. All Program fees & fines are payable to Mack House of Western WA.
It is the responsibility of the member to make sure Pastor Mack receives payments.
2. Program fees are due on the 1st of each month. Members will be charged a late charge of \$5.00 a day for any fees made between the 2nd & the 14th of the month.
3. Unless arrangements have been made with the Pastor for an extension, if your program fee has not been paid in full by 6pm on the 14th of the month, you must vacate the premises. See "Expulsion" at end of agreement.

B. ROOMS

1. You will occupy your own room.
2. Do not enter another member's room without their permission.
3. All rooms become available by seniority.
4. **NO PORNOGRAPHY ALLOWED.** Not in your room or in the house.
5. Your room is to be kept reasonably clean.
6. You may not paint your room without permission from Pastor Mack
7. No pets of any type are allowed.
8. Rooms will be inspected without notification.
9. Because of fire hazard/system overload concerns, the Pastor or agent must pre-approve any electrical sound systems or other appliances before they are used in a member's room.
10. No open flames; candles, incense, etc.

D. CHORES:

1. You will be assigned a daily or weekly cleaning chore.
2. Failure to do your chore or to sign off your chore on the chore list will result in fines and/or other penalties.

E. LAUNDRY:

1. Laundry hours are: 8 am to 10 pm Monday thru Sunday

F. QUIET HOURS:

1. Quiet hours are in effect 10 pm to 8 am daily.
2. Stereos, TV's & loud talking must not be so loud as to disturb others.
3. After 10pm headphones will be used on any audio device except in T.V. room

G. TV/LIVING ROOM/GAME ROOM USE:

1. There are no time restrictions on TV time use.
2. The TV will be in the dayroom and is on a first come, first serve basis.

H. RELATIONSHIPS:

1. **Sexual relations are prohibited while living in the Christian Based Mack House. The only exception is for a LEGALLY MARRIED MAN AND WOMEN.**

I. DISPUTE RESOLUTION:

1. Pastor John/Pastor Jane will settle all disputes if it cannot be worked out amongst the members of the household or management.

J. FOOD:

1. A storage shelf, shared refrigerator and shared freezers are provided.
2. A pantry is provided by the house with free food.
3. Eating someone else's food without permission constitutes stealing.

K. KITCHEN USE:

1. Kitchen and stove use are on a first come, first serve basis.
2. You are expected to clean up & wash your dishes after you're done.
3. All needed utensils & dishes are supplied by the house.

L. TELEPHONE:

1. Long distance call service is not available.
2. The house phone is not allowed in your room.
3. You are not required to answer the phone when it rings, but if you do, you are required to look for the person the call is for or take a written message for them.
4. **Limit your conversation to 15 minutes.**

M. CHURCH SERVICES & HOUSE MEETING

(Mandatory to all program participants and residents) Initials: _____

1. **Mandatory Church Services: Sunday 10am – Wednesday 7pm. You must attend.**
2. **If for any reason, you need to miss a program meeting, you must notify Don Blystone at least 1 hour before the program meeting begins and get their permission or you will be fined – no excuses.**
3. **You must stand at all praise and worship services**
4. **You must be on time for the meetings. Extra chores will be assigned accordingly.**

N. CLEANLINESS:

1. Your mother does not live here, so you must clean up any mess you make.
2. Do not make a mess & expect the person with chore to clean up after you. You will be penalized!!!
3. This also goes for personal hygiene, toilets & showers.

O. HOUSE SUPPLIES:

1. The house supplies the following items:
Comet, Light bulbs, Dish soap, Sponges, Trash bags.

P. VISITORS:

1. **No female visitors allowed except to attend church services and/or bible study.** They come for services and must leave immediately thereafter. Visitors are subject to each & every house rule and visitors are your responsibility. **Whatever they do, you did. If they use, you used and you're out!!!**
2. No overnight visitors allowed unless approved by Senior Staff Pastor Mack.
3. **No minors allowed.**
4. You may not leave your visitors in the house while you leave.
5. **Do not allow the visitor to roam the house or go directly to the person's room.**
6. **No sleep overs without permission**

Q. AUTOMOBILES:

1. **1 Auto per member is allowed.**
2. Auto must be registered, licensed & insured to member or vehicle will not be able to park on any Mack House property.
3. If your car is not running, it needs to be fixed within 1 week or removed from property or it will be towed at your expense.

R. SMOKING

1. Smoking of cigarettes or e-cigarettes and chewing tobacco and the use of spit bottles is Not allowed inside the house.
2. You must go outside to smoke, use e-cigarettes and chew tobacco, and the cigarette butts are to be disposed of immediately. Not stacked up outside in a container.

S. EXPULSION: **Read This!!**

1. If you are kicked out of the house, you have exactly 15 minutes to get some of your things and get out! Your room key must be surrendered immediately. You must call and set up a time to come collect the rest of your things; you have three (3) days to complete this.
2. The program fees you have paid & all deposits are forfeited. **Initial:** _____
3. The House Manager/Chore Coordinator will clean the room & will remove all food & other items from the refrigerator.
4. If fees is owed to the house, I agree that any and all of my possessions at the Mack House can be held as collateral, and if not retrieved within 30 days they can be disposed of in any manner Mack House sees fit.

T. CHRISTIAN HOME

1. **You are living in our "Christian" Clean & Sober Homes. Behavior is expected to conform to Christian attitudes and principles.**
2. **Only Christian Literature is allowed in the House. You will not be allowed to bring literature or artifacts from non-Christian organizations such as: Jehovah Witnesses, Mormon, Native American, Muslim, Wicca, etc.**
3. **If you show a bad attitude in the home or during our program services or complain about having to attend church services, you will be required to move out of our home.**

The nature of the Mack House is immediate expulsion without notice of a resident member who is found, by the Pastors Mack and/or the majority of the house members, to be using either alcohol or drugs. Disruptive behavior or nonpayment of program fees can also lead to expulsion from the Mack House. **THE WHOLE HOUSE, AS WELL AS PRIVATE BEDROOMS ARE SUBJECT TO SEARCH AT ANY TIME (INCLUDING ANY VEHICLES LOCATED ON PREMESIS). FAILURE TO ALLOW SEARCHES FOR COMPLIANCE WITH HOUSE RULES WILL RESULT IN IMMEDIATE EXPULSION FROM PREMESIS.** Expulsion will also be mandatory for refusal to do any required drug/alcohol testing.

Living in the Mack House is by membership only. The Mack House does not fall under the landlord/tenant act. This means that a resident can be voted out of the house for violations of the house rules, including but not limited to; not doing required chores, non-payment of program fees, leaving windows or doors unlock, etc. The time given to move out will be determined by the current members of the house or the owners.

Violations such as using drugs or alcohol, disruptive behavior, or possessing a weapon will result in the resident member being given 15 minutes to gather their immediate belongings and vacate the house and premises.

I have read the items in this agreement and understand that if I am accepted into the Mack House, I agree to the terms listed and I waive any landlord/tenant rights that I may be entitled to. I also understand that I fully and freely subject myself to the rules of the Mack House of Western Washington. I also understand that these rules are subject to change without notification. I also agree to accept Pastors John & Jane Mack as my Pastors and **AGREE TO MAKE AN EFFORT TO LIVE A CHRISTIAN BASED LIFESTYLE WHILE RESIDING IN THE MACK HOUSE.**
