In consideration of the terms and conditions contained in this Contract, the parties agree as follows:

- Carrier shall provide transportation services for such commodities as may be tendered to
  it by provision of the Carrier's operating authority. During the term of this Contract, the
  Carrier agrees to comply with the rules and regulations pertaining to Motor Carriers, as
  published in the code of Federal Regulations at 49 CFR, Chapter III.
- 2. In consideration of the terms of this Contract, FIVE STAR TRANS INC. agrees to tender the Carrier a minimum of two shipments if Carrier agrees during this period of Contract. Further, the Carrier agrees to assign vehicles for the exclusive use of FIVE STAR TRANS INC., during that period., but the parties agree that said vehicle shall not be dedicated solely to meeting the transportation needs of the FIVE STAR TRANS INC. and may be used by Carrier to meet the other customer's needs. During the term of this Contract, the Carrier agrees to not double broker or subcontract any shipment tendered to the Carrier by FIVE STAR TRANS INC.
- As in accordance with DOT regulations, Owner/Operators are personally responsible or accountable to such actions leading to any obligation or act and acknowledge that FIVE STAR TRANS INC. is an independent company that has no authority or responsibility to the Carrier.
- 4. During the term of this Contract, the Carrier agrees to carry and keep in force, at its own expense, \$100,000.00 of cargo liability insurance coverage, and \$1,000,000.00 in automobile liability insurance applicable to the transportation service provided to FIVE STAR TRANS INC. Further, the Carrier agrees to provide evidence of such coverage, and amend or change thereto, for the duration of this Contract.
- 5. Carrier shall be liable for full actual loss resulting from loss, damage, injury, or delay on shipment transportation under the term of this Contract; full actual loss is the

- replacement of cost of goods and cost of freight tendered to the Carrier for transport. All claims for loss and damage shall be handled and processed in accordance with regulation published in the Code of Federal Regulation at 49 CFR Part 370. The term, conditions, or provision of the governing bill of lading or any other shipping form, tariff or rule utilized shall be subject and subordinate to the terms of this Contract and, in the event of a conflict, this Contract shall govern. This Contract cannot be changed, modified, limited or supplemented by reference to any Carrier rate, rule, classification, practice, schedule, or tariff.
- 6. Carrier agrees to indemnify and save harmless FIVE STAR TRANS INC. from any and all nature whatsoever rising out of the Carrier's operation and activities hereunder without limitation, claims, losses, or liability for personal injury, property damage, cargo loss or damage, auto liability, or any combination thereof resulting from the negligence of legal Carrier, its employees or agent which may occur during the performance of service under this Contract, including court costs and attorney's fees incurred in defending or prosecuting such claims. Carrier shall provide an Endorsement from their insurance company and list FIVE STAR TRANS INC. as additional insured for Liability insurance and Cargo insurance.
- 7. The Carrier shall promptly issue freight bills to FIVE STAR TRANS INC. for shipment transport under this Contract and FIVE STAR TRANS INC. agrees to pay such freight bills within 28 to 30 days of receipt thereof. Subject to the terms and conditions, this Contract remains in force and in effect for an initial period of one year and is preset to renew annually. Either party may cancel this Contract upon 30 days written notice to the other, given at any time during the life of the Contract.
- 8. The terms and provisions of this Contract shall be interpreted under the Laws of the State of California. Further, this Contract and appendices attached shall not be modified, except in writing and signed by both parties thereto. Finally, this Contract shall cancel and supersede all other Contracts previously entered by the parties. This contract will stay in agreement for one year minimum and will automatically renew for the following year. At any time if either party decides to cancel the agreement, they will have to notify the other party with a 30-day notice.
