STR UPDATE

The topic of Short-Term Rentals has been a moving target for everyone in the past few months. *The Hague Chronicle* is doing its best to keep residents informed of the state, county, and local laws and procedures the owners who rent their properties need to know.

Here is the latest information:

New York State (NYS) Sales Tax on STRs is 7% and goes directly to the state. NYS will remit 3% back to Warren County and keep 4% for NYS.

Several platforms, including VRBO, will be charging guests an 11% tax. Seven percent will go to NYS and 4% will go to Warren County for its Occupancy (Bed) Tax.

Airbnb will no longer collect a County Occupancy Tax unless said county has a Voluntary Contract/Agreement (VCA) in place. Warren County does not have such a contract in place.

At the time when an owner who rents out an STR property has the inspection done by a Warren County inspector, a \$75 fee must be paid to that inspector. So, have your checks ready!

Dear Town of Hague Residents,

Over the past few months, the Hague Volunteer Fire Department (HVFD) has been meeting with officials on the town board to figure out ways to address the rising costs of emergency medical services. These rising costs are due to new laws and procedures that are now required by New York State (NYS), our dramatically increasing call volumes (which are due to the numbers of residents, vacationers, and tourists), decreasing volunteer ranks, and personnel shortages.

We are working hard to ensure that we continue to provide the highest quality Emergency Medical Services (EMS), while easing the future tax burden on town residents.

NYS began allowing fire departments to bill for EMS with the Recovery Cost Reduction Law of 2023.

The HVFD presented an informative and successful meeting on April 7, 2025, featuring Peter Barry, who owns EMR Billing Services, as the speaker. He summarized his EMR billing process and answered questions. Information will be available at the Hague and Silver Bay post offices.

Details are:

- 1. Taxpayers are responsible for ALL of EMS's availability, readiness, and usage costs.
- 2. Going forward, all users of the service will share in the cost of EMS, thereby reducing the taxpayer burden.
- 3. Most of the billing revenue will come from private and public insurance companies. The previous practice of not billing users lets insurance companies "off the hook," unfairly burdening the town and the HVFD with the full cost of expenses.

The HVFD has always been committed to giving all patients the highest level of care and will continue to provide care regardless of the ability to pay. We thank everyone for their continued support.

SCHOOL ADVISORY COMMITTEE (SAC) UPDATE

In meetings on April 8 and 25, 2025, the Ticonderoga Central School District (TCSD) Board of Education (BoE) discussed and approved the budget for the 2025-2026 school year. Details will be available when printed copies of the full document are made available. In the April 15th meeting, the increase in the school tax levy was announced as 1.06%.

The budget schedule is:

- May 6th proposed budget must be released
- May 13th public hearing on budget
- May 14th budget notice mailed to voters
- May 20th budget vote

As of *The Hague Chronicle's* deadline date of April 20th, no response to Josh Patchett's several invitations to the BoE to make a budget presentation in Hague had been received.

Voting on three open BoE positions will occur on May 20th. At press time, we did not know who the candidates would be; the approved list is supposed to be issued by April 22nd. SAC is attempting to get some indication as to the potential candidates' positions regarding Hague-related issues.

The next TCSD BoE meeting is scheduled for **Tuesday**, **May 20th at 6 pm**. Results of the voting will be announced. Strong in-person Hague attendance at all BoE meetings is urged, as the meetings are not streamed.

Dr. Roger Catania has been invited, and will be attending, the May 1st Hague SAC meeting. Dr. Catania is the New York State (NYS) Education Department Board of Regents Regent for the 4th Judicial District, which includes both Warren and Essex Counties. He served for eight years as superintendent for the Lake Placid Central School District before his retirement in 2021 and his appointment to the Board of Regents in June of 2022. Dr. Catania has been fully informed about SAC's concerns regarding TCSD's academic performance and the BoE's handling of PILOT agreements. His expert opinion is being sought by SAC.

Reminder: All Hague parents with children in TCSD are strongly urged to promptly return the Parent Survey they received from the SAC! Only five of the 28 surveys have been returned.

Let's all get engaged and advocate for our school and our community!

AARP TAXAIDE

Hague AARP TaxAide has finished another successful season preparing federal and state tax returns for over 300 individuals and families who are concentrated in the Hague, Ticonderoga, Crown Point, and Schroon Lake areas, but also come from as far away as Glens Falls/Queensbury and Lake Placid/Saranac Lake.

This group has an excellent record for preparing accurate returns. It has discovered that more taxpayers than in past years did not receive their social security statements or had challenges in getting new ones.

Given recent news reports of layoffs at both the Social Security offices and the IRS and the possible need for proof of identity, TaxAide urges taxpayers to be careful to retain important documents.

There is still a Social Security office on Warren Street in Glens Falls (1-877-405-4875) that may be easier to contact than the national number.

If taxpayers have difficulty, they may contact their congressional representatives' constituent services representatives.

The team and taxpayers are thankful to the town of Hague for use of the large room in the community center.

Bob and Jan Whitaker, who have served on and led the team over the past 20 years, plan to step back and need to be replaced to provide the same capability to serve the community.

Silver Bay's Hepbron Hall has been named to the Preservation League of New York State's 2025–2026 Seven to Save list, which highlights significant historic sites at risk. Built around 1900, Hepbron Hall — originally Forest Lodge — once housed workers and later served as affordable guest lodging. It reflects early Adirondack rustic architecture and is part of a rare grouping of 32 historic buildings on the Silver Bay campus. Currently condemned due to failing foundation supports, the building faced possible demolition. Silver Bay hopes to stabilize and repurpose it as affordable family lodging.

UV FILTER REMINDER

A friendly reminder for anyone who drinks UV sterilized water from Lake George: regular water sterilization maintenance is crucial!

Homeowners must replace the UV bulb in their UV sterilization systems annually and clean or replace the quartz sleeve every other year.

It has been discovered that the latter is not being done consistently for homes inspected on Lake George. If you have concerns, please reach out to your local plumber or drinking water technician.

LOOKING BACK

EXCERPTS FROM THE HAGUE CHRONICLE MAY 1975 (50 YEARS AGO)

FLOOD INSURANCE

The adoption of a resolution on flood insurance by the Town Board at its meeting on April 15 will qualify residents of potential flood plain areas for subsidized Federal Flood insurance.

While Hague Brook has from time to time overflowed its banks during the early spring, the only really serious flooding occurred on June 3, 1947. A newspaper account of the day began: "Hague Brook, normally a peaceful trout stream running through this resort community, went berserk during the torrential rainstorm Monday night and early Tuesday morning, overflowing its banks and causing damage of many thousands of dollars. Two garages were wrecked, an automobile demolished, tourist cabins flooded and the macadam highway leading over Graphite Mountain ripped and torn. One of the hardest hit by the torrents of water, rushing a foot deep down the highway and over the main bridge on Route 9N, was Cobbs Cabins. The main building at the establishment was also damaged, its foundation partially washed away, and two gasoline pumps ripped out by the force of the raging stream."

One old-time resident said he had lived in Hague for fifty years and never before (and, we might add, never since) has the stream overflowed its banks except very mildly.

This entire account can be read in the June 12, 1947, Ticonderoga Sentinel newspaper.

ONE YEAR LATER

Excerpts from the *Ticonderoga Sentinel*, July 14, 1976: (The entire account is available online.)

An "Act of God" wrought havoc on the lakeside village of Hague Sunday night as rains caused extensive flooding of the Hague Brook.

Town and state highways crews worked throughout Monday morning to clear the collected debris and washed-out portions of Route 8, blocking traffic most of the way up the hill from the Route 9N intersection.

The rains came down from about 5 p.m. until 11 p.m. Frank Rivers of Forest Bay near Hague measured the rainfall in his rain gauge to be four and 9/10 inches overnight.

Houses were flooded, trailers moved, cars wrecked, and garages moved.

One garage opposite the Hague Supermarket was moved from its foundation down to the bridge over the Hague Brook over the intersection of Route 9N where water spewed out into the road. The macadam there buckled and the By Water Motel and Coffee Shop received excess water and dirt.

The Hague Supermarket also received extensive damage, estimated at \$10,000 by owner Robert Hoyt.

The parsonage of the Hague Wesleyan Church was also extensively damaged.

The Green Acres Campsite near Graphite also received extensive flooding. There, one trailer was moved from its foundation, another completely flooded, and several cars (were) completely inundated with mud and debris.

Water in the brook was estimated 15 feet above normal levels. The road up Graphite Hill was severely eroded in two positions as water rose over the tops of bridges and on to the macadam.

Fred Stone, assistant resident engineer for the New York State Department of Transportation said that repair work will continue over the next few days. He said the road will be closed from the base of the hill up to Green Acres Campsite until it can be repaired.

What more can be said? Never say "never," especially when dealing with Mother Nature!


