## FISHING TOURNAMENT DRAWS BIG CROWD

More than 18 inches of fresh snow fell in Hague just before the Hague Fish & Game Club's annual fishing tournament, but the storm did not stop anglers from heading out onto the ice.

A total of 119 adults and 60 youth registered for the event through local bait shops. The tournament once again drew strong community support, with local merchants sponsoring prizes and helping provide youth anglers with starter fishing equipment to begin building their own tackle collections.

Club members also donated items for the event. Mike Flack crafted a handmade ice chisel, emphasizing that it is an important safety tool every ice fisherman should carry. The Silver Bay General Store sold tickets and made a Gold Line donation, which helped provide prizes for the junior division winners.

The club was also pleased to welcome New York State Department of Environmental Conservation Officer Higgins, who stopped by during the tournament.

## SCHOOL ADVISORY COMMITTEE (SAC) UPDATE

The School Advisory Committee (SAC) continues to seek a better education for our children and a fair and equitable administration of school taxes. However, our several requests for an update by the Ticonderoga Central School District (TCSD) Board of Education (BoE) of their academic goals published in August 2025 have not been answered.

In the meantime, SAC has researched the latest 2024-2025 NYS Education Department statewide rankings based on NYSED's annually administered standard tests across schools for grades 3 through 12. The tests determine the students' level of proficiency compared to state requirements for more than twenty subjects. The test results are used to rank some 600 public school districts.

## HAGUE BROOK TRAIL UPGRADE

Thanks to a concerted effort by a bunch of conscientious and caring people, our Hague Brook Trail path has been restored to safe access and is open to welcome spring. This wonderful town asset is a part of the Lake George Wild Forest within the Adirondack Forest Preserve. Access is available from the parking lot just off Graphite Mountain Road/Route 8 that's located just 200 yards west of the community center.

From the parking lot, a bridge across Hague Brook leads to the trail which winds up the steep mountainside along the raging brook and waterfall.

Last Fall, Sally DeLarm-Rypkema, our town historian, noted that the bridge and infrastructure had significantly deteriorated and was concerned enough about the safety aspects to take action. Sally began a long, arduous quest to determine who or what entity was actually responsible to maintain this property in safe condition.

The Hague Volunteer Fire Department was busy for the month of February with four fire calls, three EMS assists, and four drills for a total of 63 volunteer hours.

EMS had 12 calls and two standbys for a total of 53.5 paid and volunteer hours.

We are moving our Mother's Day brunch to **Saturday, May 9th** with the same hours, **9 to 11 am**.

From **March 16 through May 14**, there is a fire ban in effect, prohibiting outdoor brush burning to reduce wildfire risk during the high-risk spring season. Residential burning of trash, leaves, and brush is banned statewide during this period, with violations risking at least a \$500 first-offense fine.

## ZONING BOARD OF APPEALS - 2/26/2026

Present were Chairman Robert Goetsch, Deputy Chairman Chris Richards, Board Members Tina Barth-King, Chris Navitsky, and Oliver Gourley. Also present were Zoning Enforcement Officer Ed Kirchberger and Recording Secretary Kathy Santaniello.

There were no public hearings.

### **Silver Bay Association for Christian Conferences and Training, 87 Silver Bay Road**

*Development within 100 feet of shoreline; variance for 160-50 B (1) (b) development within 50 feet of shoreline setback*

The applicant proposes installing an ADA-accessible ramp to the waterfront over an existing steep gravel pathway, with a requested railing width of 48 inches where 36 inches is required. Chris Girard of Dock Doctors was present to answer questions.

Kirchberger reported that an updated SEQR form had been completed and distributed. Barth-King confirmed that the project lies within the shoreline setback and that zoning district details and mean high water mark measurements were accurate, requesting that those measurements be added to the application. Navitsky asked for clarification on the ramp and platform placement, which was provided.

A motion was made and seconded to accept the application as complete and place it on the March agenda. The vote passed unanimously.

Kirchberger reported that a public hearing will be held at the March Zoning Board of Appeals meeting, followed by referral to the planning board for site plan review and advisory opinion at its April 2nd meeting. Warren County approval has been received and an Adirondack Park Agency review is pending. Board members agreed that individual site visits would be sufficient.

### **OTHER BUSINESS**

Kirchberger reported that he has distributed a questionnaire to Hague Zoning Board of Appeals and Hague Planning Board members to gather input on zoning updates, as he works with Warren County Planning and the New York State Department of State to pursue a grant for a full update of the town code.

He also reviewed ongoing discussion of guest cottage regulations. The town board has requested an additional recommendation from the Hague Zoning Board of Appeals due to wording discrepancies. Kirchberger noted that the current definition of a guest cottage allows for interpretation and would benefit from clarification. He also confirmed that zoning administrators currently have authority to approve such structures.

Board members discussed issues to be addressed in a broader code revision, including lake density, undersized lots, lot coverage, septic requirements, and enforcement. It was noted that the Hague Comprehensive Plan must be updated before a full code revision can proceed.

Discussion also included square footage limits for guest cottages. The current code allows up to 2,000 square feet, though a 1,250 square foot limit had previously been recommended. Barth-King suggested reviewing questionnaire responses and planning board input before making an additional recommendation.

## PLANNING BOARD - 3/5/2026

Present were Chairperson Sandy Powell, Board Members Pam Peterson, Alane Vogel, Jami Jordan, and Tom LaPointe. Henry Friedman was in remote attendance via phone. Also present were Zoning Enforcement Officer (ZEO) Ed Kirchberger, Zoning Clerk Sarah Dever, Chris Richards, and Chris Girard of Dock Doctors.

Powell welcomed LaPointe to the board and acknowledged his accomplishments. She also thanked Peterson for her service as deputy chair and noted that Friedman will step into that role.

There were no public hearings.

### **NEW BUSINESS**

*Silver Bay Association for Christian Conferences and Training, 87 Silver Bay Road, (DEV 03-26) (SP 02-26) (VAR 01-26). Development within 100 feet of shoreline; variance for Section 160-50 B (1) (b), development within 50 feet shoreline setback.*

The applicant proposed installing an ADA-accessible ramp to the waterfront over an existing concrete slab and gravel pathway. The project was before the planning board for an advisory opinion to the Zoning Board of Appeals.

Board members reviewed the application and site conditions, including a large stump beneath the proposed ramp, shoreline vegetation, stormwater runoff, and ramp access. The applicant explained that the ramp would be installed using steel pipe footings with minimal excavation. It was noted that the stump would be ground down rather than removed.

The board discussed environmental impacts and accessibility benefits. Members agreed the project would improve access for those with mobility challenges while maintaining the character of the shoreline.

A motion was made and seconded to issue a negative SEQR declaration. The vote passed unanimously.

A motion was made and seconded to deem the application complete. The vote passed unanimously.

A motion was made and seconded to provide a positive advisory opinion to the Zoning Board of Appeals with conditions that native shoreline vegetation be maintained or replaced in kind, additional native plantings be added between the ramp and the tennis courts, and the stump be ground down rather than excavated. The vote passed unanimously.

### OLD BUSINESS

The board agreed to move the May meeting from May 7th to May 14th at 6 pm. Members were asked to submit forms for Adirondack Planning Forum training by March 9th.

### OTHER BUSINESS

The board continued discussion on proposed code changes, including guest cottages and short-term rentals. Powell will prepare a draft recommendation for review at the April meeting.

Members also discussed Section 150 of the town code and future training opportunities. Powell will coordinate a subdivision training session with New York State Department of State Local Government Specialist Monica Ryan.

## TOWN BOARD - 3/10/2026

Present were Supervisor Joshua Patchett, Councilmembers Jack Bast, Maureen Cherubini, Edna Frasier, and Lara Smith. There were no absences. There were ZOOM attendees.

A moment of silence was observed for Martin "Blackie" Fitzgerald, Theodore "Ted" Conant, Diane Howard, and Peter Doliber.

**PUBLIC HEARING:** Code Change Recommendations  
The public hearing on code change recommendations from Zoning Enforcement Officer (ZEO) Kirchberger remains open until the April meeting. No one spoke for or against the recommendations.

### COMMITTEE REPORTS:

**Buildings/Grounds (Frasier/Patchett):** Frasier reported she is researching options to make the community center entrance handicap accessible, including an automatic door opener. Patchett reviewed bids for repairs to the exterior wood surface at the visitors' center.

**Highway (Frasier/Cherubini):** The Highway Department's cold storage building has been completed. Bids are being received for garage improvements. Dunklee noted a possible storage area for the Animal Control Officer.

**Museum/Historian (Bast/Smith):** Work continues on the Hague Central School exhibit.

**Personnel (Bast/Cherubini):** The town continues to seek a Zoning Board of Appeals alternate. Tom Lapointe has been appointed to the planning board.

**Planning/Zoning/Stormwater (Cherubini/Frasier):** The zoning board of appeals report has been received and a wastewater application was discussed later in the meeting.

**Recreation/Promotion/Youth (Smith):** Winter weekend events at the Hague Fish & Game Club have been rescheduled to March 21st, with family activities from 1 to 4 pm, and music by Rich Ortiz from 5 to 8 pm.

**Sewer (Smith/Patchett):** The new computer system is operating without issues.

**Town Park/Beautification (Smith/Frasier):** Winter flags will be replaced with spring and summer flags.

**School Advisory Committee (SAC) (Bast):** The School Advisory Committee reported that the town has filed an application with the New York State Department of Taxation and Finance seeking a special equalization rate to address disparities in school tax apportionment within the Ticonderoga Central School District. The application is under review by the Office of Real Property Tax Services. SAC also encouraged community participation in upcoming board of education meetings and noted the need for another Hague representative on the board.

### COMMUNICATIONS AND PETITIONS:

The board approved the Hague Seniors' request to use the Visitors' Center for the Senior View Café from May 24 through May 31. The Seniors announced they will not hold the White Elephant Sale this year.

The board agreed to join a Lake George Association (LGA) letter to Governor Kathy Hochul requesting additional funding for septic replacement programs.

Amanda Vickerson presented plans for small boat tours operating from the town dock. Concerns regarding parking, dock space, and logistics were discussed, though overall support was expressed.

### NEW BUSINESS:

A public hearing was scheduled for April on a wastewater variance for Bolton Sibling LLC, 5 Burdick Lane.

The board adopted Resolution No. 75 of 2026 establishing a Length of Service Award Program (LOSAP) for Hague Volunteer Fire Department members, subject to voter approval at a referendum on November 3rd. The program would provide a monthly benefit based on years of service beginning in 2027. The vote passed 4-0-1 (Cherubini abstained).

The board approved use of the Steamer Dock by Northern Lake George Boat Tours LLC for limited seasonal operations, with conditions including insurance, a hold harmless agreement, and a \$150 fee.

Funding was approved for School Advisory Committee (SAC) members to attend the Rural Schools Association conference, for board and planning board members to attend the APA Planning Forum, and for the town clerk and deputy clerk to attend their annual conference.

The board approved a \$5,564 contract with MacDougal and Mazin Contracting for visitors' center repairs and authorized the purchase of pallet racking for the highway department.

## HAGUE BROOK TRAIL UPGRADE, CONT'D

With the help of Hague Deputy Highway Superintendent Tim Fiallo and his excellent working relationship with DEC, contact was made and help found that responded to our requests for attention.

Kate Kuklinski, Land Manager, and Ben Thomas, Regional Forester, from NYS DEC's Division of Lands & Forests located in Warrensburg, came to our rescue. They brought in needed repair materials and personnel to the site, including help from a group of Boy Scouts. Our Hague Highway Department also donated a substantial number of materials to provide additional safety margins. With everybody's help and cooperation, adequate repair was accomplished before winter set in.

The Hague Brook is currently raging with snow melt runoff and is a glorious sight from this bridge and the trail! Thanks, Sally, Tim, Kate, and Ben!

Visitors still need to be reminded to BE CAREFUL! This is Wild Forest, not Hague-owned property. Visitors are on their own when they enter the preserve! ▣



## TOWN BOARD, CONT'D

Resolution No. 77 of 2026 was adopted authorizing a \$207,798 contract with Hybrid Building Solutions for a new salt storage building.

Additional discussion included septic grant funding delays, alternative phone service options, dock usage, parking concerns, and a call for volunteers for the Memorial Day Parade Committee.

The next regular meeting will be held April 14, 2026.

## NYS TEST SCORE RANKINGS OF TCSD STUDENTS

On New York State standardized tests, Ticonderoga students scored four in the top half, 18 in the bottom half, overall compared to regional schools in the bottom quartile.

## SCHOOL ADVISORY COMMITTEE (SAC) UPDATE, CONT'D

When TCSD is compared to twenty neighboring TCSD schools in the North Country, we find that it is ranked in the upper half for only four out of twenty-two subjects. TCSD is ranked below the median of this cohort of schools that face the same challenges as TCSD does. Overall, in our region, TCSD is ranked in the bottom quartile. A link to this analysis is available on the Town of Hague's website and can be viewed [HERE](#). The children of Hague, Putnam, and Ticonderoga deserve a better education. The TCSD BoE must commit to improving the quality of education it offers. The SAC welcomes thoughts and suggestions from Hague residents regarding how to improve TCSD academic performance.

Regarding school taxes: On February 27th, Hague filed a formal application with the New York State Department of Taxation and Finance seeking a special equalization rate for the TCSD to ensure Hague taxpayers are not unfairly burdened with a disproportionate share of school taxes.

This state-authorized process under Real Property Tax Law is intended to correct significant differences in assessment levels within a district. Hague's application is necessary because the current system does not accurately reflect some Ticonderoga true market values, resulting in substantially higher per-pupil costs for Hague residents compared to neighboring areas.

If approved, the special equalization rate would create a fairer allocation of the school tax levy and could provide meaningful, hopefully, annual savings for Hague homeowners, families, and seniors. The application is currently under review by the New York State Office of Real Property Tax Services (ORPTS).

Finally, the April School BoE meeting is on **Tuesday, April 21st** at the High School Cafeteria **at 6 pm**. SAC encourages Hague residents to attend! The SAC will be there too!

Also, Hague needs another representative on the School Board of Education! Petitions to be included on the September BoE ballot can be picked up at the TCSD District Office at the high school and must be submitted to Erin Hamel, BoE Clerk, **before April 20th. Who do we have in Hague who is willing to serve in this important role? Hague needs a candidate we can strongly support!** ▣

## PETER DOLIBER PASSES AWAY

It was with great sadness that Silver Bay YMCA announced the passing of Peter R. Doliber (1955 – 2026) on March 9, 2026 after his courageous battle with cancer.

Doliber first joined Silver Bay YMCA in 2022 and guided the organization with unwavering commitment, empathy, and purpose.

Under his leadership, Silver Bay's reach grew, its impact deepened, and Silver Bay remained steadfast in its mission to cultivate relationships, strengthen communities and nurture spirit, mind, and body for all.

It was under Doliber's leadership that Silver Bay was able to become more fiscally sustainable, while being able to provide over \$1.4 million (2024) in direct community benefits through programs and services. It was this work that was awarded the 2025 "Large Nonprofit of the Year" award by the Adirondack Regional Chamber of Commerce. It wouldn't have been possible without the leadership and support of Doliber.

During his tenure, Doliber helped guide and develop many projects and programs at Silver Bay. One of the

programs most near and dear to him was the creation of the Ticonderoga Community Early Learning Center (TCELC). The TCELC provides much-needed childcare to the region, and, while Doliber took great pride in helping to get the TCELC started, what he loved most was being able to see the children in the center learn, flourish, and grow.

"Peter was not only a mentor to many of us here at Silver Bay, but he was also a friend. Through Peter's guidance, many of us here were able to grow professionally and personally while having a genuine impact on the community. The work we do and will continue to do at Silver Bay will forever reflect the legacy and impact Peter had on this organization, community, and staff," Silver Bay YMCA Interim CEO Lucas Callahan stated.

Many of the projects Silver Bay is currently working on were made possible due to the groundwork Doliber laid. The improvements being made to Slim Point, the Fisher Gymnasium Winterization, and the Renovations to Bayview Lodge ensure that Doliber's impact will be felt for many generations to come.

Silver Bay YMCA Board of Trustees Chair Elise Walton commented, "Peter joined Silver Bay to build on Silver Bay's

## THE HEMLOCK WOOLLY ADELGID

The hemlock woolly adelgid (HWA), the invasive forest insect first detected in the Lake George watershed in 2020, continues to spread and pose a threat to water quality and wildlife habitat. To help mitigate the impacts of HWA, the Lake George Land Conservancy (LGLC) continues to manage HWA on infested preserves through chemical control, in conjunction with the release of biological controls (biocontrols) — predatory insects that specifically feed on HWA.

This spring, the LGLC will complete a cycle of chemical treatment at both the 15-acre East Brook Preserve in Lake George and the 60-acre Clark

Hollow Bay Preserve in Putnam.

The goal of using a chemical and biocontrol two-prong approach is to provide chemical protection to the trees while the biocontrols have time to build numbers. As the biological controls get established, they can reduce the population of HWA on a landscape scale and create a glimmer of hope for the future of hemlock forests.

The LGLC staff and their partners in the [NYS Hemlock Initiative](#) and [Lake George Hemlock Coalition](#) are also looking for evidence of mortality of HWA after this year's cold winter. This information will help to further research and guide management



plans as they continue their efforts to protect Lake George from this invasive pest.

Please follow this advice from the New York State Department of Environmental Conservation (NYS DEC):

- Stick to low-elevation hiking trails.
- Avoid hiking on any trails during periods of significant rainfall.
- If hiking on muddy or flooded trails, stay in the center of the trail to prevent erosion. The center of the trail can sustain boot prints.


