PUBLIC MEETING SCHEDULED FOR COMPREHENSIVE PLAN UPDATE

The Town of Hague and the Comprehensive Plan Update, Grant Application, and Visitor/Community Center Committees invite all residents and stakeholders to participate in the first public meeting for the Town's Comprehensive Plan Update on **Thursday**, **July 10**, **2025**, **from 6 to 7:30 pm** at the Hague Community Center.

This important workshop marks a key milestone in the town's process to create a consensus-based plan that will serve as a road map for Hague's future development. Public input is critical to developing a plan that truly represents the community's vision.

The meeting will begin with a presentation about the planning process and the findings of the recent Community Preference Survey. The presentation will begin at **6:15 pm** and then shift to an open house format where attendees will be invited to provide feedback at poster stations that will illustrate potential opportunities, actions, and projects that may have a positive impact on Hague's future.

SCHOOL ADVISORY COMMITTEE (SAC) UPDATE

The School Advisory Committee (SAC) was honored to have Dr. Roger Catania attend its May 1, 2025 meeting. Dr. Catania is the New York State Education Department Regent for the 4th Judicial District. Prior to that position, he was the superintendent of the Lake Placid Central School District. Dr. Catania is well versed in academic concerns and the meeting was very informative.

In the May 20th School Board of Education (BoE) voting, Mark Russell was re-elected and John Dreimiller and James Wells, Sr. were elected.

Here is how the votes were cast:

John Dreimiller: 319 Mark Russell: 290 James Wells, Sr.: 284 Tracey Cross-Baker: 233

The 2025-2026 budget easily passed 341 to 86. The total budget increased by 0.03%, with a school tax levy increase of 1.07% compared to last year.

PUBLIC HEARINGS

COSTELLO - 264 Summit Drive - Subdivision (SUB 02-24)

The applicant wants to subdivide an eight-acre parcel (Lot A) with a house and barn in OCII zoning from a 67-acre parcel (Lot B) that spans both OCII and RC zoning. The intent is to keep the house and gift the remainder to their son. No public comments were received or voiced in opposition. The public hearing was closed by unanimous vote.

SUBDIVISIONS/OLD BUSINESS

COSTELLO - 264 Summit Drive - Subdivision (SUB 02-24)

Board members reviewed requirements under Subdivision Code Article IV. The SEQRA was complete, all easements were in order, and approvals were received from Warren County and the APA. A site visit was waived based on available maps and an online review. A motion to approve the application passed unanimously. Chairman Powell signed the subdivision maps for filing.

NEW BUSINESS

PARLIN/RIGGER - Multiple Lots - Subdivision (SUB 01-25)

Applicants seek to reorganize four existing lots into four conforming lots for estate planning. The application was withdrawn from this meeting due to missing information.

BOSCO – 28 Friends Point South – Development (DEV 40-24, SP 09-24)

The project involves a lakeside stone patio and stone steps. Although previously granted a variance with Planning Board recommendations, the APA has reversed the ZBA's decision due to concerns about patio expansion and lake visibility. Tony DeFranco, representing the applicant, expressed concerns about the APA's ruling and documentation.

The next Hague Planning Board meeting will be held on May 1, 2025. \square



DIED: John Callanan McDonald, 94, of Ticonderoga and Westport on April 12, 2025, peacefully, at home.

John was born on May 15, 1930, in Plattsburgh. He lived



After graduating from Port Henry High School, he completed a post-graduate year at the Irving School for Boys in Tarrytown before attending Dartmouth College, class of 1952. He majored in history and played varsity football and basketball. Following graduation, he served in the U.S. Marine Corps during the Korean War, then earned his law degree from Albany Law School in 1958.

He married Anne Burleigh in 1964. John practiced law in Essex County and served as the town attorney for Port Henry, Ticonderoga, and Hague. In 1972, he was appointed Essex County District Attorney by Governor Nelson Rockefeller and was reelected six times, serving until 1993.

A dedicated outdoorsman, he enjoyed hunting, fishing, and gardening, and was a devoted Dartmouth football fan. He supported his community through

long-time service to many local organizations. He was president of the Black Watch Memorial Library for over 45 years and board chairman of AuSable Chasm for more than 50 years. John was a member of the Veterans of Foreign Wars, the American Legion, the Marine Corps League, the Elks Lodge, the Knights of Columbus, the Northern Lake George Yacht Club and the Gooley Club, among others.

He was predeceased by his sister, Helen; brother, Michael; and granddaughter, Meredith.

He is survived by his wife, Anne; children, Mary, John Jr. (Andrea), and Bridget Fawcett (Donald); and grandchildren, Margaret, Anna, Elisabeth, and Rudd. He is also survived by his brother, Thomas.

SUPERINTENDENT NEPHEW ANSWERS CITIZEN'S QUESTIONS REGARDING SCHOOL BUDGET

Some questions posed by a private citizen regarding the new school budget were answered by Superintendent Scott Nephew. This Q & A is public data and is shared here in its unedited entirety:

 How does the budget reflect actions to address the learning needs of students not demonstrating proficiency in ELA, Math, and Science? (Appendix C)

There is no specific 'budget plan' for improving 3-8 test scores. Programs, curriculum, and instructional strategies are adjusted each year, month, week, and day by our staff to best give our kids the tools they need to be successful in our District, and ultimately to prepare them for Regents exams, graduation, and the path that they choose when they leave us.

2. What initiatives is the proposed budget funding to reduce chronic absenteeism? (Appendix C)

No initiatives are proposed in the budget to reduce chronic absenteeism. Our staff members (teachers, counselors, support staff, etc.,) work continuously with students/families who are having attendance issues. Outside agencies are also involved when necessary. Please also note that our chronic absenteeism rates of 21.6% (K-8), and 7.2% (9-12) could indeed improve, but are also well below the state average of 34.8%.

3. Does the TCSD have a near-term forecast of future PILOT revenue? How much PILOT revenue is the TCSD anticipating in each of the next few years?

An in-depth look at PILOT agreements is scheduled to be held at our regular June BoE meeting.

 Health insurance represents a large chunk (27.3%) of the budget, excluding debt service. What options are being explored to reduce the cost of health insurance to TCSD while still offering comparable benefits?

The district is part of a 15-school health care consortium which has helped to reduce costs. The consortium in conjunction with our legal advisors are continuously looking for ways to reduce costs, and our current 4.5% health care increase is far lower than neighboring groups. In reality, salaries and benefits will always make up a large portion of our budget, but we will continue to work on ways to bring down costs, while still providing proper benefits for our employees. A few other examples of how the consortium has helped reduce costs are:

- rate setting negotiations with Anthem
- centralized billing with oversight for all Districts
- wellness initiatives
- employee assistance programs

safe driving conditions on our roads.
As the LGA stated in a recent
memorandum, "The Town of Hague is
a perfect case study illustrating what
can happen when simple adjustments
to winter road maintenance
techniques are made, saving taxpayer
dollars and protecting our water,
which benefits the economy, public
health, and the environment."

Legislation currently before the State Senate and Assembly (A.4481-A located <u>HERE</u> and S.6976-A located HERE) would establish the New York Road Salt Reduction Council and a Citizen Advisory Committee to help advance the recommendations issued in 2023 by the Adirondack Road Salt Reduction Task Force. This would ensure that the recommendations don't simply remain on the pages of the study but are put into action.

LGA SUPPORTS LEGISLATION TO REDUCE ROAD SALT

As the lake temperature warms and our thoughts turn to lazy summer days in and on the water, winter driving and road salt might not be top of mind for most of us. But, protecting Lake George's legendary water quality is a year-round task. With that in mind, the Lake George Association (LGA) has issued a memorandum supporting legislation before the State Senate and State Assembly that would help reduce road salt in the Adirondacks. According to the LGA, road salt is one of the major threats to Lake George's pristine water quality.

Throughout the Adirondacks, state snowplow drivers drop an average of 37 tons of road salt per lane-mile per year on state highways. Things are better in Hague, where the town maintains the state highways under a contract with the state.

And, as reported in past issues of *The Hague Chronicle*, Hague is a leader in salt reduction efforts, with funding assistance from the LGA. The result is a win-win-win situation. By reducing its

LGLC LAUNCHES FUNDRAISING CAMPAIGN

The Lake George Land Conservancy (LGLC) is conducting its largest fundraising campaign ever as it strives to raise \$9 million to permanently protect more than 1,200 acres of land around Lake George.

The LGLC is under contract to purchase 517 acres of Pilot Knob Mountain, including its 2,159-foot summit and 1.6 miles of streams. The fundraising campaign also includes multiple conservation projects in

LOOKING BACK

THE HAGUE CHRONICLE – JUNE 1975 HAGUE'S HISTORICAL SITES

With the assistance of Town Historian, Mrs. Vila Fitzgerald, the Warren County Bi-Centennial Commission has published a list of historical markers, historical sites and points of interest in the Town of Hague. Here, in capsulated form, is the list.

Historical Markers

Sabbath Day Point adjoining James Young's place which reads: "Through this place passed General Henry Knox in the winter of 1775-76 to deliver to General Washington at Cambridge the train of artillery from Fort Ticonderoga used to force the British out of Boston". It was erected during the Sesquicentennial of the American Revolution. (marker #1)

Another marker, erected by the Warren County Centennial Commission in 1913 and which can be seen at the town park, reads: "The Town of Hague, known as Rochester until April 6, 1808 formed from the Town of Bolton February 28, 1807". (marker #2)

Historical Sites

<u>Rogers Rock</u>– Where Major Robert Rogers, in the winter of 1757-58, being pursued by Indians, went on snowshoes with his men to the top of the mountain, only to be stopped at the precipice leading to the lake. He turned his snowshoes around and retraced his steps down a ravine eventually reaching the lake. He had earlier thrown his supplies over the precipice.

<u>Friends Point</u>- This was once an Indian Scout encampment. On a dark night, two scouting parties met here during the French and Indian Wars and prepared for combat. They discovered they were friends and not foes; hence the name.

<u>Sabbath Day Point</u>- In July 1759 General Amherst landed here with a force of 12,000 men and passed the Sabbath Day in religious services; hence the name.

Points of Interest

<u>Calamity Rock</u>-About one-half mile north of Hague where the John Jay burned on July 29, 1856. Six lives were lost.

<u>Graphite Mines</u>–On Route 8 where graphite mines operated from about 1880 to 1924.

<u>Silver Bay Association</u>–Where the first Boy Scout training camp for leaders in the United States was held in 1910.

<u>Old abandoned cemetery</u>–On Route 9N about one-half mile south of the town park, where five Revolutionary War veterans are buried.

<u>Wardboro</u>– About 12 miles south of the town park, three miles off Route 9N, was once a thriving settlement named for a number of Ward families who first settled there. An old cemetery marks the spot.

<u>West Hague</u>- An area about four miles west of Hague on Route 8. This was the most thickly populated part of the town in the 1800's. An abandoned cemetery remains but there are no other markers.

<u>Tannery Site</u>- Located below the bridge on Tannery Brook in West Hague; it was run by Irish and Wright.

<u>Cooper Shop</u>- Located on West Hague Road and operated by Andrew Bevins in the early 1800's.

<u>Two Mill Wheels</u>- Can be seen atop stone pillars on either side of the bridge leading to the New York Department of Environmental Conservation fish weir.

<u>Lower Falls</u>– Site of the first grist mill built in the early 1800's. Owned by a Mr. Kenny, later by Rufus Rising and operated by H.H. Harrison.

<u>Upper Falls</u>- Site of a gristmill brushback factory and cider mill which were operated until 1910. The flume and water wheel can still be seen.

<u>Four Chimneys</u>– Brick house about four miles north of Hague on Route 9N. It was built in 1822 by Warner and William Cook and is now occupied by Mr. and Mrs. Alfred Stanley. The bricks were made on the premises.

<u>Jabe Pond</u>– Named for Jabe Patchen, is located a mile west of Route 9N in Silver Bay. Jabe Patchen was the son of Samuel, the first supervisor of the Town of Hague and a Revolutionary War hero.

Lake Shore Graphite Mines – Located off Route 9N about a quarter mile atop Rising Hill. This unsuccessful mining operation continued from 1898 to 1901. The foundations of boarding houses and store, a waste pile and closed off mine entrances are all that remain.

Marker #7 – <u>Annual Outboard Marathons –</u> 9N -1954 to 1964

Marker #8 - Hague Central School - Rt. 8 - 1927 to 1979

Marker #9 - Graphite - Rt.8 - 1880 to 1921

Signs describing churches and other places of interest are also in various places in Hague for you to enjoy while walking about town.

Since we are celebrating the 250th anniversary of the American Revolution this year, we hope some of our own history will be of interest and pride to you and all of us who call this place home.

WHAT'S HAPPENING AT THE FORT

Fort Ticonderoga has officially added four Spanish cannon and two mortars to its permanent collection, a historic gift from the Yale University Art Gallery. On long-term loan since 1943, these iconic bronze pieces have been a central feature of the fort's landscape for over 80 years.





The announcement comes during National Preservation Month, highlighting efforts to protect historic sites and artifacts.

Cast in the early 1700s during the reign of King Philip V, the artillery includes two massive 24-pounder cannon and two 16-pounders, all bearing intricate inscriptions like *Violati Fulmina Regis* — "the offended King's thunderbolts." Also included are two 13-pulgada mortars, each weighing more than two and a half tons.

Originally donated to Yale in 1928 by World War I veteran and Yale alumnus de Lancey Kountze, the pieces were transferred to Fort Ticonderoga with Yale's approval in 1943. Kountze, a dedicated supporter of museums, served as a Patron of the Fort Ticonderoga Museum until his death in 1946.

"These Spanish artillery pieces have shaped the Ticonderoga experience for generations," said Curator Dr. Matthew Keagle. "We're grateful to Yale for entrusting us with their long-term care."
