Community Center staff. Bertha worked for the town for more than forty years and was the face of the town to all who passed through the community center's halls and the town's environs.

It was Bertha and her cheerful countenance who greeted us in the lobby of the community center; it was Bertha who asked after our families; it was she who asked what she could do for us. She had her fingers in so many pies and wore so many hats that there was very little she couldn't help us with. We all think of her as the Hague Community Center Receptionist, but over the years, her hats have included the Hague Highway Department Secretary, the Hague Town Receptionist/Clerk, the Hague Community Center Coordinator, the Hague Food Pantry Coordinator, the Hague Deputy Town Clerk, and the Hague Deputy Registrar of Vital Statistics. Need something? "Call Bertha; she'll know!" was the frequent refrain.

Bert was born in Warrensburg, the eldest of the nine children of Mary and Clifford Frasier.

The family moved to Hague when Bert was four years old. Being the oldest child is most likely when her caring for others began and it has continued throughout her life. She graduated from Hague Central School in 1958. Bert raised her own six children here in Hague. They spent some interesting summers when she and her husband, Jack, the last Swede Mountain Fire Observer, lived with four of their children in a three-room cabin on Swede Mountain.

ZONING BOARD OF APPEALS - 11/16/2023

Present were Chairman Robert Goetsch, Ray Snyder, Chris Navitsky, Linda Mury, and Jon Hanna. Also present were ZEO Tristan Shappy, Acting Zoning Enforcement Officer Cathy Clark, and Recording Secretary Kathy Santaniello.

PUBLIC HEARING:

KIMBLE (26.17-2-42.122) 9112 Lakeshore Drive (Hamlet) VAR 15-23

No one spoke in favor of or opposed to the project. Four letters were read from nearby property owners who had questions regarding the zoning issues involved. Clark reported the Planning Board had carried out a site visit and made a positive recommendation, with conditions. Motion was made, seconded, and unanimously passed that the public hearing be closed.

REGULAR MEETING

OLD BUSINESS:

1. JESBERGER (43.13-1-29) 7 Bayberry Lane (TR-1) VAR 08-23, VAR 09-23, VAR 10-23

The applicant is applying for three variances for an addition to a nonconforming structure. The home is in the sewer district and the project has received approval from the Cape Cod Association.

Zoning Issue: 160-65 (A)(1) More than 25% increase to a nonconforming structure.

Two of the variance requests have been eliminated, leaving only Variance 08-23, Zoning Issue 160-65 (A)(1), more than 25% increase to a nonconforming structure. Motion was made, seconded, and passed unanimously.

2. KIMBLE (26.17-2-42.122) 9112 Lakeshore Drive (Hamlet) VAR 15-23

The applicants would like to remove an existing 100-sq. ft. shed and construct a 200-sq. ft. gazebo 30' from the MHW.

Zoning Issues:160-50 B (b) (3)

There were questions about the right-of-way/easement situation, how far back from the lake the structure will be, retaining the easement for pedestrian access to the lake, .and whether there will be lights in the structure.

Two conditions were discussed: 1. The amendment to the easement to be ten feet. 2. No permanent lights on the structure. The motion was made, seconded, and passed unanimously including only the first condition.

OTHER BUSINESS: At 7:20 pm, the board went into executive session to discuss possible litigation. After discussion, the motion was made, seconded, and carried 4-1-0 (Goetch recused.) to adjourn the executive session.

A motion was made, seconded, and passed unanimously that the board authorize payment of bills in the General Fund, Highway Fund, and Sewer Funds #1 and #2.

Frasier read Diane Trudeau's resignation letter. A motion was made, seconded, and passed unanimously that her resignation be effective December 31, 2023.

A motion was made, seconded, and passed unanimously that Desiree Diskin would work at the front desk at the rate of \$17 per hour, effective January 2, 2024 and until the board approves a replacement for Bertha Dunsmore.

A motion was made, seconded, and passed unanimously that Donna Clark's salary be raised to \$19.50 per hour so it is in line with other town employees.

Patchett read his letter of resignation for his unexpired Hague Town Board term, effective December 31, 2023 at 11:59 pm. The letter in its entirety is on file at the town clerk's office.

Frasier reminded the board that the judge's, town clerk's, ZEO's and bookkeeper's books need to be audited by January 20, 2024 and that the 2024 organizational meeting will be held January 3rd at 6 pm.

At 3:10 pm, the board went into executive session to interview applicants for the upcoming open town board position. The session was closed.

A motion was made, seconded, and unanimously passed to appoint Martin Fitzgerald II to fill the seat vacated by Patchett, effective January 1st.

PUBLIC HEARING #1:

Ellie Hitzrot at 24 Tower Point Road, *Tax Map #* 76.12-1-14 is seeking six variances pertaining to her septic system. Sandblom stated that the owners want to replace their system to meet the current standards. The proposed system will be a NSF Certified Enhanced Treatment Unit, Fuju CEN-5 tank, a pump tank, and new absorption field, which is suitable for the limited space. Cedarwood Engineering has reviewed the application and has made recommendations in a letter dated January 8, 2024. That letter is available for review in the town clerk's office. Patchett stated the Hitzrot Public Hearing will remain open until the February 13, 2024 town board meeting.

PUBLIC HEARING #2:

Oxford Cottages, Inc./Lee Cunningham, *Tax Map* #76.20-1-3.2, 4 Silver Bay Road (TR-1R) The applicant is seeking five variances pertaining to the existing septic system. Jarrett gave an overview of the previously-approved Oxford Cottages, Inc./Lee Cunningham application. Several audience members and ZOOM attendees spoke either in favor of or against the application.

Due to a clerical error in the original application, the application had to be resubmitted for town board approval. Stephanie Bitters from Bartlett, Pontiff, Stewart & Rhodes, P.C., Attorneys, who was retained by Peter and Carol Sisca and Callie Sullivan, provided and reviewed documentation as to why they retained the firm. The document, dated January 11, 2024, is available for review in the town clerk's office. Patchett stated this public hearing will remain open until further notice.

Jarrett then gave brief reviews of the following sewer-related applications:

David Lance Clark at 9657 Lakeshore Drive *Tax Map # 12.14-1-18.1*

The motion to set these public hearings for February 13th at 6:15 pm was made, seconded, and passed.

WELCOME GUESTS/PRIVILEGE OF THE FLOOR:

David DeFranco presented documents explaining his concerns and suggestions regarding the applications for Thomas Simunek and David Lance Clark.

Doulin said we need to focus on the lake's water quality, including preventing bacteria in the lake.

REGULAR COMMITTEE REPORTS:

Buildings and Grounds/Community Center/ Enhancement: Patchett stated the community center building needs fresh paint on the interior and exterior.

Highway: Dunklee stated the highway department crew has been welcoming and helpful during his transition period.

Museum and Historian: The scheduled meeting was canceled due to weather.

Personnel: The interviews for highway and front office help will be held in the near future. Interviews for the opening on the planning board will be conducted on January 17th. Bast is still working with Civil Service regarding the ZEO position.

Planning/Zoning/Storm Water: ZEO Cathy Clerk stated her office has been extremely busy and for the board to expect many more variances.

Recreation/Promotion/Youth: Fitzgerald reminded Patchett to review the 2024 budget to confirm the Silver Camp monies were budgeted for the upcoming year.

Sewer Districts # 1 and #2: The truck is having major mechanical issues that need to be addressed. The Sewer Advisory Committee continues to work on the placement of an emergency generator at Cape Cod Village.

Town Park and Beautification: Ramant is working with Todd Fish and National Grid on the replacement of some streetlight bulbs.

Technology and Communications: Patchett explained this is a new committee, which will focus on better communication between the town board and the members of the community.

Coffin stated there had been an issue will the Hague E-Check payments online due to the fact that the managing credit card company did not activate the option on the town's website. The issue was promptly addressed. Anyone who made payments via E-check online before January 10th is asked to please contact Coffin.

UNFINISHED BUSINESS:

Patchett reminded the community the town is searching for a volunteer to organize the Memorial Day Parade. Interested persons or groups should contact him.

Patchett stated that the updated Short-Term Rental (STR) changes have been distributed to the town board members for them to review for a future public hearing. These changes are also on the town's website.

NEW BUSINESS:

Patchett reminded the board to schedule appointments to audit the books of the judge, ZEO, bookkeeper, and town clerk by January 20th.

WIND-CHILL FACTORY, CONTINUED

Until now, the Wind-Chill has been open from March through October, with its busiest months being June, July, and August. The long summer lines attest to that!

It has employed scores of teenagers and adults from Ticonderoga, Hague, Arcady, and Gull Bay. In the heart of the summer, about 40 people man the pizza, grill, fryers, and ice cream areas.

The exciting news is that, as of January 2024, the Wind-Chill has also "gone Mexican" by opening the Mexican Grill on site!

When asked why he wanted to stay open all year and why Mexican food, owner Bob Porter explained, "We have great employees in the summer and we want to continue employing them. We decided that with Mexican being a quick-service model and with it being the fastest-growing ethnic food, it would be the right menu to try. Also, nobody else in town offered Mexican on a permanent basis."

So, after Columbus Day weekend 2023, Bob and his crew made a number of modifications to the building. They studied nationwide Mexican restaurants to see what each did well and what he and his crew could do even better. Bob's sister, Karen Whalen, helped in every facet of the transition.

The manager, Tyler Laudermilk, and workers Erin Burroughs and Chantal Smith did research, Porter attended cooking shows and met with Sysco Foods, and they all learned how to make authentic Mexican-style dishes. They committed to going above and beyond the norm by trimming the fat off meats prior to cooking, chunking the beef, and marinating the meats in their own flavorful marinades.

After much work, they were ready. The official ribbon-cutting ceremony occurred on Thursday, January 11, 2024 at 4:30 pm...and quality Mexican food became available on an everyday basis in Ticonderoga!

The Mexican Grill offers made-to-order burritos, burrito bowls (similar to Chipotle's), tacos, taco salads, and seven different signature bowls, featuring a variety of healthy and delicious optional ingredients. Kid's meals are also available.

The employees make their own pico de gallo, salsa verde, corn salsa, and regular salsa and they even whip their sour cream so it's extra light and creamy. Now, that *is* special!

The grill has a self-serve fountain with sodas and iced teas. Bottled sodas, Mexican sodas like pineapple and mango, and authentic Mexican Coca Cola in glass bottles (which uses sugar cane instead of the American corn syrup version) are all available. Incidentally, soda aficionados say the

Mexican Coke tastes much better than our American variety!

There's an original Slush Puppy machine in which they can make blue raspberry Slushies and even virgin margaritas.

A milkshake machine (like they have at Five Guys and Chick-fil-A) creates tasty milkshakes that are so thick, they require extra fat straws!

To place an order, customers can call 518-585-3044, order online at windchill factory.com, or by downloading the app. Porter says it's super easy to use and food can be completely made to order. The customer places an order, the staff is alerted, it accepts the order, and the app tells the customer how long it will be before the order will be ready. Simple!

The Mexican Grill is open for takeout only from 11 am – 7 pm, seven days a week. There is a drive-up window for pick ups and delivery service is available. It is located at 794 Route 9N in Ticonderoga.

Porter says he plans to continue operating the Mexican Grill during the summer, along with all the delicious offerings we've come to love from the Wind-Chill Factory. That is good news!

"If you haven't tried the Mexican Grill, please come out and try it. I think you'll be pleasantly surprised. We offer service, quality, quantity, and a good price," said Porter.



Guided by this program, students raise landlocked Atlantic salmon through the first three stages of life (egg, alevin, and fry) and then release them in the Lake George watershed. Students use a tank setup that mimics an outdoor environment, including rocks where salmon can congregate and a chiller to control water temperature.

In January, the salmon eggs were delivered to participating schools. Each week, tank temperature is increased by one to two degrees. During the month of February, the eggs will hatch, releasing tiny alevin that spend time on the rocks. An attached nutrient sac provides food through this stage, which lasts approximately six weeks. In March, the salmon transition to the fry stage and the students begin feeding them. By the end of May, the fry are two to three inches long and tank temperature is the same as the water in local streams.

After obtaining a release permit from the state, students set their salmon free within the watershed, as the school year draws to a close. Through their five months of being caretakers for the salmon, the students learn valuable lessons about the life cycle of salmon.

TREE AND SHRUB SEEDLING SALE IN WARREN COUNTY

Before we know it, the snow will be gone, the ground will thaw, and property owners will start thinking about their yards and gardens. Residents may want to consider taking advantage of the Warren County Soil and Water Conservation District's annual tree and shrub seedling sale to improve the landscape around their properties.

Buying young bare root seedlings can provide beneficial habitat for wildlife, encourage pollinators such as hummingbirds, butterflies, bees, and more, help reduce soil erosion, improve water quality in Warren County, and beautify landscapes.

Fruit trees, conservation packs, tree shelters, bluebird, bat, and wood duck houses, wildflower seed mixes, deer plot seed mix, and upland game bird seed mixes can also be ordered.

TI-ALLIANCE RECEIVES GRANT FOR CHILDCARE

The Ticonderoga Revitalization Alliance has received a \$25,000 grant from the Cloudsplitter Foundation to support the Ticonderoga Community Childcare Project.

"We're excited to be a part of bringing public childcare to another Adirondack community. Early learning is essential to preparing our children for school and has such a significant impact on their ability to be successful throughout their lives. The availability of childcare for working families also helps to raise the level of household incomes and supports a healthy community economy. We can't wait to visit the new facility," said Cloudsplitter Foundation Director of Grants and Administration Chenelle Palyswiat.

The funding comes at a critical time as renovations on the building at St. Mary's School began in January. Other planning for the center's opening is ongoing including a final operating plan, facility upgrades, staffing, and curriculum.

Pre-registration is open and pre-registered families will have priority for final enrollment.

Since early 2022, Ti-Alliance and a dedicated team of committee members have been working to bring public childcare to Ticonderoga. At the outset, the center will support approximately 50 children and create 11 full time jobs, all providing living wage salaries and benefits. The center is expected to open this spring.

Ti'coustics, the music shows featuring local musicians on guitars and other instruments, will have two shows in February 2024.


