## DO WE NEED A HERBICIDE IN LAKE GEORGE?


In 2023, the NY Supreme Court ruled that the Adirondack Park Agency (APA) did not follow its own processes when it issued a permit for the Lake George Park Commission (LGPC) to put the herbicide ProcellaCOR into Lake George to combat Eurasian milfoil. The LGPC appealed that decision, and in early May of this year, the NY Appellate Division reversed the lower court's ruling.

As a result, the LGPC has again applied for permits to put the chemical into Lake George at Glenburnie and Huletts Landing, both of which are within the Town of Hague's jurisdiction. The APA is expected to vote on the permits at its June 20, 2024 meeting, meaning the chemical could potentially be put into the lake by the end of this month.

The Lake George Association (LGA) steadfastly opposes ProcellaCOR, citing

the risks it poses, based on scientific data specific to Lake George. Click HERE to view the science.

In addition, the LGA noted that the State of Minnesota recently identified the active ingredient in ProcellaCOR as a PFAS-containing pesticide. PFAS is a class of "Forever Chemicals" that cause cancer and have contaminated drinking water supplies in communities across the country, including in NY.





# WOTTON ELECTED TO SCHOOL BOARD

In the election held on May 20, 2024, Donna Wotton of Hague was elected to serve on the Ticonderoga School Board of Education. Erik Leerkes was re-elected and Tom Jebb was elected. The school budget passed 456-134.

There were three open seats. The results were: Erik Leerkes – 281, Tom Jebb – 268, Donna Wotton – 247, James Wells, Sr. – 233, John Dreimiller – 229, and Robert Porter – 205.

Wotton told *The Hague Chronicle*, "I'm so honored for the support of everyone that voted for me. The Hague residents really brought out the vote. It was a very close election with the votes very evenly distributed between the candidates. The strength of the Hague voters really won the day. I can't wait to represent Hague on the school board and work to strengthen our schools for all the students and families of Ti, Hague, and Putnam!"

## NEW HISTORICAL MARKER IN HAGUE

The Hague Historical Society, in conjunction with the Town of Hague, and with the assistance of the Hague Highway Department, recently installed its newest historical marker. This, the eighth such sign, is located in the town park and commemorates the outboard marathons held in Hague from 1954 -1964. The pits for the marathons were in this park.

The other markers are for Hague Central School, Graphite, the Steamboat Landing, Arcady, the

## **PROCELLACOR, CONTINUED**

The LGPC contends that ProcellaCOR poses no risk based on studies submitted to the Environmental Protection Agency by the manufacturers of the herbicide. You can read the LGPC's position on the use of ProcellaCOR HERE.

The LGA recently launched a "Not 1 <u>Drop</u>" campaign to raise awareness about ProcellaCOR research and to suggest specific actions people can take to express their opposition, such as writing to the APA and the governor.



Public and municipal opposition to ProcellaCOR on Lake George is strong. All four towns in the north basin -Hague, Ticonderoga, Putnam, and Dresden - have gone on record opposing the herbicide and more than 4,600 people have signed a petition against it HERE. This, the LGA points out, is an entirely different situation from other lakes where ProcellaCOR permits have been granted. In those cases, municipalities and residents asked to use the herbicide to combat what they viewed as a milfoil crisis. One thing that the LGA and the LGPC agree on is that there is no such crisis in Lake George.

Now the question is: Will the LGPC and the APA listen to what the town governments and the people on Lake George are telling them? Will they take the time to review the Lake George-specific science presented by the LGA? Will they take into consideration the concerns raised by the State of Minnesota about PFAS in ProcellaCOR? Or will they move forward with their plans despite all this?

## **TI-ALLIANCE UPDATE**

Here are some updates from Ti-Alliance Executive Director Donna Wotton:

#### SKILLED CAREER TRAINING SCHOLARSHIP PROGRAM

Each student will attend a program for an associate's degree or certification in a field where jobs exist in our community. Almost all students receive some financial aid from their programs, but often the rest is not manageable for the

student and its family. Ti-Alliance funds their tuition and expense gap to enable them to get their training. Last year, it funded \$41,000 in scholarships.

Students graduating from rural schools in NYS are at a disadvantage compared to their urban and suburban peers. That's because our tax base barely funds the state education mandates and enrichment programs are always the first to go. It's also because these programs just aren't accessible or available in our small community.

Each year, Ti-Alliance dedicates a small amount of general funds to supporting underfunded programs at the school. It wants to create a fund that can help more students broaden their horizons and experiences so that they are better prepared to be good students and citizens.

#### Some examples are:

1. In 2022, for \$600, Ti-Alliance funded a four-day trip for art student, Michael O'Donnell, to NYC where he

visited museums including the Fashion Institute of Technology (FIT). Michael has now been accepted at FIT!

2. Two years ago, Audrey Cook was accepted as one of the youngest students ever to attend Sotheby's two-week summer art program in New York City. Ti-Alliance donors provided the \$6,000 to allow her to attend.

3. The Teacher Wish List - Ti Alliance surveyed the teachers in Ti to ask what would make a difference in their classrooms. For \$2,000, every request was fulfilled.

## **ZONING BOARD OF APPEALS - 4/25/2024**

Present were Chairman Robert Goetsch, Chris Navitsky, Cathy Clark, Linda Mury (via ZOOM), and Chris Richards, alternate. Absent was Jon Hanna. Also present were Zoning Enforcement Officer Ed Kirchberger, Recording Secretary Kathy Santaniello, Sandra Powell, Nydia Mitchell, Ken Andrea, Denise Gugumuck, Peter Mitchell, and Scott Patchett.

#### **PUBLIC HEARINGS**

## 1. MITCHELL (60.17-1-17) 30-32 Oneida Drive (TR-1R) VAR 06-24 and VAR 07-24

Mitchell and his two siblings would like to subdivide their lakefront lot that has two houses into two lots. They would then sell one of the lots with a house and keep the other lot with a house for their family. A letter was read expressing concern about where a second dock would be located. The planning board had forwarded a negative recommendation to the ZBA, which was also read.

#### 2. TROUT HOUSE VILLAGE RESORT (26.17-2-40) 9117 Lakeshore Drive (Hamlet) VAR 05-24

Scott Patchett, property owner, gave an overview of what had been done with the patio project, which he felt positively addressed some safety issues with this area. Kirchberger read four positive letters regarding the project. The planning board's positive recommendation was also read.

A motion was made, seconded, and unanimously passed to close the public hearings.

#### **OLD BUSINESS:**

## 1. MITCHELL (60.17-1-17) 30-32 Oneida Drive (TR-1R) VAR 06-24 and VAR 07-24

The owners of this property would like to subdivide a 1.6-acre lot into two parcels. Lot #1 is proposed to be .66 of an acre and Lot #2 is proposed to be .50 of an acre. Lot #1 would have 63 feet of shoreline and Lot #2 would have 112 feet of shoreline.

## Zoning Issues: 160.24 A - Acreage and 160-50 B (c) [1] Shoreline width

Mitchell reported he had not made any progress on the acquisition of additional property, but he was still trying to gain 37 additional feet from the adjacent boat club property for Lot #1. Clark reminded Mitchell that variances are not granted based on financial or personal difficulties, but rather must be based on some practical difficulty with the land itself. After much discussion, a motion was made, seconded, and unanimously carried to table acting on the proposal for 60 days to allow Mitchell more time to come up with some possible solutions.

#### 2. TROUT HOUSE VILLAGE RESORT (26.17-2-40) 9117 Lakeshore Drive (Hamlet) VAR 05-24

The applicant is seeking an after-the-fact variance for a stone paver patio area over 100 sq. feet and raised by 20 inches and made level by use of a 6' x 6' retaining wall. Additionally, two existing decks were resurfaced using Trex and existing fencing was replaced to adhere to the 36" height code regulation. An additional section of 36" high fence was added for safety reasons where there was a drop in elevation between patio areas.

#### Zoning Issues: 160-50B Shoreline

There was discussion regarding runoff and the permeability of the pavers. It was recommended that the owners put in an additional stone trench for drainage. The motion was made, seconded, and carried 5-0 to approve Variance 05-24, with the addition of the trench along the eastern edge of the stone patio where it borders the Trex deck.

## 3. PARLIN (60.17-1-22) 3 Dot & Jack Lane (TR-1) VAR 04-24

The applicants are requesting a shoreline variance. The existing shoreline of this lot is 251.5 ft. The proposed shoreline would be 68 ft., if approved.

#### Zoning Issues:160-50B Shoreline

The applicants will be contacted to confirm that they have resolved any issues that would require a variance at this time.  $\hfill\blacksquare$ 

#### PLANNING BOARD - 5/2/2024

Present were Chairman Pam Peterson, Sandra Powell, Edna Frasier, Judy Gourley, and Meg Haskell. Also present were Zoning Enforcement Officer Ed Kirchberger, Recording Secretary Kathy Santaniello, and Landscapers Bob Burch and Dylan Stein.

#### **NEW BUSINESS:**

#### ROSELLI (93.16-1-6) 92 Sabbath Day Point Road (TR-1)

The applicants propose the demolition of wood retaining walls and impervious paving stones to be replaced with more natural cobbles, native plants, and permeable pavers. Pre-existing non-conforming lot size is less than 100 feet from the water.

#### Zoning Issues: 160-50 B1 - Shoreline

Landscapers Bob Burch and Dylan Stein presented the project. Plans include natural cobbles, natural granite treads (steps), a rain garden, a drip line, and various native plants. The stormwater permit has been submitted to the Lake George Park Commission (LGPC), but no reply has been received. The board thought the application could not be deemed complete until the drawings are updated to include a fixed fire pit (if the applicants want one) and the inclusion of the existing patio dimensions. A site visit was scheduled for Friday, May 10, 2024 at noon.

#### **OTHER BUSINESS:**

Frasier made some inquiries with surrounding towns about their procedures/penalties for those who did not go through the proper permitting process for their projects, resulting in requests for after-the-fact variances. She found that many penalties were much more severe than ours, and that the town board can revise our present penalty fee schedule if it chooses. Kirchberger is working on this.

## **TOWN BOARD - 5/14/2024**

Present were Supervisor Joshua Patchett, Board Members Steve Ramant, Martin Fitzgerald, Maureen Cherubini, and Jack Bast. Also present were: Highway Superintendent Chad Dunklee, Zoom Coordinator Tim Fiallo, Matt Coffin, Chris Richards, Bob Holmes of RU Holmes Engineers, Connor DeMyer, Project Engineer of Environmental Design Partnership, LLP, Dylan Menke, Pat Hintze, Lindsey and Don Smith, Donna Wotton, Seddon Beaty, Luann Fritzky, Pat Hintze, Joe Tinnirella, Denise Gugumuck, Mike Auerbach, Mike Kent, and some unnamed others. There were 10 - 15 attendees via ZOOM.

Motions were made, seconded, and carried unanimously to set public hearings:

- For the Short-Term Rental Local Law on June 13th at 6 pm.
- For wastewater system variances for David and Judith Polley at 8 Martins Lane - Tax Map #12.14-1-7 on June 11th at 6 pm.
- For wastewater system variances for Katherine and Stephen Engle at 9582 Lake Shore Drive - Tax map #12.18-1-13 on June 11th at 6 pm.

#### **PUBLIC HEARINGS:**

Holmes explained the six wastewater variance applications for Hallie and Alan Cornell at 9651 Lakeshore Drive, Tax Map #12.14-1-21. Cedarwood Engineering reviewed and responded to the application; the board has reviewed its suggestions. Holmes said it's an improvement and the upgrades will be in the same location as the current system.

A motion was made, seconded, and carried unanimously to open the public hearing for wastewater treatment system variances for Hallie and Alan Cornell at 9651 Lake Shore Drive Tax map #12.14-1-21.

Nobody spoke for or against the application. A motion was made, seconded, and carried unanimously to close the public hearing. A motion was made, seconded, and carried (4-1) (Fitzgerald abstained) to approve the application.

DeMyer reviewed two requested variances for the Turn Auerbach Way LLC property at 7947 Lakeshore Drive, Tax map #93.12-1-28. Cedarwood reviewed and responded to the application in a letter dated May 10th. A motion was made, seconded, and carried unanimously to open the public hearing for wastewater treatment system variances for Auerbach. Auerbach spoke in favor, stating that the system would be an upgrade that would protect the lake. Discussion ensued. Patchett asked if the use of a poly-lined membrane would be cost effective and if additional sloping would address concerns. DeMyer answered, "Yes." A motion was made, seconded, and carried unanimously to close the public hearing. A motion was made, seconded, and carried unanimously to approve the Auerbach application, with the conditions that a poly-lined

membrane and additional sloping be added and with the conditions stated in Cedarwood's letter.

#### WELCOME GUESTS/PRIVILEGE OF THE FLOOR

Discussion included:

- Whether the Lake George Park Commission (LGPC) will re-inspect new septic systems once homeowners have made upgrades.
- Concerns about tax increases and the amount that the Town of Hague residents pay for school taxes. Bast reminded the group that there is a committee to address the school taxes and that the minutes for its meetings can be found on the town's web page. Attendees stated it is important to attend school board meetings and to vote during elections. Donna Wotton is running for the Ticonderoga School Board. Voting is on May 21st.
- Whether the town board could put Wi-Fi at the visitor center for safety purposes.

#### **REGULAR COMMITTEE REPORTS:**

**Highway (Dunklee):** The department has been repairing roads and culverts.

**Museum and Historian (Ramant):** The Hague Historical Society is upgrading its records and the museum.

**Personnel (Bast):** Some personnel issues will be addressed during New Business.

**Planning/Zoning/Storm Water (Cherubini):** The board has received and reviewed the ZEO report.

**Recreation and Promotion and Youth (Fitzgerald):** The community should get its children signed up for Silver Camp at Silver Bay YMCA.

**Sewer District # 1 & 2 (Bast):** The compressor for the wastewater treatment plant is still working and the new compressor should arrive any day.

**Town Park and Beautification (Ramant):** The visitor center lights are all working and National Grid is fixing the remaining street lights. The boat launch will open Friday, May 17th, the visitors' center will open June 22nd, and life guards will be on duty starting June 28th. All food trucks have been scheduled for the summer and the fireworks will be on July 3rd.

**Environmental Concerns (Ramant):** The herbicide ProcellaCOR is still being considered for use in Lake George. Go to lakegeorgeassociation.org and follow the instructions how to write a letter to the Lake George Park Commission (LGPC) to express your concerns about the use of this dangerous treatment. Knotweed funding and removal continues.

**Technology and Communications Committee** (**Patchett**): The Email database is working and growing. Thanks to Amanda Peterson for helping the program succeed.

The town has received a \$25,000 grant, with a required \$5,000 matching amount from the town.

## TOWN BOARD, CONTINUED

The grant has been approved for the comprehensive plan for the town. Patchett would like to look into using some of this money to do upgrades to the visitors' center. Additional paperwork still needs to be completed. Thanks to Desirée LaPointe for her work on this.

#### **COMMUNICATIONS AND PETITIONS:**

Patchett reminded Hague citizens to vote for the school budget and school board candidates on May 21st and that the Hague Memorial Day Parade and Celebration will be on May 25th. He thanked Cherubini and LaPointe for all their work on the parade. There is still room for floats or marchers; contact Desirée at 518-543-6161 if interested.

## **TI-ALLIANCE UPDATE, CONTINUED**

The Gap Fund is a dedicated "bucket" that Ti-Alliance can draw from to support school trips, enrichment programs, individual student opportunities, classroom enhancements, and dream making. These experiences are life-changing to students. Some examples are:

1. A Ticonderoga student has been accepted to Dartmouth College's high school pre-med summer camp. It's a competitive program but she's at the top of her class and highly motivated. She's working to fund it through her after school and weekend work and her side business baking for events. She needs \$8,000.

2. There is an opportunity for a Ticonderoga student to have a full scholarship to Vanderbilt in Nashville. Vanderbilt alums in Ti are willing to take the top two students in the Ti High School Junior Class to do a college tour there, but neither of the students can pay for the trip. They need \$2,000.

3. Our school system offers bridge and AP courses to students. (Bridge courses let students earn transferable college credits during high school. AP classes let students take an exam for a potentially-transferable college credit.) They are less expensive than college courses and often allow students to enter college with a semester or two under their belts, but many families cannot afford the upfront fees of \$100 per course.

On August 6, 2019, Governor Cuomo signed Brianna's Law. The law is named after Brianna Lieneck, an 11-year-old Long Island girl who was killed in a tragic 2005 boating accident

Brianna's Law requires power boaters (including those operating sailing vessels with auxiliary power) to complete a boat safety course.

The law has been phased in since 2019. Anyone born on or after January 1, 1978 needed a certificate beginning in January 2024.

ALL operators of motorized boats and personal watercraft regardless of age, MUST have a certificate by 2025. NYS recognizes boat safety certificates issued by other states.

## **LOOKING BACK**

#### THE TICONDEROGA DAM

This first section of this article *(in italics)* was written in 1974 and was discovered in the archives of the Hague Historical Society.

An event of historical significance took place earlier this month when the International Paper Company (IPC) deeded the dam at the head (NOTE: Actually, because Lake George flows from south to north, Lake George Village is technically the "head" of Lake George and the outlet is in Ticonderoga) of Lake George to the State of New York. With the dam, the paper company also conveyed seven acres of land and presented the state with a check for \$150,000 for use in reconstructing the dam, removing the buildings, and grading.

The level of Lake George is about 220 feet above the level of Lake Champlain. Water descends from the head (See note in

paragraph above) of Lake George through what the French called "La Chute," but which is now known as "Ticonderoga Creek," a distance of about 3 ½ miles to Lake Champlain. Obviously, a great source of power, grist mills and lumber mills were constructed along its course as early as 1800 - 1810.

To regulate the flow of water, a dam was constructed about 160 years ago. This was replaced by the present dam and locks, which were built in 1900 by IPC, which had acquired title to the five pulp and paper mills located at the head of the falls. In 1925, IPC gained complete control of the water when it purchased the three mills at the lower falls.

The dam was so constructed that the level of Lake George rose to about a foot above its natural level. The people on the lake wanted the

paper company to maintain this level and, after considerable litigation, IPC, by law, was assigned the responsibility of maintaining the level between 2.5 and 4 feet on the Rogers Rock gauge between (unreadable) 1st and October 1st.

With the abandonment of the old mill several years ago, IPC has no interest in the water power and has sought to be relieved of its responsibility. The state acquiesced and the turning over of the dam and the properties places the responsibility on the (NY State) Department of Environmental Conservation. At the presentation ceremonies, Albert Oetken, a vice president of IPC, said that if the dam were to be removed, the lake level would be lowered considerably, the shoreline would be altered, and there would be new hazards to boating from rocks and even islands, which would rise above the surface. He also pointed out that by maintaining a constant level, dock owners are not inconvenienced by wide variations in water levels. Their docks are neither flooded nor made unapproachable.

On a visit to the area the other day, we were amazed at the tremendous volume of water rushing over the dam. It is inconceivable that, in these days of energy shortages, the power generated by this water performs no useful function.

#### UPDATE 2024 (50 years later)

Lake George is a natural lake with an approximately 233-square-mile watershed. Precipitation results in surface water, runoff, or groundwater flows. The condition of the watershed's soil (frozen to unfrozen, dry to saturated), the level of intermittent lakes, ponds, and

> wetlands in the watershed, as well as the state of trees and vegetation, all affect the amount of runoff. Excessive precipitation and runoff can cause the lake to rise occasionally to undesirable levels. Lower than desired lake levels can also be caused by persistent dry weather and evaporation. During such periods, especially late summer and fall, evaporation from the surface of the lake can exceed the incoming water and the lake level falls.

During such conditions, the discharge gates of the dam are closed and the lake water may not be used for power generation. The hydroelectric facility is located at the base of the lower falls and is owned by Patriot Hydro Power of Manchester, NH. They provide the power generated by the water to the local electric grid.

The dam is, in all probability, promoting the continued health of our "Queen of American Lakes" by controlling the level of the lake.

We hope everyone will respect and enjoy this beautiful jewel in a clean, proactive way. If you see something that harms our "Queen," say something, do something. Teach the love of nature and all it has to offer so that the lake will still be healthy and viable for generations to come.
