### **HAGUE SCHOOL ADVISORY COMMITTEE**

Hague's two requests for the Ticonderoga CSD School Board of Education (BOE) regarding the apportionment of the 2024-2025 school tax levy between Ticonderoga and Hague have been rejected.

In a surprise meeting on June 27, 2024, the BOE voted down the requests to incorporate multi-year assessment averaging (MYAA) and to include the full value of multiple energy projects underway in Ticonderoga.

As noted in the July issue of *The Hague Chronicle*, Hague planned to deliver a statement by Supervisor Patchett at the July 9th BOE Meeting. The statement sought collaboration between the two towns, emphasizing that MYAA benefits both and that including energy projects is more equitable and has precedence in Ticonderoga. Both methodologies are within NYS Tax Law-authorized BOE jurisdiction.

However, the July 9th BOE meeting, initially reported to be "a very long meeting," ended early. Jack Bast, attending in place of Josh Patchett (who was at Hague's Town Board Meeting), was unable to present the planned Hague statement. Jack reported that three loyal, interested Hague residents attended that meeting – Lari Dhein, Linda Toner, and Annette Wells.

SAC has now reached out to meet with Superintendent Scott Nephew, instead of addressing the entire BOE. SAC encourages Hague residents to attend the August 20th BOE meeting, where the final apportionment of the 2024-2025 school tax levy will be voted on.

Linda Fusco and Beth Barton-Navitsky represented SAC at the Rural Schools Association of NYS (RSA) "The Miracle of Rural Education" Summer Conference held from July 14-16, 2024, at the Olympic Village Conference Center in Lake Placid. RSA represents all rural schools in NYS, including Ticonderoga CSD. The RSA conferences provide a meeting place for school board members and superintendents to collaborate on the many issues facing rural schools.

Linda and Beth, based on their extensive education credentials, are both RSA members for SAC and are developing important insights and contacts to advance SAC objectives. Donna Wotton, Hague's representative on the Ti BOE, is also an RSA member through her Board of Cooperative Educational Services (BOCES) assignment.

## MONITORING THE EFFECTS OF PROCELLACOR

As reported in our July issue, the Lake George Park Commission put ProcellaCOR, a chemical herbicide, into two bays across the lake from Hague in the early morning hours of June 29, 2024, despite objections from all four towns in the north basin (including Hague) and more than 5,000 people. The locations were Blairs Bay in Glenburnie and Sheep Meadow Bay in Huletts Landing, both of which are within the jurisdiction of Hague.

The Lake George Association (LGA) is collaborating with its partners at The Jefferson Project to thoroughly monitor the water and ecosystem in these two bays. Water, plant, and soil samples are being analyzed in an independent lab at the University of Connecticut. The LGA plans to release initial results in early August. # HEMLOCK COALITION FORMED

Nine environmental groups and state agencies have joined together under the Lake George Hemlock Coalition umbrella to protect hemlock trees in the Lake George basin from hemlock woolly adelgid (HWA), an invasive insect.

In a matter of years, the destructive bug could destroy the hemlock forests that are integral to Lake George water quality. The coalition received a \$108,000 grant from the Lake Champlain Basin Program to develop a comprehensive approach to protect the trees. Click HERE to learn more.


# JUDY STOCK RETIRES FROM THE HAGUE CHRONICLE

June was a busy month for the Hague Volunteer Fire Department (HVFD). We did four drills, helped EMS four times, and responded to eight fire calls, totaling 214 fire volunteer hours. The EMS team had 12 calls and two drills, adding up to 116 hours, for a grand total of 330 hours.

Chief David Snow and I met with LifeNet of NY, a critical care flight team, and we're happy to have two new landing zones in Hague. We will have training to review air methods and set up procedures for these new zones.

We've had a great response to calls and we want you to know we're here for you.

It's very important to follow boat safety rules, including wearing a life vest properly. We've had too many calls about people in trouble while kayaking or boating because they weren't using life vests. Time is critical in emergencies, so please stay safe with your family and friends.

### **BITES AT THE BAY**

Bites at the Bay is a restaurant-style takeout service at Silver Bay YMCA that allows boaters to place their orders online and continue to enjoy the lake as they wait for their food to be prepared. Word has it that we might see some relics that were owned by Colonel Mann and perhaps even an item or two from the legendary Cave. You never know what will turn up!


Even if you don't have an item to share, come spend the evening with us, see some Hague history, and hear the stories.

### **ZONING BOARD OF APPEALS - 6/27/2024**

Present were Chairman Robert Goetsch, Linda Mury, Chris Navitsky, and Jon Hanna. Also present were Zoning Enforcement Officer (ZEO) Ed Kirchberger, Recording Secretary Kathy Santaniello, Chris Navitsky, and Peter Mitchell.

#### **PUBLIC HEARING:**

### MITCHELL (Continued) (60.17-1-17) 30-32 Oneida Drive (TR1-R) VAR 06-24 & VAR 07-24

The owners of this property would like to subdivide a 1.6-acre lot into two parcels. Lot #1 is proposed to be 0.66 of an acre and Lot #2 is proposed to be 0.50 of an acre. Lot #1 is proposed to have 63 feet of shoreline and Lot #2 would have 112 feet of shoreline.

### Zoning Issues:160-24 A, Acreage, and 160-50 B (c) [1] Shoreline width

Mitchell summarized the status of the project. His neighbors immediately to the north and south of this property have no objections to this project and the APA sent a letter to Kirchberger stating that it would be up to the ZEO and the ZBA to determine if a shoreline lot width variance would be needed as no further development was planned at this time. No one spoke against the proposal and no letters were received. Motion made, seconded, and passed unanimously to close the public hearing.

#### **OLD BUSINESS:**

### MITCHELL (60.17-1-17) 30-32 Oneida Drive (TR1-R) VAR 06-24 & VAR 07-24

The owners of this property would like to subdivide a 1.6-acre lot into two parcels. Lot #1 is proposed to be 0.66 of an acre and Lot #2 is proposed to be 0.50 of an acre. Lot #1 is proposed to have 63 feet of shoreline and Lot #2 would have 112 feet of shoreline.

### Zoning Issues:160-24 A Acreage, & 160-50 B (c) [1] Shoreline width

Kirchberger says he will leave the "gray area" decision to the ZBA as to whether a shoreline lot width variance would be required. Navitsky asked Mitchell if there had been any progress with obtaining additional shoreline acreage from the boat club to the south of his property. Mitchell said they might approach them again, depending on the outcome of this meeting. Goetsch favored requiring both variances, with conditions. Navitsky asked about the need for septic easements, as both houses presently share a common septic system.

Motion made, seconded, and unanimously in favor to grant Variance 06-24, the area variance.

Navitsky recommended including the following conditions:

- 1. That there be no further additions or increase in floor space to either existing structure with this subdivision.
- 2. There will be a septic easement created for the Highlander wastewater to be treated on the Scottage

property, and such easement will remain with the property.

Motion made, seconded, and passed unanimously to grant the shoreline width variance request 07-24.

Navitsky recommended the following conditions:

- 1. There will be no future expansion or increase in floor space to the existing structures on either property.
- 2. There will be a septic easement created for the Highlander for their wastewater to be treated on the Scottage property, and such easement will remain with the property.

#### **NEW BUSINESS:**

### 1. CUNNINGHAM (OXFORD COTTAGES) (76.20-1-32) 4 Silver Bay Road

The applicants are requesting an after-the-fact variance for a small shed attached to the cottage to house the water system. (Water tank, hot water heater, and sediment and UV filters)

### Zoning Issue:160-50 B, (b) Shoreline setback.

Navitsky and Kirchberger discussed the neighbor's foundation, the fact that it's an after-the-fact situation, the need for a retaining wall, and a stop-work order. A motion was made, seconded and passed 4-0 to deem this application complete, to put the project on the agenda for next month, and to wait to see if more information comes in requiring other variances required for this property.

### 2. ENGLER (43.5-1-26) 9077 Lakeshore Drive (HP) VAR 08-24, (SP) 04-24

Replacement of existing retail single-story building with new two-story mixed-use building with retail on bottom and residence above.

Zoning Issues:160-20A Front yard setback & 160-65 Continuation of non-conforming structure, 25% increase

The question was raised as to whether this application has been significantly changed from other times the applicant has previously presented to the ZBA for this property. Kirchberger said there are only minor changes. A motion was made, seconded, and passed 4-0 to deem the application incomplete and table the project.

### 3. HARRISON (26.17-2-42.121, 9110 Lakeshore Drive (HP) VAR 11-24

Retaining wall over four feet high. They previously gained after-the-fact permission, but they still require a variance due to the height of the fence.

### Zoning Issue:160-52 B, Wall over four feet erected

Water seems to be running through the wall. A motion was made, seconded, and passed 4-0 to deem the application incomplete and table the project.

Additional information required should include wall construction details, an engineer's stamp for the wall (as it is over four feet), and where the property lines are located in relation to the wall placement.

### **TOWN BOARD - 7/9/2024**

Supervisor Joshua Patchett and Board Members Maureen Cherubini and Chris Richards were present. Board Member Jack Bast joined via ZOOM and Martin Fitzgerald was absent. Also in attendance were Highway Superintendent Chad Dunklee, ZOOM Coordinator Tim Fiallo, Bennet Driscoll from Catholic Charities of Warren County, Tracey Clothier, Assessor Dave Martucci, and 21 other community members.

#### WELCOME GUESTS/PRIVILEGE OF THE FLOOR

Patchett introduced Driscoll, who discussed the Supplemental Nutrition Assistance Program (SNAP). Driscoll highlighted the assistance available to eligible households and offered support for the application process.

Clothier then presented on the Local Waterfront Revitalization Program (LWRP) and grant opportunities. She explained that the LWRP addresses shoreline erosion, flooding, water quality, and downtown revitalization. Clothier also discussed potential grants from the Office of Parks, Recreation, and Historic Preservation (OPRHP) and the New York State Department of State (NYSDOS) to help fund the improvement of the Town of Hague Visitors' Center and other projects.

### **PUBLIC HEARING AND APPROVALS**

A public hearing for wastewater system variances for Peter and Melba Tacy at 9588 Lake Shore Drive was set for August 13, 2024. The board approved the minutes from June 11, 2024, and authorized payments totaling \$184,909.21 across multiple funds.

#### **COMMITTEE REPORTS**

**Administrative:** Martucci briefed the board on pending litigation involving a property assessment dispute.

**Buildings and Grounds:** The fish weir bridge has been restored. The community center has seen landscaping and exterior lighting improvements, enhancing aesthetics and safety. Future upgrades to the heating system are being considered to improve energy efficiency and climate control.

**Highway:** Dunklee discussed the need for a new town truck and the completion of road improvements on Yaw Road, Hollow Road, and Fitzgerald Road.

**Museum and Historian:** The Hague Historical Society will exhibit on the history of the town's outboard races this summer.

**Personnel:** The Personnel Committee is reviewing job descriptions for community center employees.

**Planning/Zoning:** The ZEO report was reviewed by the board.

**Recreation and Promotion:** Children at Silver Camp are enjoying their activities.

**Sewer Districts:** Cherubini announced the delivery of a crucial Sludge Tank Compressor.

**Environmental Concerns:** Knotweed control will begin the week of July 15th.

**Technology and Communications:** The town's e-mail database is expanding.

**School Advisory:** Bast reported on the Board of Education's rejection of Hague's tax levy requests.

### **RESOLUTIONS**

The board passed resolutions to apply for grant funding for the development of the Town of Hague Community Welcome Center and the preparation of a Local Waterfront Revitalization Program (LWRP). Additionally, it approved payments to Clothier for grant preparation and budget amendments for the purchase of a new lawn tractor.

### **OTHER BUSINESS**

A special town board meeting was scheduled for July 16th to discuss the purchase of a new highway truck and potential litigation.

The Sewer Advisory Committee will meet on August 8th.

Present were Chairman Pam Peterson, Sandra Powell, Edna Frasier, Judy Gourley, and Meg Haskell. Also present were Zoning Enforcement Officer (ZEO) Ed Kirchberger and Recording Secretary Kathy Santaniello.

#### SUBDIVISIONS:

### Mitchell (60.17-1-17) 30-32 Oneida Drive (TR1-R) VAR 06-24 VAR 07-24

The owners propose subdividing a 1.6-acre lot into two parcels. Lot #1 is proposed to be 0.66 acre with 63 feet of shoreline, and Lot #2 is proposed to be 0.50 acre with 112 feet of shoreline. A public hearing has been set for August 1st.

### REFERRAL TO THE ZONING BOARD OF APPEALS (ZBA):

### Oxford Cottages (Cunningham) (76.20-1-32) 4 Silver Bay Road

The applicants are requesting an after-the-fact variance for a small shed attached to the cottage to house the water system. The ZBA had accepted the application but tabled the project for further review.

### **OLD BUSINESS:**

### Mitchell (60.17-1-17) 30-32 Oneida Drive (TR1-R) VAR 06-24 VAR 07-24

The ZEO reported that the two variances had been approved with conditions by the ZBA. The Planning Board set a date for a public hearing for the subdivision on August 1st.

#### **NEW BUSINESS:**

### Smith (43.5-1-32) 9104 Lakeshore Drive

The applicant seeks to replace an existing lawful nonconforming single-family residence with a new structure, improving side and frontline setbacks. A site visit was scheduled for July 24, 2024, at 3 pm.

### **CANADIAN FUNDRAISERS STOP IN HAGUE**


Early on the afternoon of Tuesday, July 16, 2024, at the fervent request of our five-year-old grandson, my husband and I stopped at the Hague Park and Beach on our way home. While our grandson was making a beeline for the swings (which all of us who grew up in Hague have enjoyed over the years), I spied an unusual "vehicle" pulling into the parking lot. It was a gentleman skating on rollerblades pushing another gentleman in a wheelchair. I strolled over to chat with them.

I discovered they were traveling from Montreal to Times Square in New York City to raise money for Muscular Dystrophy (MD). The gentleman in the wheelchair was François Bernier, 34, who has MD, and the gentleman who was propelling the chair was his friend and caregiver, Jean Philippe DuBois, 32.

They had decided to take a well-deserved break in our beautiful park before they tackled "the wall," the massive climb over Tongue Mountain. I cannot imagine how anyone could push a wheelchair with a man in it over that mountain propelled simply by legs on roller blades! The rig included a custom wheelchair with handlebars and disc brakes

like on a mountain bike. Jean Philippe also had brakes on his rollerblades.

Jean Philippe explained that he had relatives as well as friends with MD, so the need for research and equipment touched his heart and he wanted to do something to help. He and François, along with Jean Philippe's father, Guy DuBois, who drove their support car, decided to set a goal of traveling the 600 km (372.82 miles) from Montreal to NYC in ten days, averaging 60 km (37.28 miles) per day and hoping to raise \$20,000 (Canadian) in the process. They left



Montreal on Saturday, July 13th and, as of our meeting, had raised \$11,000. When asked who was donating to the cause, they said it was some people from home and many people who had seen them on their journey and had clicked on their QR code to donate.

They planned to travel mainly on Route 9N and expected to reach Times Square on July 22nd. When asked what they expect to happen then, François joyfully said, "We're going to celebrate in a manner to be determined...but there WILL be red wine!" 🔳

### **LOOKING BACK**

The Hague Historical Society held its regular monthly meeting at the Hague Baptist Church Annex on February 20, 1974.

After a brief business meeting, the program was turned over to Clifton West, who outlined the history of West Hague School District #3 from old account books which he had uncovered. Mr. West and a number of those present had attended school in the district and there were many humorous anecdotes to relate.

Apparently, a school district was created whenever there was an apparent number of children, about 30, to fill a one-room schoolhouse. West Hague District #3 came into being in 1812

and covered the geographic area between the West Hague Road and Route 8 and from the road on which the Sanitary Landfill is now located down to a line drawn from the Mays' home on Route 8 to the Leon Wells home on West Hague Road. The first trustees were John Holman, John Hafford, and William Cook, many of whose descendants continue to live in the area. The first record of state aid for education was in 1870 when \$70 was allocated to the district. The records indicate that the assessed valuation of the property in the district in 1889 was \$15,775, an indication that property taxes were now being levied to pay for education.

Generally, there were two terms, one in the winter and one in the summer. In between terms children were needed for work on the farm. In 1900, \$320 was paid in [a] teacher's salary for the entire year.


The eight school districts in the Town of Hague were consolidated into the present central school district in 1926-1928, when the present school building was constructed.

### 2024 Update - 50 years later

In 1979, Hague Central School was annexed to Ticonderoga Central School District. Many argued that

consolidation to the TCSD to the north would reduce taxes in the town of Hague. Ironically, the same segment of seasonal residents that originally pushed for consolidation are now protesting that Hague is taxed disproportionately. (WIKIPEDIA)

Hague taxpayers are now liable for over 50% of the school taxes for the Ticonderoga School District.



Final assessed value Ticonderoga – \$919,076,649 – uniform 100%.

Final assessed value Hague – \$1,048,887,733 – uniform 97.5%.

School Taxable assessed valuation – Ticonderoga – \$750,164,379.

School Taxable assessed valuation – Hague – \$989,984,752.

Having or not having children is not a viable argument when school taxes are questioned as NYS laws determine school taxes. Hague's population is showing a declining trend since 2010. There were 896 residents

in 2008; 632 residents in 2022 and approximately 528 residents in 2024. We are losing the youth quickly and that is sad. But, that fact will not help us as it pertains to taxes.

New Hampshire raises 60% of their school funding on property taxes, Vermont, very little, and Hawaii none!

NYS touts the "lottery monies" as being used toward funding education as aid. Since 1967, the NYS Lottery has earned \$78.7 billion and has funneled over \$64 billion into helping K-12 public education. Since the "Lottery" is a government body and the prizes are public funds, the NY Constitution requires that all net proceeds from games go towards the support of schools. Yet, for every \$1 spent on the lottery, only approximately 34 cents go toward education. (nylottery.org)

The Hague School Advisory Committee (SAC) is attempting to convince the Ticonderoga School Board

of Education to use Multi-Year Assessment Averaging (MYAA) to correct the tax levy to benefit both towns. You can study their course of action on the "townofhague.org" website under "Committees."

We believe most of us who attended Hague Central School and remember the community spirit and happier times are thankful we have those days embedded in our hearts.
