A LETTER FROM JOSHUA PATCHETT, SUPERVISOR, TOWN OF HAGUE

Ticonderoga Central School District – Board of Education
August 20, 2024 Meeting

Mr. Russell (Editor's note: Russell is the president of the BOE), in 1979 our Hague school district was merged with Ticonderoga's. The changes in our relative situations over the past 45 years and, in particular, our interactions this past year with the Board of Education, have made it clear that it is now warranted to revisit that arrangement.



Throughout the past year Hague has sought your cooperation and collaboration to review the particulars of that arrangement ... and the effects that that arrangement has had on your constituents in both communities. Hague has twice supported an initiative to study the benefits of Multi-Year Assessment Averaging (MYAA), and a retrospective analysis shows both communities would benefit equally from the use of MYAA. New York State Real Property Tax Law, in fact, provides the Board of Education with the authority to implement MYAA. Yet you have repeatedly rejected our request to cooperate in a detailed study of the factors that drive volatility in assessments and the benefits of MYAA in dampening that volatility.

Until the COVID years, you routinely held Board of Education meetings in Hague and provided an information session on the proposed school budget. This year, our request for a Budget Review in Hague was met with your refusal to attend any meeting "outside the High School building."

More recently, we have taken note of the boom in energy projects in Ticonderoga. Over the next three years, projects are scheduled to be completed with an estimated value in the range of \$150 million dollars. You have entered Payment In Lieu of Taxes (i.e., PILOT) Agreements with each of these projects that avoid full payment of school taxes for the life of the project. In spite of the impact on school taxes, Hague was not a party to any of these PILOT agreements. And, your constituents in Hague do not benefit in these PILOT Agreements to the extent that your constituents in Ticonderoga do. PILOT payments reduce the Essex County, the Ticonderoga Town, and the school taxes for Ticonderoga taxpayers. Ticonderoga also, of course, experiences significant direct economic benefits from these energy projects.

Including Hague, since we are the major contributor to school taxes, in the PILOT negotiations would have provided Hague taxpayers at least some consideration and possibly even benefit. Subsequently, at least including the full value of these projects in the school tax levy apportionment would be a balanced, fair and equitable method. New York State Real Property Tax Law, in fact, provides the Board of Education with the very authority to include the full value of these projects in the school tax levy apportionment calculation.

Furthermore, the Board of Education has, in fact, set this exact precedence for such methodology by including Sylvamo Waste Treatment property in current calculations.

LAKE GEORGE OPEN WATER SWIM (LGOWS)

The 14th Annual Lake George 2.5k, 5k, 10k Swims took place on Saturday, August 17, 2024, from 7:45 am - 12 pm. The air temperature was 72 degrees and the water temperature was 75 degrees.

JOSHUA PATCHETT LETTER, CONTINUED

The Town of Hague transparently enacted a resolution of support for the inclusion by the Board of Education of the new energy projects in this year's school tax levy apportionment calculation. In a little noticed, off-schedule meeting, without any mention of acting on Hague's request on the agenda, you summarily denied both our energy and our MYAA requests. Then, under the guise of New Business, the Board further committed to never treat Hague fairly in this respect by ruling that the energy projects would not ever be included in the apportionment process.

Finally, on July 9th you directed our Hague representatives to meet with the School District Superintendent instead of with the Board of Education. Our attempt to do so has not yet been met, and the final school tax levy is now set.

Mr. Russell and School Board Members, your constituents in Hague seek your cooperation and collaboration in a mutual effort to revisit the existing Ticonderoga Central School District arrangement in a manner that provides a better education for our students and, of equal importance, achieves a fair and equitable approach to determining school taxes. Thank you for listening. ■

SCHOOL ADVISORY COMMITTEE (SAC) UPDATE

At the direction of Mark Russell, president of the Ticonderoga School Board of Education (BOE), on July 17, 2024, SAC requested a meeting with Superintendent Scott Nephew of the Ticonderoga Central School District (TCSD). The purpose in requesting the meeting was to resolve the impasse we're in with the BOE, which has repeatedly refused Hague recognition, respect, or cooperation regarding apportionment of the school tax levy. For over 20 years, Hague has paid more than 50% of the levy. As of August 20th, Nephew had not yet granted a meeting.

The 2024-2025 school tax levy rates were approved at the BOE meeting on August 20th. Hague's formal requests for consideration of both multi-year assessment averaging (MYAA) and Ti energy project full tax assessment had already been denied in the special June 27th BOE meeting. Hague's 2024-2025 rate is **\$7.6475333**/thousand of assessed value, which corresponds to **56.3%** of the total levy. This tax rate is **2.6%** higher than last year and the apportionment percentage is an increase from last year's **55.9%**.

Supervisor Josh Patchett, several SAC members, and a host of Hague residents attended the August 20th BOE meeting. Patchett presented a strong Hague statement expressing our concern about the ongoing lack of cooperation and collaboration with Hague being evidenced by the BOE. Patchett emphasized that it is now warranted to revisit the school tax apportionment arrangement that has existed since our School District merger 45 years ago. We were again rebuffed by the chair of the BOE Meeting.

The Hague School Advisory Committee has now been working for one year. Regrettably, we have not yet made any progress in changing our tax apportionment. But, we've learned a lot about the process and we understand much better why the three previous attempts were not successful. And, we now have a Hague resident on the BOE in Donna Wotton – thank you Donna!!!

SAC is not going away! We are continuing our efforts. ▣

SECOND ANNUAL ANTIQUE AND CLASSIC BOAT SHOW HELD IN HAGUE

The Antique and Classic Boat Society (ACBS), founded on Lake George 50 years ago, hosted its Second Annual Hague Show on Friday, August 23, 2024. It was a run up to the main show, which is held annually on the Saturday before Labor Day weekend in Lake George Village. The sight of the gleaming and polished mahogany hulls, the unmistakable low rumble of the engines starting up, and even the smell of the gasoline is an amazing sensory experience for young and old.

Eighteen boats from around the north basin were on display in the town launch slip as well as on trailers in the parking lot, delighting the constant stream of visitors who came to the town park that morning.

ZONING BOARD OF APPEALS - 7/25/2024

Present were Chairman Robert Goetsch, Linda Mury, Chris Navitsky, Jon Hanna, and Tina Barth-King. Also present were ZEO Ed Kirchberger and Recording Secretary Kathy Santaniello.

OLD BUSINESS:

CUNNINGHAM (OXFORD COTTAGE) (76.20-1-32) 4 Silver Bay Road

The applicants are requesting a variance after-the-fact for a small shed attached to the cottage to house the water system. (Water tank, hot water heater and sediment and UV filters)

Zoning Issue: 160-50 B (b) Shoreline setback

Discussion included concerns about other additional zoning issues involving the property, but Kirchberger and Goetsch felt the board should only be dealing with the issue involving the shed addition to the cottage. King asked that more dimensions involving the cottage and shed addition be provided by the applicants, including original and new footprints. After further discussion, a motion was carried 5-0 to schedule a public hearing on this project for the next ZBA meeting in August.

NEW BUSINESS:

1. CUNNINGHAM (OXFORD COTTAGE) (76.20-1-32, 4 Silver Bay Road

Counsel for the property owner is seeking to overturn and vacate a stop-work order issued on June 6, 2024 by Kirchberger regarding failure to make known the circumstances created by their excavation as discovered by Kirchberger and various ZBA and planning board members on their site visit.

Goetsch asked Kirchberger to explain the stop-work order issue, which entailed the failure of the applicants to notify the town of a potentially dangerous situation resulting from their excavation near the adjacent southern property owners' property line and foundation. Kirchberger chose to issue a stop-work order based on Section 160-90 of the code, which would allow the applicants to retain their present application, propose solutions to the problems, and possibly continue on with their construction without starting over with a new application. Kirchberger asked for support from the ZBA for the justification of his reasoning behind the issuance of the stop-work order. Kirchberger does not think the applicants have offered any solutions to the problem. Additionally, he thinks that a public hearing would be the next step in the process. Navitsky asked for more information regarding the approved plans for the project. After further discussion, a motion carried 5-0 to schedule a public hearing for this project for the next ZBA meeting.

2. ENGLER (43.5-1-26) 9077 Lakeshore Drive, (HP) VAR 08-24, (SP) 04-24.

The applicant is asking to replace an existing retail single story building with a new two-story mixed-use building with retail on bottom and a residence above.

Zoning Issues: 160-20A Front yard setback, 160-65 Continuation of non-forming structure, 25% increase.

Kirchberger felt there were some significant changes made from the original plan, which had been denied in 2021. A motion to schedule a public hearing on this project for the next ZBA meeting was carried 4-1 (King).

3. HARRISON (26.17-2-42.121) 9110 Lakeshore Drive (HP) VAR 11-24

Retaining wall over four feet high. Previously gained development after-the-fact, but still requires a variance due to height.

Zoning Issue: 160-52 B Wall over four feet erected.

Kirchberger reported that he spoke with the applicant, who will obtain a report from an engineer who will address the problems with the wall to resolve all the issues in question. The motion to table this project until next month's meeting carried 5-0.

4. SMITH (43.5-1-32) 9104 LAKESHORE DRIVE

The applicant wants to replace an existing lawful non-conforming single family residence structure which contains a conforming use.

Zoning Issues: 160-50 B (b) Expansion within shoreline setback. 160-20 A Expansion within front line setback 12.18-1-11

Kirchberger reported that a site visit had been done with the planning board members on 7-24-2024, during which time several concerns with the project were brought up. Kirchberger has been in touch with Erik Sandblom of SRA Engineers and he will be working on bringing additional information/options to the planning and ZBA boards to help resolve the concerns stemming from the site visit. A sketch plan review will be done with the planning board. After discussion, a motion to table this project until more information is available carried 5-0. The applicant thanked Kirchberger and the planning board for visiting the site and for offering guidance going forward.

PLANNING BOARD - 8/1/2024

Present were Chairman Pam Peterson, Sandra Powell, Edna Frasier, Judy Gourley, and Meg Haskell. Also present were ZEO Ed Kirchberger, Recording Secretary Kathy Santaniello, Mr. Smith, and Erik Sandblom of SRA Engineers.

OLD BUSINESS:

1. ENGLER (43.5-1-26) 9077 Lakeshore Drive (HP) VAR 08-24, (SP) 04-24

Replacement of an existing retail single-story building with a new two-story mixed-use building with retail on the bottom and a residence above.

Zoning Issues: 160-20A Front yard setback and 160-65 Continuation of non-conforming structure, 25% increase.

Powell recused herself as she is an immediate neighbor to this property.

Kirchberger reported that the applicant had provided him with some information pertaining to the difference between this application and an old application and this information was included in the board members' packets. Frasier asked about the availability of a DOT report. Engler reported that this was done before the "Made in Hague" store was opened there. Peterson asked that a site visit be scheduled, maybe in conjunction with members of the ZBA. She also asked that the site be marked clearly before the site visit and that the neighbors be notified of the visit. The site visit was scheduled for Monday, August 12, 2024 at 3 pm.

2. SMITH (43.5-1-32) 9104 Lakeshore Drive

The applicant wants to replace an existing lawful non-conforming single-family residence structure which contains a conforming use.

Zoning Issues: 160-50 B (b) Expansion within shoreline setback. 160-20 A Expansion within frontline setback.

A site visit was done on July 24, 2024. Kirchberger reported that Sandblom and the applicant were both present and wanted to get feedback from the board from a sketch plan discussion to take back to modify the proposal to meet requirements after receiving some preliminary feedback from the site visit. They presented an existing and a proposed footprint of the site plan with some modifications of setbacks and areas of non-conformance. Discussion included reducing the total square footage, making the setbacks more conforming, parking, drainage, possibly moving the structure farther back from the road, location of propane tanks, and stormwater runoff. Because the project will likely require variances, the applicant's next steps will involve further consultation with the ZEO and ZBA. Sandblom and the applicant expressed gratitude for the board's input thus far.

TOWN BOARD - 8/13/2024

Present were Supervisor Joshua Patchett and Board Members Martin Fitzgerald and Chris Richards. Jack Bast attended via ZOOM and Maureen Cherubini was absent. Also present were Highway Superintendent Chad Dunklee, ZOOM Coordinator Tim Fiallo, Tracey Clothier, Donna Trudeau, Bob Holmes of RU Holmes, Michael Randall, and 24 community members. There were six attendees via ZOOM.

A moment of silence was observed for Walter Porter, Ray Snyder, and Robert Wotton.

WELCOME GUESTS/PRIVILEGE OF THE FLOOR

Patchett and the board were asked questions about potential upgrades to the Hague Visitor Center.

Community members expressed concerns about the size, included features, the preservation of the beach/picnic area, parking upgrades, funding, and the timing of committee meetings.

Patchett reassured the community that there will be involvement in addressing these questions, stating that the upgrade plans are still in the conception stage. Future committee meeting dates and times will be posted on the town's website.

Randall requested that the board consider placing fencing or a tree line between his property and the highway department. The board will explore options.

GUEST SPEAKERS

Tracy Clothier provided an overview of the town's contract with JMZ Architects/Planners, explaining that the 2020 comprehensive plan, completed by the LA Group, is currently under review. The visitor center is not meeting current needs. Clothier noted:

- Community involvement is planned to discuss needs.
- The size of the future visitor center is currently unknown and will be determined with the architect.
- A cost proposal will be prepared for discussion.
- The architect will present a draft and site plan to the committee.
- These drafts and plans will go before the board.
- The town's portion of the architect's fees is \$5,000, with the balance funded by grants.

Trudeau, representing the Hague Volunteer Fire Department (HVFD), stated that the HVFD will conduct a class for town employees on the operation of the new AEDs at the community and visitor centers. She also mentioned the need for volunteers, inviting community members to join the HVFD. Interested individuals can contact the HVFD at 518-543-6059.

Holmes provided a brief overview of the need for the requested variance for a holding tank on the property. A motion was carried to set a public hearing on waste water variances for Sally Markert at 9685 Lakeshore Drive, Hague, on September 10th at 6 pm at the Hague Community Center.

Waste Water Variances: A motion was carried to approve waste water variances for Peter and Melba Tacy at 9588 Lakeshore Drive, Hague.

REGULAR COMMITTEE REPORTS

Buildings and Grounds/Community Center/

Enhancement: Two bids have been received for staining two sides of the community center building.

Highway: The department has been busy with ditch and tree work. A proposal was made for a new plow blade and poly spreader for consideration at next month's meeting.

Personnel: The reorganization of the community center staff is complete. Donna Clarke is now the Front Desk Receptionist/Clerk. On-the-job training for new hires will continue. Diane Trudeau, who served Hague for over

four decades, retired in July, but will continue to serve on the Sewer Advisory Committee. The board expressed gratitude to Diane for her service.

The Personnel Committee has reviewed applications and recommended appointments for the Planning Board and Zoning Board of Appeals (ZBA) alternate positions.

Recreation and Promotion and Youth: Silver Camp's 2024 season will end next week.

Sewer District #1 & #2 There was an annual inspection by NYS DEC at the Wastewater Treatment Plant (WWTP). The official report is pending, but unofficial feedback was positive. The Sewer Advisory Committee approved changes to EDU assignments for vacant lots. Other updates include the arrival of a new WWTP lawnmower, the expected installation of a new air compressor, and ongoing discussions about a new WWTP truck. A building closure and main gate locked policy will be enacted later in this meeting.

Environmental Concerns: The knotweed program is underway.

Technology and Communications: The ZOOM equipment has been upgraded.

School Advisory Committee: Bast reported efforts to meet with the Superintendent of Ticonderoga Central School District to resolve an impasse regarding school tax levy apportionment. Hague residents are urged to

attend the Board of Education meeting on August 20th at 6 pm.

COMMUNICATIONS AND PETITIONS

Hague received a \$15,000 grant from the Glens Falls Foundation. Desiree LaPointe was thanked for her efforts in securing the SWIMS Grant, which will fund lifeguard training, recruitment, and retention.

- Authorize Patchett to sign the contract with JMZ Architects/Planners for \$34,800
- Approve a new open gate policy
- Add Ginger Kuenzel as a member of the Visitor Center Committee
- Approve EDU vacant lot changes
- Authorize Patchett to sign the Met-tel contract, updating equipment
- Approve a new Social Media Policy

Motions were carried to:

- Appoint Henry Friedman as an alternate on the Planning Board, with a term expiring in 2025

Appoint Alane Vogel as an alternate on the Zoning Board of Appeals, with a term expiring in 2027.

Qualified applicants are eligible for up to 50 percent of the total project cost of upgrading their septic systems, with a maximum grant of \$10,000. LOOKING BACK

THE HAGUE ARTS FAIR

The first Hague Arts Fair was held August 4, 1973. The following was reported in the September 1973 issue of *The Hague Chronicle*.

The Hague Arts Fair – A Success?

Was the Hague Arts Fair held on August 4 a success? This is a question that a lot of people have asked.

For those who had wares to sell, it was probably not much of a success. There was little evidence that many items were purchased. The hottest item in this category was the Home Bureau Cookbook of which more than 20 were sold.

But for those who exhibited merely for the thrill of showing off their creations to their fellow townspeople, it was a great success. And for those who came to see the mass of talent that Hague was able to assemble on a hot August afternoon, it was likewise a great thrill.

Should the fair be continued next year, and the year after that? By all means! It is the best way yet for Hague to present itself to the summer tourists and to its own townspeople as a talented and cultured community proud of its residents. Also a real opportunity is given to summer and year round residents to spend a day in mutual admiration of each other.

Credit for proposing the fair in the first instance goes to Mr. [RUDY] Meola, [SR.] who assembled a group in his office early in the year to consider the proposal. However, the group of women...Mrs. Meola, Strumm, [Mrs.] Brock, [Mrs.] Crabbs and [Mrs.] Seerup and the high school students, Sally DeLarm and Mary Samascott, who took the ball and carried it, also deserve credit.

If the Hague Arts Fair is to be continued, we think it requires a sponsoring organization and we can think of no more appropriate organization than the Hague Chamber of Commerce. We urge that it does so.

Update:

The Hague Arts Fair, last recorded in *The Hague Chronicle* as being held in the summer of 2015, was the 43rd one and had been sponsored by the Hague Chamber of Commerce since 1974. The write up in *The Hague Chronicle* in 1973 stated, "more than 25 individuals and organizations had signed up." And, in 1974, "a guess in excess of over 500 persons attended the fair."



For the first eight years, there was no charge to be an exhibitor. In 1981, the chamber decided to charge \$5 for a full day per exhibitor. After ten years of hosting a one-day fair, the chamber extended it to a two-day affair. In 1983, the following quote was published (in an article in *The Hague Chronicle*) – "All items should be hand-made or home-baked. This is NOT a flea market." Also, "For exhibitors, there will be a charge of \$10 for either day or \$15 for the two-day show."

In 1988, the charge went up to \$15 for one day and \$25 for two days. In 1991, the charge for exhibitors went up again to \$20 for one day or \$30 for both days.

From 1973 until 1991, the Hague Arts Fair was held in the park at the town beach. In 1991, the location was moved to the new community center and was held there each year thereafter.

In 1996, the fair name was changed to the Hague Arts and Craft fair. A quote at that time in an article in *The Hague*

Chronicle stated there would be "approximately 50 exhibitors from neighboring counties and states" and that "this fair is now a cross-section of local talent and Adirondack art."

In 2005, the fair was back to its original name, the Hague Arts Fair. In 2005, it reverted to the Hague Arts and Craft Fair. In 2009, there was yet another new name, the Hague Arts Fair

and Farmers Market. In 2010, again and finally, the original name was used.

The Hague Chamber of Commerce merged with the Ticonderoga chamber in 2020. The new name was the Ticonderoga Area Chamber of Commerce (TACC).

There were many people who helped organize and promote the fair through the years and they all deserve a hearty thank you for caring about the town and its people. For those who spent time creating and exhibiting, it was likely a fun (though not always fruitful) way to see new faces and talk to friends, neighbors and strangers with stories of their own.

A "fair" to exhibit home-made, home-baked items stood its ground for a long time. It may be that its demise came due to commercialism or a loss of interest. We both attended and/or exhibited items and are happy we were able to experience the "Hague Arts Fair." ■
