PROCELLACOR PERSISTS IN SEDIMENTS OF LAKE GEORGE

Scientific findings released in late September by the Lake George Association (LGA) raise important questions about the long-term environmental impact of the herbicide florpyrauxifen-benzyl (FPB), which is marketed under the name ProcellaCOR. The chemical, designed to kill the invasive Eurasian water milfoil plant, was applied by the Lake George Park Commission (LGPC) in the waters off Glenburnie and Hulett's Landing in June of 2024.

A research team representing the LGA, Rensselaer Polytechnic Institute (RPI), and Paul Smith's College immediately began sampling water, plants, and sediments in the treated bays.

NEW YORK STATE PROPOSITION 1 (2025)

The **2025 Proposition 1** is a constitutional amendment concerning state forest preserve land in the Adirondacks.

- What it does: The amendment would allow the state
 to use up to 323 acres of the forest preserve, located
 at the Mount Van Hoevenberg Olympic Sports
 Complex in Essex County, to expand winter sports
 facilities. These facilities support events like biathlon
 and Nordic skiing.
- **Mitigation:** To offset this land use, the proposal requires the state to add at least 2,500 acres of new land to the forest preserve.
- Purpose: The amendment is intended to support the Olympic sports presence in New York and is particularly important for the Lake Placid area.

The Hague Chronicle reached out to each of the local candidates running for office, asking each one to submit a 150-word statement about themselves and their goals for Hague along with a headshot photo.

IDENTIFYING, REPORTING, AND CONTROLLING HABS

This is the time of year when Lake George has seen Harmful Algal Blooms (HABs) in the past. The Lake George Association (LGA) asks everyone to keep their eyes out for signs of them and to report them to the LGA so they can follow up.

PLANNING BOARD - 9/4/2025

Present were Chairperson Sandra Powell, Deputy Chairperson Pamela Peterson, and Board Members Alane Vogel and Henry Friedman. Also present were Robert Holmes of RU Holmes Engineers, Zoning Enforcement Officer (ZEO) Ed Kirchberger, and Recording Secretary Kathy Santaniello.

PUBLIC HEARINGS

BAIRD (60.13-1-15), 44 Pudding Lane (TR-1), DEV 11-25, SP 02-25

Zoning Issue: Development within 100 feet of the lake (160-23 C [1][g]).

The applicant sought approval to demolish existing buildings and build a new single-family dwelling. Holmes explained the project, which adds 0.25 acres from a neighboring Dill property to make the lot more compliant. A new wastewater system will be installed and no variances are required. A letter of support from neighbor Jeff Dill was read; no objections were heard.

REGULAR MEETING

SITE VISITS

BAIRD (60.13-1-15), 44 Pudding Lane (TR-1)

Zoning Issue: Development within 100 feet of the lake (160-23 C [1][g]).

A visit on August 21st showed a 0.77-acre lakefront lot with multiple structures. The plan calls for their demolition and building a 2,998-square-foot home and a 1,113-square-foot guest cottage with garage. Discussion covered tree removal, driveway location, and shoreline buffering.

INGREY (60.5-1-14), 31 Pine Cove Road (TR-1)

Zoning Issue: Development within 100 feet of the lake (160-23 C [1][g]).

The applicant plans to replace a one-story house with a conforming two-story home and garage. The new structure meets all setbacks and includes rain gardens to manage stormwater.

GIRARD (42-1-25.2), 107 Dodd Hill Road (TR-2)

Zoning Issue: Accessory structure (160-10 A).

This involves an accessory structure with a bathroom and shower approved by a former ZEO. A variance is required to maintain plumbing. The building has no well or hot water and qualifies as an accessory structure.

OLD BUSINESS

BAIRD (60.13-1-15), 44 Pudding Lane (TR-1)

The board issued a negative SEQR declaration and approved the site plan unanimously with conditions: shed plumbing not reconnected, trees replaced per revised plan, planting plan followed, and Lake George Park Commission (LGPC) approval obtained.

INGREY (60.5-1-14), 31 Pine Cove Road (TR-1)

Approved (3-0-1) (Peterson abstained) with the following conditions: pending LGPC stormwater approval and relocation of one tree.

NEW BUSINESS

BOSCO (26.14-1-5), 28 Friends Point South (TR-1)

Zoning Issue: Development within 100 feet of the lake (160-23 C [1][g]).

The applicant proposed a smaller design with a permeable stone patio and stone steps. After reviewing the lengthy procedural history and the APA's "Lawnmower Rule," the board approved the revised plan (3-0-1) (Powell abstained), citing improved safety, erosion control, and neighbor support.

GIRARD (42-1-25.2), 107 Dodd Hill Road (TR-2)

The application was deemed complete and received a positive referral to the Zoning Board of Appeals (4-0), conditioned that the structure not be used as living space.

BARCASTEDO LLC (SMITH), 19 Waltonian Road (TR-1)

Zoning Issue: *Development within 100 feet of the lake (160-23 C [1][g]).*

The applicant plans to replace a deteriorating timber retaining wall with a boulder wall and new stone steps. A site visit was set for September 8th at 11 am.

ZONING BOARD OF APPEALS - 9/16/2025

SPECIAL MEETING

Present were Chairman Robert Goetsch, Deputy Chairman Chris Richards, and Board Members Tina Barth-King, Chris Navitsky, and Oliver Gourley. Also present were Zoning Enforcement Officer (ZEO) Ed Kirchberger, Recording Secretary Kathy Santaniello, and Alane Vogel.

BOSCO (26.14-1-5), 28 Friends Point South (TR-1), DEV 40-24, SP 09-24, VAR 19-24

Zoning issue: 160-23 C(1)(g) development within 100 feet of the lake; 160-50 B(1)(b) shoreline setback

The applicants are seeking to revise previously approved plans to slightly reduce the project and improve conformity, add a new lakeside stone patio, and replace timber steps with stone steps. The expanded patio would be permeable. Earlier, the project was considered to not require a variance; however, following review of the revised plans, the Adirondack Park Agency (APA) advised that a variance is required because it views the patio as connected to the house and stairs.

ZEO Kirchberger summarized his communications with the APA, noting he does not agree with the APA's interpretation because the patio is not attached to the house and relates to ongoing "natural ground" considerations. To proceed, if a

variance is required, a public hearing must be held before any decision.

After a brief discussion, a motion was made and seconded to deem the application complete and schedule the public hearing for 10-2-25. The motion passed unanimously.

OTHER BUSINESS

ZEO Kirchberger announced there will be no ZBA meeting on 9-25-25. The next ZBA meeting will be 10-2-25 at 5:30 pm, immediately followed by the Planning Board meeting. A public hearing for the Girard project is also scheduled on 10-2-25; materials will be provided to the board.

ZONING BOARD OF APPEALS - 10/2/2025

Present were Chairman Robert Goetsch, Deputy Chairman Chris Richards, and Board Members Tina Barth-King, Chris Navitsky, and Oliver Gourley. Also present were attorney John DuChame, engineer Tony DeFranco, applicant Tom Girard, Zoning Enforcement Officer (ZEO) Ed Kirchberger, and Recording Secretary Kathy Santaniello.

PUBLIC HEARINGS

BOSCO (26.14-1-5), 28 Friends Point South (TR-1), DEV 40-24, SP 09-24, VAR 19-24

Zoning issue: §160-23 C(1)(g) development within one hundred feet of the lake; §160-50 B(1)(b) shoreline setback.

The applicants proposed revising previously approved plans to reduce overall size, construct a new permeable lakeside stone patio, and replace timber steps with stone steps. The Planning Board had issued a positive recommendation with native plantings to strengthen the shoreline buffer and a wall height not to exceed four feet unless another variance is requested. DuChame noted the Planning Board granted site plan approval on September 4, 2025, and he submitted letters of support from the Friends Point Homeowners Association and adjacent owners. DeFranco confirmed the plans matched those reviewed on August 28, 2025; field-verified the closest patio point at approximately 40.4 feet from the lake (previous approval at 38.2 feet); and described stormwater improvements using a permeable surface, berms, swales, and plantings. There were no comments in opposition.

GIRARD (42-1-25.2), 107 Dodd Hill Road (TR-2), DEV 51-21, VAR 03-25

Zoning issue: §160-10 A accessory structure.

An accessory structure was approved with a bathroom on stamped plans; a shower was later added and, per the

applicant, was approved by the former ZEO without a ZBA review. The board noted only the ZBA can authorize bathrooms or showers in accessory structures. Tom Girard spoke in favor; there was no opposition.

REGULAR MEETING

OLD BUSINESS

BOSCO (26.14-1-5) 28 FRIENDS POINT SOUTH *(TR1) DEV* 40-24, SP 09-24, VAR 19-24

After discussion of measurements, alternatives, prior APA correspondence, safety concerns related to replacing deteriorating steps, and the reduced patio size (approximately 700 to 650 square feet), the board applied the variance criteria and determined the project would not adversely affect neighborhood character or environmental conditions and that the permeable surface and drainage features would improve stormwater management. The vote passed (3-2) (Navitsky and Barth-King).

GIRARD (42-1-25.2) 107 DODD HILL ROAD (*TR2*) *DEV 51-21, VAR 03-25*

The board confirmed the property is on the town sewer system and found the request largely corrected an administrative oversight, is consistent with neighborhood character, and would not have any adverse environmental impact. The motion passed unanimously.

OTHER BUSINESS

Starting in November, the Zoning Board of Appeals will meet on the third Thursday of each month.

PLANNING BOARD - 10/2/2025

Present were Chair Sandra Powell, Deputy Chair Pamela Peterson, and Board Members Alane Vogel and Henry Friedman. Also present were Zoning Enforcement Officer (ZEO) Ed Kirchberger and Recording Secretary Kathy Santaniello.

OLD BUSINESS

BOSCO (26.14-1-5), 28 Friends Point South (TR-1), DEV 40-24, SP 09-24, VAR 19-24

Zoning Issues: 160-23 C (1)(g) Development within 100 feet of the lake; 160-50 B (1)(b) Shoreline setback

The applicant requested reaffirmation of Site Plan Approval for a revised, slightly smaller design. The project includes construction of a new permeable lakeside stone patio and replacement of timber steps with stone steps.

The board reconfirmed that the proposal will improve erosion control through landscaping and enhance safety by

replacing deteriorated steps. Letters of support were received from neighboring property owners and the Friends Point Homeowners Association. The plan also includes replacing one removed tree with a new one. The motion to reaffirm Site Plan Approval passed unanimously.

BARCASTEDO LLC (SMITH) (26.14-1-10), 19 Waltonian Road (TR-1), DEV 30-25, SP 05-25

Zoning Issue: 160-23 C (1)(g) Development within 100 feet of the lake

The applicant proposes replacing a deteriorating timber retaining wall and steps with boulders and new stone steps. No variance is required under APA Appendix D.

A site visit was conducted on September 8th with engineer Tony DeFranco, ZEO Kirchberger, and Board Members Powell, Vogel, and Friedman. The existing railroad ties are in poor condition and the project will improve both safety and site stability. Several shrubs and one small tree may need removal, while existing drainage pipes remain functional.

During SEQRA review, the board found no significant adverse impact. The project will stabilize the slope, improve aesthetics, and remove creosote-treated materials, which both benefits the environment and increases safety. A Negative Declaration was issued, the application deemed complete, and the Type 1 Site Plan approved without conditions. The motion passed unanimously.

OTHER BUSINESS

PARLIN SUBDIVISION

The board noted this Class A Regional project received APA approval in September 2025 following a positive referral last May. The application has been deemed complete, and a public hearing was scheduled for November 6, 2025 at the next planning board meeting. The motion passed unanimously.

TOWN BOARD - 10/14/2025

Present were Supervisor Joshua Patchett and Board Members Jack Bast, Edna Frasier, and Lara Smith. Absent was Maureen Cherubini. Also present were Deputy Town Supervisor Sally DeLarm Rypkema, Zoom Coordinator Tim Fiallo, Highway Superintendent Chad Dunklee, Town Clerk Kim Coffin, HHS President Ginger Henry Kuenzel, Lindsey Smith, and 16 community members. There were also attendees via ZOOM.

A moment of silence was held for Bernard "Two Buck" Denno.

REGULAR COMMITTEE REPORTS:

BUILDINGS AND GROUNDS/COMMUNITY CENTER/ENHANCEMENT (Frasier):

A ZOOM meeting was held with the architect and engineer who are working on plans for the visitors center regarding funding for new bathrooms. Patchett added that three options are being explored: renovating the existing bathrooms, enlarging the men's room, or extending the area by removing cabinet space.

HIGHWAY (Frasier):

Frasier reported that the sediment pond on the Smith property has been cleaned out; approximately 28 loads of material were removed. Dunklee said the foundation for the new cold storage building is ready for concrete delivery. The department has received its new trailer and documentation to scrap the old one will be presented to the board. Dunklee added that Fiallo obtained a \$26,000 grant to pave an extension of Jabe Pond Road.

MUSEUM AND HISTORIAN (Bast):

Bast reported that the Hague Historical Society (HHS) needs closet space in the community center for safe document storage, as the basement is too damp. The Buildings and Grounds Committee is reviewing options and coordinating with the HHS. Kuenzel expressed appreciation for the town's continued support and said this year's Cave exhibit will remain open through December, while next year's exhibit will focus on the Hague Central School. She emphasized the importance of moving forward with a new vault project in 2026.

PERSONNEL (Bast):

Councilmember Bast announced two new hires: Brandy-Lynn Frasier as a part-time Transfer Station Attendant and Sarah Dever as the part-time Zoning Enforcement Officer (ZEO) Clerk. Open positions remain for one Hague Planning Board member and one Hague Zoning Board of Appeals alternate.

Bast reminded residents that Election Day is November 4th. Joshua Patchett is running for supervisor against write-in candidate Lindsey Smith for a one-year term. (This is because Warren County has determined that elections for town supervisors are to be conducted in the same years that national elections for US House of Representatives, Senate, and President are held.) Three candidates — Edna Frasier, Maureen Cherubini, and Chris Richards — are running for two four-year town board seats.

PLANNING, ZONING, AND STORMWATER (Frasier):

Frasier reported there are currently 66 completed short-term rental permits.

RECREATION, PROMOTION, AND YOUTH (Smith):

Smith announced that the Fish & Game Club will host a Trunk-or-Treat on October 25th, followed by a children's movie on the field's big screen.

SEWER DISTRICTS 1 & 2 (Smith):

Councilmember Smith reported that the generator installation at Cape Cod Village is progressing, although there have been delays with digging for the power line.

TECHNOLOGY AND COMMUNICATIONS (Patchett):

Patchett reported that all town email addresses will be transitioned to the .gov domain by year's end.

SCHOOL ADVISORY COMMITTEE (Bast):

Councilmember Bast stated that on October 3rd, Patchett and he sent a letter to the New York State Education Department seeking guidance on improving Ticonderoga Central School District's (TCSD) academic performance. The letter was endorsed by Dr. Roger Catania, NYSED Regent for the 4th Judicial District.

Bast said SAC's efforts continue to focus on fair school tax apportionment and academic accountability. He noted that about 30 Hague students are enrolled in TCSD this year. His inquiry about total district enrollment was rejected by TCSD officials, who cited Freedom of Information Law (FOIL) rules. Bast encouraged community members to become involved and consider running for the Board of Education (BoE).

The next BoE meeting is October 21st at 6 pm in the high school cafeteria.

COMMUNICATIONS AND PETITIONS: (Patchett):

Patchett reported that the town applied on October 1st for a \$125,000 Adirondack Park Community Smart Growth Grant to support town park improvements.

He also sent a letter to Fort Ticonderoga requesting free admission for Hague residents; both letters are on file with the town clerk.

The AARP requested continued use of the community room for tax-aid services in 2026, marking the 19th year of collaboration.

LGA HOLDS TENTH ANNUAL SALT SUMMIT

Lake George is a leader in reducing road salt, a critical threat to our lake. For the past ten years, the Lake George Association (LGA) has brought together experts from private industry and state and local leaders to find and promote practical strategies for scaling back of the use of salt on our roads.

This year, at the annual Adirondack Champlain Regional Salt Summit, Lake George Waterkeeper Chris Navitsky and Phill Sexton of WIT Advisers unveiled a powerful new tool that depicts the progress made over the past decade in reducing road salt use around Lake George.

The Road Salt Reduction StoryMap tells the story of how municipalities, businesses, state leaders, and community partners have come together since 2015 to take on one of the most urgent threats to clean water: road salt pollution.

Through interactive maps, data visualizations, and photos, the StoryMap highlights:

- The launch of the Lake George Road Salt Reduction Initiative in 2015.
- The Memorandum of Understanding (MOU) signed by municipalities across the watershed, recently re-adopted to reaffirm commitment ten years later.
- The role of the Salt Summit in building partnerships, sharing knowledge, and inspiring innovation.

SCHOOL ADVISORY COMMITTEE UPDATE, CONT'D

(TCSD) unacceptably poor academic performance, as measured in its poor ranking among NY public schools.

Our jointly signed letter was addressed to Angelique Johnson-Dingle, Deputy Commissioner for P-12 Instructional Support, and was endorsed by Dr. Roger Catania, our 4th Judicial District NYSED Regent, who is fully knowledgeable about our TCSD situation.

Our October 3rd letter states that our basic and reported findings have been that the TCSD Board of Education and the superintendent have been dismissive of the Town of Hague's and SAC's longstanding concerns and of the state proficiency test results, thereby putting Hague's and Ticonderoga's students learning experience at risk. Our letter sought NYSED advice on how to effectively address the demonstrated poor TCSD academic performance. We eagerly await a constructive NYSED response.

On a separate issue regarding 2025-2026 TCSD student enrollment, SAC estimates that approximately 30 Hague school-age children are enrolled this year.

When, in a simple email, I requested information on the total TCSD enrollment, I was denied that number. I was summarily informed by a TCSD official that my email was interpreted both as an interrogatory and as an incomplete Freedom of Information Law (FOIL) request. I was told that, therefore, according to Section 89 of NY Officers Law, TCSD is not required to respond to either — and, therefore, they didn't. A full-fledged FOIL request has subsequently been submitted for this apparently non-public number.

I again remind us all that for us to succeed in our mission to improve TCSD academic performance and to obtain fair and equitable school taxes, we need more than committee involvement — we need for parents and citizens to be engaged.

We are reaching out to families for their insights and advocacy. We also encourage community members to consider running for the Board of Education, where Hague's voice and votes are urgently needed. Together, with persistence and collaboration, we believe we can make a meaningful difference.

The next TCSD Board of Education meeting is scheduled for **Tuesday**, **November 18th at 6 pm** in the high school cafeteria.

PROCELLACOR PERSISTS IN SEDIMENTS OF LAKE GEORGE, CONT'D

The team's newly released scientific report HERE marks the first known long-term study of ProcellaCOR's persistence in lake sediments.

The study found that, while it disappeared from the water within days, consistent with prior studies, ProcellaCOR persisted in lakebed sediments. Why is this important? To read the answer to this and other questions submitted to the LGA, click HERE.

The research also found that lake circulation spread the herbicide beyond the direct treatment zones. Together, these findings show that ProcellaCOR behaves differently in the real world than in laboratory studies, raising new questions about long-term ecological impacts, the effects of repeated applications, and how sediment persistence has previously been underestimated in prior research.

"The ecological impacts are unclear but warrant further investigation." said LGA Executive Director Dr.
Brendan Wiltse. "Our findings should be taken into consideration when planning herbicide treatments and in state permitting processes, especially in cases where there are repeat applications because of the potential for long-term accumulation of the herbicide and its degradants, and the unknown ecological impacts from this accumulation. It's imperative that herbicide use be guided by robust aquatic invasive species management

plans that consider all management tools."

The LGA emphasized that, based on its current data, there is no evidence of any risk to drinking water, recreation, or human health. The LGA and its partners are committed to advancing their research, including further study of FPB's persistence in Lake George sediments, plants, and animals, and expanded sampling on other Adirondack lakes.

PROTECT OUR HEMLOCKS BY REPORTING HWA

The Lake George Land Conservancy (LGLC) is calling on hikers, hunters,



birders, and all other outdoor enthusiasts to help protect local forests from the hemlock woolly adelgid (HWA), an invasive insect threatening the region's hemlock trees.

Those exploring the outdoors are encouraged to check hemlock branches for white, cotton-like spots at the base of the needles — these are signs of HWA. Anyone who spots them should snap a photo and submit a report. Each sighting plays a vital role in preserving hemlocks and maintaining the pristine water quality of Lake George.

The Hague Chronicle- November 1975

We ran across a poem in the Grand Mara (Michigan) Pilot and Pictured Rocks Review which we would like to share with you. It is entitled Ghost Apples.

GHOST APPLES

Ghost Apples without a will Are what I pick. Atop a hill. The leaves of autumned colored trees blow

on a lake-born wind that smells of snow. Whose tree this was I cannot know There is no house or grave to show His name. He found this valley long ago.

To mine for copper, didn't know
That market prices far from here
Could kill his dream. That pioneer Dug
and built and planted
And never reaped what God had granted.
The mines are gone, mere holes.
Foundations overgrown mark where
these souls
Struggled, built, then went away
Defeated. They never knew that here,
Today
I'd come to pick the wealth they left
behind!

A load of apples that remain Of all their struggle and their pain. God only knows what of our age Shall be the next man's heritage.

UPDATE 50 YEARS LATER

The poem likely depicts a sadness pertaining to the lives that labored and could not remain to enjoy the sweet fruits of the orchard they planted.

However, "Ghost Apples" are natural ice sculptures that occur when freezing rain coats decaying apples which are still clinging to trees. As the fruit rots and collapses, the icy shell remains, creating a fragile, glasslike casing that resembles a ghostly version of the original fruit.

In Native American tales, some tribes saw ghost apples as "winter fairies." In European folklore they are linked to "frost fairies" that steal fruit souls. In modern symbolism, ghost apples are a metaphor for beauty in decay. They are also featured in poetry and act as a sign of nature's impertinence.

Agriculture studies help scientists understand ice formation dynamics that may improve frost resistant varieties and inspire protective coatings for crops. This could also lead to new preservation techniques for fragile artifacts.

The best places to see ghost apples in person are in Michigan, Canada, and Northern Europe from late December to February in the early morning.

Meanwhile, enjoy fresh apples and apple products at any local orchard. This is the time of year for apple harvesting and apples are low in calories, high in fiber, Vitamin C, and antioxidants.


