hired in 2016. Not sure how many positions, about 3-4 to start and maybe more as the process grows.

Those selected as CSMs will no longer be able to serve as an Assessor. Discussion of CSMs will look at

agency files annually thru Power DMS each year, ensuring examination of ALL files during the four years.

On-sites will follow the current GSA format, where assessors will verify compliance through interviews,

observations, and discussion with agency personnel. Assessors will not review any files.

Open Forum:

Zeta reminded of CASE will be gone in December of 2017. She reviewed the PSCASN website and

listserve, reminding that the board has secured the services of Craig Celia to maintain both for the PAC.

Discussion of crosswalk differences ensued.

Deb Gailbreth had a question regarding by-laws and membership for those not longer affiliated with an

agency such as those (herself included) getting ready to retire. Honorary Membership is covered under

the by-laws.
