In Attendance:

Twenty-seven agencies were represented at the meeting. The PSCASN Meeting Roster is attached to these minutes. CALEA Regional Program Manager Mark Mosier attended.

President Kathy Strickland called the meeting to order at 3:15 PM, welcoming everyone. She introduced Board Member Mary Sue Robey who was in attendance, as well as Vice President Angel Geoghagan who attended via video conferencing. Introductions were made around the room.

President Strickland thanked Jody Farmer for her years of service on the Board of Directors. and wished her well on her retirement. President Strickland appointed Brenda Gisewite to the Board of Directors to replace Secretary Farmer until the November election. Brenda Gisewite introduced herself to the members.

Old Business:

Mary Sue reported there are currently 127 member agencies. The balance at the time of the meeting was \$21,373. No dues are being collected in 2022 for current members. However, we will resume collecting them in 2023.

Craig Hartley stopped by to greet the group. He talked about CALEA doing away with the Excellence Award. CALEA wants people to focus on the standards and getting better, not getting an award. CALEA Regional Program Manager Mark Mosier addressed the group. He said they are looking for more CALEA Communications Assessors.

New Business:

President Strickland announced that the PSCASN Vice President and Secretary positions will be up for elections in November. If you are interested in one of these positions, please contact her.

With Craig Celia's retirement, PSCAN has a new WebMaster. We welcome Sherianne Hermes and thank her for stepping up to fill this important role.

President Strickland said she encountered an agency that chose the CALEA Tier 1 option. However, they also had the Communications Accreditation and inappropriately used the Crosswalk. President Strickland cautioned the members that only agencies that choose the Tier 2 or Advanced Accreditation can use the Crosswalk for their Communications standards.

At each conference, PSCASN has a slot for communications training. Anyone interested in presenting communications training will receive a free CALEA Conference registration. Please let a Board member know if you are interested in teaching a class.

President Strickland asked the group if there was anything for open discussion. Hearing none, she announced the PSCASN Hospitality would be held at the Gatorville restaurant located by the pool immediately following the meeting.

With no further business President Strickland adjourned the meeting at 4:00 pm.
