ORDINANCE 310 was adopted by City Council effective October 29, 1981

Sec. 12-1. - Separate license for each premises. Every person who conducts any business or engages in any trade or occupation from any premises or who uses a vehicle for such purposes within the city shall procure a license in the manner prescribed in this article and shall pay the required fee.

Sec. 12- 5. - Expiration date. A license shall be valid for one calendar year and shall expire on the last day of December at 12:00 midnight of the year for which it is issued.

Sec. 12 - 6. - The fact that a license or permit has been granted to any person by the state to engage in the operation, conduct, maintenance or management of any business, trade, occupation or premises shall not exempt such person from the necessity of procuring a license from the city. However, this article shall not be interpreted as giving the city any authority to regulate the professional conduct of any state-licensed professional.

12 - 7. - No license shall be issued until the required fee is paid. If the license year shall terminate within six (6) months or less from the date of the issuance of the license, the required license fee shall be one-half of the required annual fee. A penalty of ten (10) per cent of any required license fee shall be assessed and paid upon the failure of any licensee to renew such license on or before February fourteenth of any year.

12-10. - The licensee shall carry the license on his person at all times when engaged in any business for which the license was granted or conspicuously displayed in a fixed location at all times.
