Terms and Conditions

RETAINER FEE, PAYMENT AND CANCELLATIONS

A \$200 retainer fee and a signed contract is required to consider this an order and contract for services to be rendered. The remaining balance due four (4) weeks prior to pick up or delivery date. Any changes to an order must be made no later than 4 weeks prior to your event date. Any changes requested after signing of this contract cannot be guaranteed and may be subject to additional charges. Retainer fee is paid to reserve your date and is **NON-REFUNDABLE in the event of cancellation.**

REFUND POLICY

Sweet Creations by Gigi will not offer refunds or exchanges for custom products that meet our quality standards once a cake has been picked up/delivered and "Accepted" by you or another designated party. Additionally, under no circumstances will Sweet

Creations by Gigi provide a refund more than the cost of the order. All products are the responsibility of the customer once it leaves our possession. Refund requests due to decorating style, color shade or general decoration design will not be honored or considered. We only give refunds if the product does not meet the flavor, size, and general description detailed above. Cake flavor and texture are subjective. Refunds requested due to flavor or texture after cake has been accepted and picked up will be at the sole discretion of Sweet Creations by Gigi.

Sweet Creations by Gigi may consider a store credit if the product is brought back, and the quality of the cake flavor or texture is determined not to meet our standards within 2 hours of your event and is 90% uneaten. Keep in mind, variety in temperature and humidity may impact the flavor, overall design, or texture of the cake to some degree. Please understand we cannot control changes in texture or changes in color or shape due to weather conditions.

PICKUP, DELIVERY AND SETUP

The delivery time will be confirmed two (2) business days before your event date. Cakes may be setup 1-3 hours before your event. For outdoor events, we try to setup as close to the reception time as possible. The Client must disclose any adverse road hazards and/or obstacles that may hamper the delivery and quality of finished products. In the case of an unavoidable occurrence, such as an act of God, a car accident, poor road conditions, or accidentally dropping of cake during delivery — Sweet Creations by Gigi cannot be held liable for more than the price of the cake described in this order.

Sweet Creations by Gigi is not responsible for any damage to the cake after pick-up or after setup is complete. The client is responsible for providing an appropriate and secure table and environment for the cake(s). Cakes are heavy and require a sturdy table, and optimal room temperature of 75 degrees or below. If you or your representative elects to pick up and set up the cake, you assume all liability and responsibility for the condition of the cake once it leaves the possession of *Sweet Creations by Gigi*.

FRESH FLOWER USAGE

- In the case of fresh flower usage on the cake, the responsibility of the flower safety and safe food practices will rest with the florist. The person placing this order should obtain a notice of plant safety, in question, from the florist.
- ***Sweet Creations by Gigi*** is not responsible for any damage to the cake caused by the placement of flowers by another party or other items on the cake.

CAKE DESIGN AND COLORS

- Sweet Creations by Gigi will follow the client's requests as closely and as legally possible. However, we cannot duplicate an exact copy or another artist's work but will ensure the look is similar. Due to the nature of manual color matching, we cannot guarantee absolute color matches. The colors **blue, green, gray, black, red, and purple** or any shade of the dark colors **cannot be guaranteed**. These colors are unstable and tend to fade and /or bleed into surrounding colors and frosting, especially in an outdoor venue.

ALLERGY DISCLAIMER

Sweet Creations by Gigi's baked goods are made in a kitchen with shared equipment and may have come in contact with wheat, Eggs, Dairy, Nuts and red food coloring.

CAKE STAND RENTAL

All rental items will be for a five (5) day period. The day of the event and up to two (4) days thereafter. A late fee of \$3.00 per day will be imposed for each day the items are late. Should any parts be not returned or damaged in any way, the renter is responsible for the cost of replacing the entire item. The renter is responsible for returning the cake stand.
