

COMPLETE WAIVER AND RELEASE OF LIABILITY, AGREEMENT TO HOLD JP's TACTICAL & TRAINING LLC HARMLESS, AND ASSUMPTION OF RISK

By signing this waiver, I confirm that I am a United States Citizen or a LEGAL Resident A	lien (with a
green card) and am NOT prohibited from possessing firearms. This certification is man	datory for

I understand and agree to abide by all range rules and regulations, ensuring that I conduct myself in a safe manner at all times and promptly comply with all instructions from instructors. I further agree that any firearms or ammunition brought onto the premises will be transported in full compliance with State, Federal, and other applicable laws. I accept full responsibility for the safe handling and operation of any firearms or ammunition I bring into the training environment. JP's Tactical & Training LLC, along with other participating service providers and the range (including owners, stakeholders, and associates), assume no responsibility for the safety or functionality of firearms, ammunition, or related items.

Moreover, I affirm that I am of legal age and legally competent to enter into this agreement. I acknowledge that these terms are contractual and binding, and I am signing this document voluntarily and of my own free will. I also confirm that I have never been restricted from accessing firearms.

Firearms must always be safely holstered or stored until instructed for use by authorized personnel. After use, firearms must be promptly returned to a safe holster or storage. In the event of any potentially unsafe condition, I agree to immediately cease shooting, secure my firearm safely, and notify an instructor.

In consideration of the opportunity to participate in or observe training with JP's Tactical & Training LLC, I assume full responsibility for my actions and accept all personal risks associated with participation, whether foreseen or unforeseen. I assume liability for myself, my family, guests, legal heirs, and assigns. I release and hold harmless JP's Tactical & Training LLC, the range, officers (of JP's Tactical & Training LLC, the range, and other participating entities), directors, agents, and employees from any harm, death, or damages to persons, property, or others that may arise from using facilities, services, or equipment.

Additionally, I agree that I, my family, or dependents will not pursue legal action or seek damages against JP's Tactical & Training LLC, its instructors, officers, officials, course sponsors, or event organizers for any injuries sustained during training or events. I indemnify and hold harmless JP's Tactical & Training LLC and all parties involved from all claims, costs, counsel fees, expenses, and liabilities arising from such claims.

I certify that I am not under the influence of alcohol or drugs and that I am legally permitted to possess a firearm. I attest that I am physically and mentally fit at the time of signing this agreement and during my participation in training.

I acknowledge that I have read and fully understand this waiver of liability, agreement to hold harmless, and assumption of risk. I further commit to complying with all range safety rules and procedures during courses and events.

Video and Audio Surveillance:

I acknowledge and consent to the use of video and audio surveillance by JP's Tactical & Training LLC and other participating entities on their property and premises for security and safety purposes.

Training Rules:

- 1. Treat all firearms as if they are loaded.
- 2. ALWAYS keep firearms pointed in a safe direction, away from persons, areas where persons may be, and wildlife.
- 3. Keep your finger straight and outside the trigger guard until ready to shoot, upon instructor direction.
- 4. Ensure your target and its foreground/background are safe.
- 5. Avoid pointing firearms downrange indiscriminately.
- 6. Repeat all range commands loudly.
- 7. Immediately report any unsafe conditions to an instructor.
- 8. Act responsibly and safely at all times, exercising good judgment.
- 9. Show courtesy to all shooters.
- 10. Keep cell phones silent.
- 11. Cease fire immediately upon observing unsafe conditions.
- 12. Keep handguns holstered or in secure cases except when on the firing line and directed by an instructor.
- 13. Do not handle firearms off the firing line without instructor direction.
- 14. Administer range reloads only off the firing line.
- 15. Ensure personal responsibility for every fired round.

Prohibited Actions:

- 1. Shooting at people or wildlife.
- 2. Firing anywhere except downrange at the backstop with authorized commands.
- 3. Cross-range shooting.
- 4. Shooting without authorized commands.
- 5. Shooting after a cease-fire command.
- 6. Use of alcoholic beverages or drugs affecting ability to participate safely.
- 7. Prohibited firearms and ammunition as specified.
- 8. Firing armor-piercing or tracer ammunition.
- 9. Preventing bullet impacts off the approved range area.
- 10. Disruptive activities not related to training or unsupervised on the firing line.
- 11. Loading firearms without instructor permission on the firing line.
- 12. Bringing live ammunition into the classroom without instructor permission.
