1. Purchase Agreement:

2. Payment Terms:

- JP's Tactical agrees to purchase the Firearms from the Seller at the Agreed Purchase Price as specified above.
- Payment will be made to the Seller within 7 business days of JP's Tactical receipt and acceptance of the Firearms.
- Payment methods may include cash, certified check, or other mutually agreed-upon method.

3. Condition of the Firearms:

- The Seller warrants that the Firearms are accurately described in terms of make, model, serial number, and condition.
- JP's Tactical reserves the right to inspect the Firearms upon receipt to ensure they match the description provided by the Seller.

4. Legal Compliance:

- The Seller warrants that they are the lawful owner of the Firearms and have the legal right to sell them.

5. Transfer of Title and Possession:

6. Inspection and Acceptance:

- If the Firearms do not meet the description provided by the Seller, JP's Tactical reserves the right to reject the Firearms and return them to the Seller at the Seller's expense.

7. Indemnification:

- The Seller indemnifies and holds harmless JP's Tactical, any and all owners, presidents, co-owners, employees, subcontractors and staff from any claims, liabilities, damages, or expenses arising from the purchase of the Firearms, including any breach of representations and warranties made by the Seller.

8. Dispute Resolution:

- Any disputes arising from this agreement will be resolved through mediation or arbitration, conducted in Westminster, Carroll County, Maryland.
- Both parties agree to cooperate in good faith to resolve disputes promptly.

9. Termination Clause:

- Either party may terminate this agreement with 5 days' notice in writing.
- Termination may occur due to breach of contract, failure to comply with terms, or other unforeseen circumstances.
