<u>Address:</u> Glebe Farm, Rectory Hill, West Dean, Salisbury, SP5 1JL <u>Proposal</u>: Erection of dwelling and garages with annex, following removal of existing agricultural building (amended scheme to 19/00876/FULLS)

Mr Heathorn was invited to address the council on this planning application in his capacity as property developer plus his declared intent on the property, once completed, being his family residence.

Mr Heathorn elaborated on his design plans for the property, ancillary buildings, extensive landscaping, and improvements on the existing approved plans 19/00876/FULLS. Anticipated timescale to completion is 18 months. Permitted clearing and landscaping has already commenced.

The Councillors asked Mr Heathorn questions to clarify his plans with direct reference to TVBC Planning Polices, the Neighbourhood Development Plan, and the West Dean Village Design Statement. Questions focussed on size and scale, best use of land, and how well the design is in keeping with the character of the village. As a consequence, Mr Heathorn agreed to provide the councillors with plans for 20/019903 overlaid with footprint outline of:-

- Existing approved plans 19/00876
