#### **Meeting Called to Order**

Meeting called to order by Chairperson Joe McDowell at 7:00 PM

The school is looking to partner with CSP (Charter Success Partners) for which we have recommendations. Juliana and Joe will meet and move ahead to contract, after negotiation, and make the decision for our Finance and Power School partner.

# Academic Excellence
