



RANGE ORIENTATION & SAFETY

Initial

Safety Rules

- ____ 1. **ALWAYS** keep the gun pointed in a safe direction.
____ 2. **ALWAYS** keep your finger off the trigger until ready to shoot.
____ 3. **ALWAYS** keep the gun unloaded until ready to use.
____ 4. **ALWAYS** treat a weapon as if it is loaded.

- ⊕ Keep any firearm pointed downrange at ALL times, perpendicular to the target line, whether loaded, unloaded, or malfunctioning. Be sure of the target and what is behind the target.
- ⊕ Do not load the firearm until ready to fire. DO NOT insert a loaded magazine into the firearm behind the firing line.
- ⊕ All guns “benched” should be unloaded, action open, and magazine removed.
- ⊕ Under no circumstances may a loaded firearm be passed to another person from behind the firing line.
- ⊕ At the command “Cease Fire!” immediately make your firearm “safe,” set the gun down pointed downrange, and step away from the firing line into the safety area with nothing in your hands.
- ⊕ EYE PROTECTION and HEARING PROTECTION are always MANDATORY.
- ⊕ No open food, drink, or tobacco use of any kind is permitted ON the firing line.
- ⊕ Be certain that your ammunition is correct for the firearm you will be shooting. NO STEEL CORE, GREEN TIP or ARMOR PIERCING ammunition allowed. The user is subject to removal from the range and responsible for any and all damages caused.
- ⊕ Know and understand how your firearm works and the operation of all safety features.
- ⊕ Use of alcohol, drugs, or other mind-altering substances before or during your range session is prohibited.
- ⊕ PICK UP ALL spent ammunition cartridges. Place brass in buckets and steel/aluminum in garbage cans.
- ⊕ Drawing from holsters is permitted with permission from the on-duty Range Officer.
- ⊕ Range Officer decisions or determinations are final. Any misuse of the facility or disregard of rules will result in expulsion from the range.
- ⊕ The minimum age to use the range is 12 years unless part of a family membership, then 8 years of age and above. The parent/guardian MUST remain with the minor on the range. Persons under 18 cannot use fully automatic firearms on the range.
- ⊕ Intentionally damaging target stands, targets, bolts, range markers, or props will result in removal from the range.

LIABILITY WAIVER

In consideration of the acceptance of my application to use the range, which does include, but is not limited to, the use and discharge of firearms at the range, the use and discharge of rental firearms provided by Windrock Shooting Range, and the services and training by employees of Windrock Shooting Range and Windrock Park, Windrock Resources, Inc., and The Windrock Land Company (collectively known herein as "Windrock") herein referred to as Windrock Shooting Range/WINDROCK, I on behalf of myself, agents, assigns, heirs, survivors, executors or administrators, here by and forever release and discharge Windrock Shooting Range/WINDROCK, its employees, its agents, and assigns from any and all liabilities, claims, demands, or cause of actions that I may hereafter have for injuries and damages arising out of my use of the range or my presence at the range, including, but not limited to, losses caused by 1) the negligence of Windrock Shooting Range/WINDROCK, and/or its employees, agents, or assigns, or 2) ricochets of bullets or bullet fragments, or 3) the acts or omissions of third parties, or 4) hidden, latent, or obvious defects in the range facilities, including but not limited to, the bullet traps and the associated component parts of the range. I understand and acknowledge that the range is where firearms discharge deadly ammunition. I further understand that the discharge of firearms and the use of ammunition have inherent dangers that no amount of care, instruction, or experience can eliminate. I further understand that the range is an outdoor shooting facility that utilizes an earth/soil backstop to stop discharged ammunition; however, I understand that the earth/soil backstop of the range does not, in every instance, contain bullets or bullet fragments and have been known to cause ricochets which could cause serious personal injury or death; and I expressly and voluntarily assume all risks of personal injury or death sustained while using the range, including, 1) the negligence of Windrock Shooting Range/WINDROCK and/or its employees, agents, or assigns, or 2) ricochets of bullets or bullet fragments, or 3) the acts or omissions of third parties or 4) hidden, latent, or obvious defects in the range facilities, including but not limited to, the backstops and the associated parts of the range. I further agree that no oral representation, statements, and inducement apart from the foregoing written agreement have been made and that any modification of this agreement will be effective only if it is written and signed by the party to be charged. I affirm that I have read and understand all information on the front and back of this form. I am sufficiently informed and/or experienced in firearms to understand the rules and regulations fully. I promise to abide strictly by these regulations while on this property. I further certify that I am not under the influence of any drug or alcohol, not mentally ill, nor pose a threat to myself or others, and I am a law-abiding person and not prohibited by any federal, state, or local laws from handling or shooting firearms. This Form is valid only at the outdoor range location at 720 Windrock Rd., Oliver Springs, TN, and will expire on December 31 of the current year. I understand it is my responsibility to update any information relating to me should it change, including name changes, address, phone number, or any restrictions that may prohibit me from using, handling, or possessing firearms.
